## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of

### Opinion

We have audited the accompanying financial statements of United Employers Association Group Health Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023; the related statements of changes in net assets available for benefits for the years then ended; and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of United Employers Association Group Health Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of United Employers Association Group Health Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### Responsibilities of Management for the Financial Statements

#### 1. DESCRIPTION OF THE PLAN

United Employers Association Group Health Plan (the “Plan”) was established on July 1, 2015, under an agreement and declaration of trust to provide an administrative platform for welfare benefits for eligible employees, their dependents, and retired participants of participating employers. The participating employers remit monthly premium payments directly to the insurance company that the employer has selected to provide benefits to its employees. Health management fees are remitted to the Plan in order for the Plan to pay the administrative expenses of the Plan. Participants covered under the Plan include employees of employers that have executed a participation agreement with the Plan. The Plan qualifies as a multiple-employer welfare arrangement (“MEWA”).

The current Plan provides medical, dental and prescription drug benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participating employers set the eligibility requirements and benefit options for their employees within parameters established by the Plan.

Continuation of health care benefits to participants who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (“COBRA”), normally applies to all employers employing 20 or more employees during a calendar year. All sponsoring employers are responsible for offering COBRA benefits. Employers can choose whether to self-administer these benefits, elect the COBRA administrative services available through the Program, or retain a third-party administrator.

Participants should refer to the Summary Plan Description for more complete information.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Method of Accounting**

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Administrative Fee Receivable**

The administrative fee receivable represents health management fees earned prior to year-end that have not been paid to the Plan as of year-end. Management believes the receivable is fully realizable; therefore, an allowance for credit losses is deemed unnecessary. Administrative fee receivable at January 1, 2023 was \$11,271.

##### **Benefit Obligations**

Due to the nature of benefits provided, there are no benefit obligations. Therefore, the statements of benefit obligations and changes in benefit obligations normally presented in accordance with accounting principles generally accepted in the United States of America are not included in the financial statements.

##### **Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Revenue Recognition**

Revenue consists of health management fees which are received and recorded monthly in connection with each participating employer's insurance contract with UnitedHealthcare. Health management fees owed but not received at year-end are recorded as a receivable. The health management fees are calculated based on the number of subscribers per month that receive coverage through the contract with UnitedHealthcare. The performance obligation related to the health management fees is satisfied in a consistent and ongoing basis.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan obtained its determination letter, dated February 22, 2019, in which the Internal Revenue Service stated that the Plan, as then designed, was qualified under Section 501(c)(9) of the Internal Revenue Code and, therefore, is not subject to tax under present income tax laws. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

The benefits provided by the Plan are funded by contributions from sponsoring employers. Insurance premiums are paid directly to the insurance companies. The health management fees earned by the Plan are then remitted monthly from the insurance company to the Plan.

**6. RELATED-PARTY TRANSACTIONS**

The Plan has an administrative agreement with UEA, Inc., which is controlled by parties related to the Plan. Administrative fees paid for the years ended December 31, 2024, and 2023, totaled \$163,908 and \$138,084, respectively. As of December 31, 2024, and 2023, the Plan owed \$13,272 and \$12,444, respectively, to UEA, Inc., for administrative services which is included in accounts payable and accrued expenses on the statements of net assets available for benefits.

**7. SUBSEQUENT EVENTS**

In preparing these financial statements, management of the Plan has evaluated event and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These event and transactions were evaluated through October 9, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
