Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Security Benefit Corporate Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a contributory welfare plan which provides various health and welfare programs to eligible retirees and employees and their dependents of the following employers: Security Benefit Business Services (SBBS); Eldridge Wealth Solutions, Inc. (EWS), previously Security Benefit Corporation; Security Benefit Life Insurance Company (SBLIC); First Security Benefit Life Insurance and Annuity Company of New York; Security Financial Resources, Inc.; Security Benefit Academy, Inc.; SE2, LLC; Eldridge Business Services, LLC; Eldridge Executive Services, LLC; Security Distributors, LLC; Everly, LLC; Panagram Services, LLC; and Sommsation Services, LLC; (referred to herein, collectively as the Company).

A portion of the benefits are funded through the Security Benefit Voluntary Employee Benefits Trust (VEBA), which is qualified for tax exemption under Section 501(c)(9) of the Internal Revenue Code. SBLIC is the trustee of this VEBA. Other benefits are funded directly by contributions from one or more of the employers as well as the employees. EWS is the overall Plan Administrator and leading Plan sponsor for the Plan.

EWS is the named fiduciary of the Plan, with full authority to control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Benefits Committee is responsible for oversight of the Plan.

Eligibility: All regular full-time associates and part-time employees scheduled to work 20 hours per week or more are eligible to enroll in the medical, prescription, dental, vision, life and accidental death and dismemberment plans on the first of the month following the month of their hire date. If the hire date is on the first of the month, the associate would be allowed to enroll immediately. If an employee chooses not to enroll at his or her first opportunity, he or she must wait for open enrollment, which is held annually, or for a qualifying life event.

Employees may participate in the short-term disability and the long-term disability programs after the employee has worked 90 days and is scheduled to work at least 20 hours per week.

The various programs of the Plan and related contribution policies are described as follows:

Health Care Benefits Program: Provides hospitalization and medical benefits, including prescriptions, for enrolled employees, with a family coverage option, and eligible retirees. Contributions to the health care benefits program are made by enrolled employees, eligible retirees, and the employer. The employer determines the amount of contribution made for each employee class. The employer contribution is the balance necessary to meet the program's funding requirements in excess of the employee contribution.

Post-retirement benefits: Employees of EWS and its affiliates with five or more years of continuous service and who reached age 54 on or before June 30, 2017; and who retire from active employment on or after age 55 may continue to participate in health care and prescription programs. The costs of the post-retirement benefit plan are shared by the employer and eligible retirees. The employer's portion of retiree premiums is frozen at the 2003 premium rates, except for certain employees who retired prior to 2003, to whom the frozen rates do not apply. In addition to deductibles and co-payments, retirees pay the difference between the actual current premium and the frozen employer's portion.

Term Life Insurance Program: Provides life insurance coverage for enrolled employees. Contributions are paid by the employer in an amount necessary to pay premiums for the insurance coverage.

Supplemental Term Life Insurance Program: Provides additional life insurance coverage for enrolled employees. Contributions are paid by the employee in an amount necessary to pay premiums for the insurance coverage.

Dependent Life Insurance Program: Provides life insurance coverage for an enrolled employee's spouse and dependents. Contributions are paid between the enrolled employee and the employer in an amount necessary to pay premiums for the insurance coverage.

Dental Benefits Program: Provides dental benefits for enrolled employees with a family coverage option. Contributions to the program are made by both the enrolled employee and the employer. The employer determines the amount of contribution made for each employee class. The employer contribution is the balance necessary to meet the program's funding requirements in excess of the employee contribution.

Long-Term Disability Insurance Program: Provides long-term insurance coverage, which pays 66.67% of salary, up to a maximum of \$20,000 per month, for enrolled employees who experience long-term disabilities. Contributions are paid equally between the employee and the employer in an amount necessary to pay premiums for the insurance coverage through March 31, 2024. Beginning April 1, 2024, employees no longer need to elect the benefit, and the employer pays 100% of the contributions.

Basic Accidental Death and Dismemberment Insurance Program: Provides accidental death and dismemberment insurance coverage, which pays up to two times the enrolled employees annual salary. Contributions are paid by the employer in an amount necessary to pay premiums for the insurance coverage.

Note 1. Description of the Plan (Continued)

Voluntary Accidental Death and Dismemberment Insurance Program: Provides supplemental accidental death and dismemberment insurance coverage in addition to the coverage provided for all enrolled employees by the employer. Contributions for the voluntary accidental death and dismemberment program are paid by the enrolled employee in an amount necessary to pay premiums for the insurance coverage.

Voluntary Accident Insurance Program: Accident Insurance is designed to supplement employer-sponsored health coverage and helps offset the out-of-pocket costs of medical care following a nonwork related injury. Benefits are paid tax-free to employees and can be used to make up for lost wages, cover living expenses, or be applied to health insurance deductibles. Contributions are paid by the enrolled employee in an amount necessary to pay premiums for the insurance coverage.

Voluntary Hospital Indemnity Insurance Program: Hospital Indemnity insurance provides admission and daily confinement benefits for hospital stays due to covered illnesses, injuries, procedures, and pregnancy. Payments may be used for various purposes—from medical expenses like deductibles, to everyday costs, like housekeeping and childcare. Contributions are paid by the enrolled employee in an amount necessary to pay premiums for the insurance coverage.

Voluntary Critical Illness Insurance Program: Critical Illness Insurance is designed to supplement medical coverage by helping to pay for out-of-pocket costs associated with being newly diagnosed with a major illness or medical event. Some, but not all, of the conditions covered under this program include cancer, heart attack, stroke, advanced Alzheimer's disease, kidney failure, and paralysis. Contributions are paid by the enrolled employee in an amount necessary to pay premiums for the insurance coverage.

Mental Health Care Program: Modern Health provides mental health care services that include one-on-one support with a coach or therapist, as well as self-guided digital resources. Contributions are paid by the employer in an amount necessary to pay premiums for the insurance coverage.

Flexible Spending Program: Provides pretax payroll deductions for dependent care and health expense reimbursements. Contributions are made by the enrolled employee and are limited by the Internal Revenue Code (Code).

Limited Flexible Spending Program: Provides pretax payroll deductions for eligible dental and vision expenses, not medical. Contributions are made by the enrolled employee and are limited by the Code.

Short-Term Disability Program: Provides payment equal to 66.67% of an employee's regular earnings, up to a maximum of \$20,000 per month, during a period of short-term disability. Payment begins following seven days of unpaid disability leave. Contributions to the program are paid by the employer.

Vision Insurance Program: Provides coverage for routine services for eye exams, lenses, or contacts. Contributions for the voluntary vision insurance program are paid by the enrolled employee in an amount necessary to pay premiums for the insurance coverage.

Claims processing: United Healthcare processes health claims and, on behalf of the trustee, disburses health claim payments in accordance with the provisions of the Plan. The Plan pays United Healthcare an administrative fee based on the number of enrolled employees and amount of health claim payments processed.

OptumRx, through United Healthcare, processes prescription claims and, on behalf of the trustee, disburses prescription claim payments in accordance with the provisions of the Plan to the participant or designated assignee. The Plan pays OptumRx through United Healthcare an administrative fee based on the number of enrolled employees and amount of prescription claim payments processed.

Delta Dental processes dental claims and, on behalf of the trustee, disburses dental claim payments in accordance with the provisions of the Plan. The Plan pays Delta Dental an administrative fee based on the number of enrolled employees.

WEX administers the Flexible Spending Program. The Plan pays WEX an administrative fee based on the number of enrolled employees.

Eye Med Vision Care administers and processes vision claims and pays the provider's office. The Plan pays Eye Med insurance premiums, which cover the claims and administrative fees for each enrollee.

Stop-loss coverage: The Plan has entered into a stop-loss insurance arrangement in order to limit its exposure for self-insured benefits. As of December 31, 2024 and 2023, coverage was provided for individual participant claims over \$200,000 and maximum aggregate benefits were \$2,000,000.

Refunds: Refunds from OptumRx are recorded when received. Pharmacy rebates totaling approximately \$2,461,000 and \$1,346,000 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Claim amounts exceeding stop loss coverage were not remitted by the Plan, thus there were no health care refunds received by the Plan in 2024 and 2023. Amounts totaling approximately \$1,628,000 and \$4,828,000 exceeded stop loss coverage and were paid by United Healthcare for the years ended December 31, 2024 and 2023, respectively.

Experience-rated contracts: The stop-loss insurance contract is subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Self-insured benefits: Medical, dental and prescription benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Plan amendment and termination: Although they have not expressed any intention to do so, the employers have the right under the Plan to modify the benefits provided to, and contributions required of, participants. Additionally, the employers have the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on a modified cash basis. If the accompanying financial statements had been prepared under the accrual basis of accounting, contributions, rebates and plan administrative expenses to be paid or received would be recognized when incurred rather than reflected by the receipt or payment of cash. Accordingly, the financial statements of the Plan are presented on a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements on the modified cash basis of accounting and the related notes requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported, claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Benefit payments: Health claim payments are recorded when paid by the Plan to the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are not included on the statement of net assets available for benefits. These amounts are included in claims payable in the calculation of the Plan's future benefit obligations (see Note 5).

Medical and dependent care expense reimbursements related to the flexible spending program and short-term disability expenses are classified as other benefit payments.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Post-retirement benefits: The amount reported as the post-retirement benefit obligation (see Note 4) represents the actuarial present value of those estimated future medical and life benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Post-retirement benefits include future benefits expected to be paid to or for: (1) currently eligible retirees and their dependents and (2) active employees and their dependents after retirement from service with EWS. The post-retirement benefit obligation represents the amount that is to be funded by contributions from EWS and from existing Plan assets.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Concentration of Deposits

The Plan's policy is to maintain its bank deposits with sound financial institutions. Bank deposits, at times, may exceed federally insured limits.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest-bearing cash: Cash reported as Level 1 is valued at cost, which approximates fair value.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 provides a prescription drug benefit under Medicare as well as a federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D. There was no subsidy recorded for 2024 and 2023.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to the post-retirement benefit obligation, the funding of which is not covered by the contribution rate determined by EWS. It is expected that the deficiency will be funded through future increases in the contribution rates. In addition, health claims incurred by retired participants but not reported at December 31 are included in the accumulated post-retirement benefit obligation. Also, health claims in the course of settlement are included in the amounts currently payable on the statement of benefit obligations shown above, as of December 31, 2024 and 2023.

For measurement purposes, an annual rate of increase in the per capita cost of covered health care benefits was assumed at 5.75% for 2024 and 6.00% for 2023. This health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by approximately \$215,000 and \$246,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligation.

Note 6. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and the actuary. These expenses are reported in the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Note 7. Transactions With Parties-in-Interest

Administrative expenses totaling approximately \$837,000 and \$731,000 were paid during 2024 and 2023, respectively, to United Healthcare for processing of health claims and certain other administrative expenses incurred in maintaining the Plan.

Stop-loss insurance coverage for the health care benefits program was maintained by United Healthcare, and premiums associated with this coverage totaled approximately \$2,775,000 and \$1,819,000 during 2024 and 2023, respectively.

Reinsurance premiums for retirees paid to United Healthcare totaling approximately \$239,000 and \$233,000 in 2024 and 2023, respectively.

The dental benefits program was administered by Delta Dental, which received administrative fees of approximately \$53,000 and \$41,000 during 2024 and 2023, respectively.

Premium and other benefits programs are administered by Hartford Life and Accident Insurance Company, Prudential Insurance Company of America, Symetra Life Insurance Company, EyeMed Vision Care and Metropolitan General Insurance Company who are also considered parties-in-interest.

Section 1341 of the Affordable Care Act established a transitional reinsurance program to stabilize premiums in the individual market inside and outside of the Marketplaces. The transitional reinsurance program collects contributions from contributing entities to fund reinsurance payments to issuers of nongrandfathered reinsurance-eligible individual market plans, the administrative costs of operating the reinsurance program, and the General Fund of the U.S. Treasury. There was no fee in 2024 or 2023.

In 2019 the Affordable Care Act imposed fees on issuers of specified health insurance policies and plan sponsors of applicable self-insured health plans to help fund the Patient-Centered Outcomes Research Institute. The Plan paid a fee of approximately \$6,500 and \$7,600 in 2024 and 2023.

Note 8. Tax Status

The health care and dental benefits programs are funded through a Voluntary Employee Benefit Association Trust (the Trust). All other programs in the Plan are nonfunded. The Trust funding the Plan has received a determination letter from the Internal Revenue Service dated May 9, 1994, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Code as a Voluntary Employee Benefit Association and that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

The Plan has been amended since receiving the determination letter. Plan management and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements and disclosures.
