Independent Auditors' Report

To the Administrative Committee of the
Health and Welfare Trust for the Constellis Plan for Funded Benefits:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Health and Welfare Trust for the Constellis Plan for Funded Benefits, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Health and Welfare Trust for the Constellis Plan for Funded Benefits' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Health and Welfare Trust for the Constellis Plan for Funded Benefits and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter Regarding Plan Funding

As discussed in Note 2 to the financial statements, the Plans' benefit obligations exceeded its net assets available for benefits as of December 31, 2024. Management's evaluation of these conditions and its plans regarding the matter, including the Company's commitment to provide additional funding as needed, are described in Note 2. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Health and Welfare Trust for the Constellis Plan for Funded Benefits' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Health and Welfare Trust for the Constellis Plan for Funded Benefits' internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Health and Welfare Trust for the Constellis Plan for Funded Benefits' ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets held at end of year as of December 31, 2024 and reportable transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The Health and Welfare Trust for the Constellis Plan for Funded Benefits ("Trust") consists of certain combined transactions of the Constellis Funded Health and Welfare Plan and Trust ("Plan 503") and the Constellis Health and Welfare Plan ("Plan 501"), (collectively, the "Plans").

The following description of the Plans provides only general information about the Plans' provisions. Participants should refer to each of the Plan agreements for a more complete description of the provisions of the Plans and the Trust.

General:

The Plans were established effective January 1, 2018, by Constellis Group, LLC, (the "Company") to provide health and welfare benefits to certain designated employees of the Company and certain Company affiliates (together, the "Employer") and their dependents.

Contributions to both Plans are made by the Employer. In addition, active employees and certain former employees make contributions to both Plans and active subcontractors and certain former subcontractors also make contributions to Plan 501. Contribution rates are based on insurance premiums established by various insurance carriers providing group insurance policies and funding levels required to meet projected expenditures and are determined by Company management in consultation with its insurance carriers and its third-party administrators, Anthem, Inc., and Metropolitan Life Insurance Company ("MetLife"). Employee and subcontractor participation is voluntary. Any deficiency of the Plan's net assets over benefit obligations is funded by the Employer on a pay-as-you-go basis.

The Plans are subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Company is the designated administrator of the Plans. The Company has entered into an agreement whereby, Principal Trust Company (the "Trustee") has been appointed the Trustee of the Trust's assets. Under the terms of the agreement, the Trustee holds and invests the funds of the Trust.

Eligibility and benefits:

Eligibility requirements and benefits available vary depending upon the location at which a participant is employed. Participants should refer to the applicable Plan documents for each location which set forth the specific eligibility requirements and benefits available for that location.

The Plans provide health benefits (medical, vision, and dental), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. The Plans also provide continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Under Plan 501, the dental, vision, life insurance, accidental death and dismemberment, short-term disability, long-term disability and certain medical benefits are fully insured through annual insurance contracts purchased by the Company from MetLife and other carriers under the provision of group insurance policies. Premiums for certain medical benefits are paid from the assets of the Trust. Premiums for all other insured benefits are paid to the insurance company from the general assets of the Company. Medical benefits offered for certain locations are self-insured and are processed by the Plans' third-party claims processors under administrative services only ("ASO") arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Trust or the Company, up to a maximum liability as defined in the terms of the applicable Plan documents, as amended.

Despite the Plans' utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plans.

Under Plan 503, the dental, vision, life insurance, accidental death and dismemberment, and long-term disability benefits are fully insured through annual insurance contracts purchased by the Company from MetLife under the provision of group insurance policies. Premiums for the insurance programs are paid to the insurance company from the general assets of the Company. Medical and short-term disability benefits are self-insured and are processed by the Plans' third-party claims processors under ASO arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Trust or the Company, up to a maximum liability as defined in the terms of the applicable Plan documents, as amended. Despite the Plans' utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plans.

Stop loss coverage:

The Plans have entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Contributions:

Premiums to the various benefit plans covered by the Plans are determined annually by Company management based on projected costs to provide insurance benefits and vary based upon the customer contract or legal entity or company location to which an employee is assigned. The participant contributions also vary by each Plan based on customer contracts or benefits levels the Company chose to provide.

Plan termination:

Although it has expressed no intention to do so, the Company retains the right to terminate each of the Plans. In the event of termination of either of the Plans, assets of the terminated Plan and the Trust will be used to pay subsequent claims until such assets are exhausted.

2. Summary of Accounting Policies

Basis of accounting:

The Plans' financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Going Concern:

As of December 31, 2024, the Plans' benefit obligations exceeded its net assets available for benefits by \$3,534,306. These conditions initially raised substantial doubt about the Plans' ability to continue as a going concern.

In view of this matter, continuation as a going concern is dependent upon several factors, including reduced claims experience and the continued financial support of the Company to provide additional contributions as necessary to fund benefit payments and meet the Plans' obligations. Management has implemented plan design changes and claims management initiatives to reduce future costs, and the Company has represented its intent and financial ability to provide funding as needed.

Based on management's plans and the Company's intent and ability to provide additional funding, as needed, management concluded that the conditions giving rise to substantial doubt about the Plans' ability to continue as a going concern have been alleviated.

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Significant estimates include the liability and provision for IBNR claims. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plans' management determines the Plans' valuation policies. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of benefits:

Premiums paid by either the Company or the Trust are recorded as insurance premiums in the accompanying Statements of changes in net assets available for benefits.

Claim payments are recorded by the Plans as notified by Anthem, Inc. and MetLife. In addition, a provision is made to cover claims incurred but not reported ("IBNR"). The liability and provision for IBNR claims is calculated by Willis Tower Watson. In the opinion of management such reserve is adequate. Adjustments resulting from differences between estimates and actual payments, if any, to the amounts recorded at December 31, 2024 and 2023 will be reflected in the Trust's Statements of changes in net assets available for benefits as such adjustments become determinable.

Financial instruments:

Contributions receivable, claims incurred but not reported, and other payables are carried at cost which approximates fair value due to the short-term nature of these instruments.

Administrative Expenses:

Certain expenses of maintaining the Plans are paid by the Plans, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Subsequent events:

The Plans' management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. Related Party Transactions

Certain investments and related transactions as of December 31, 2024 and 2023 and for the years then ended were in investment funds managed by the Trustee. These investments and transactions qualify as party-in-interest transactions and are not considered prohibited by statutory exemptions under ERISA.

4. Claims Incurred But Not Reported

The Plans' obligations at December 31, 2024 and 2023 for claims incurred but not reported were estimated by the Plans' actuary in accordance with accepted actuarial principles based on claims data provided by the Plans' third-party claims administrators. These amounts are paid by the Plans only if claims are submitted and approved for payment.

5. Information Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule of assets held at end of year, including investments held at December 31, 2024 and 2023, and interest income for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash – Interest-bearing cash is valued at the closing price as reported by the fund sponsor from an actively traded exchange.

7. Administrative Expenses

The Trust pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the Trustee and actuary. These expenses are reported on the Statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, and one of the third-party claims administrators, are paid by the Company on behalf of the Plans.

8. Tax Status

The Trust is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Employer has obtained a favorable tax determination letter from the Internal Revenue Service dated May 18, 2017, with respect to the Trust and management believes that the Trust continues to qualify and to operate as designed.

U.S. GAAP requires management to evaluate tax positions taken by the Plans and recognize a tax liability if the Plans have taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. There are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plans are subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plans to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plans, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plans may revert to the Company or be used for purposes other than for the exclusive benefit of the Plans' participants.

10. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

The Plans invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of net assets available for benefits.
