To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JAS Forwarding (USA), Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the JAS Forwarding (USA), Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan, which provides benefits to substantially all employees of JAS Forwarding (USA), Inc. (the “Company”), who have reached the age of 21 and have completed three months of service, except for employees whose benefits have been collectively bargained, residents of Puerto Rico, temporary employees, interns and contractors. The Eligible entry date into the plan is the first day of the month following 90 days of employment.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company is the trustee of the Plan.

Contributions—Each year, participants may contribute up to 75% of their pretax annual compensation, as defined in the Plan. Those participants who meet the eligibility requirements may contribute additional amounts (e.g., age 50 catch-up); these additional contributions are ineligible for a Company-matching contribution. A participant may elect to not have contribution deferrals withheld from their bonus payments. The Company contributes 50% of the first 5% of eligible compensation that a participant contributes to the Plan. The Company may also elect to make a discretionary profit-sharing contribution to the Plan. No profit-sharing contributions were made for 2024 plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution; the Company’s matching contribution; and allocations of the Company’s discretionary contributions and Plan earnings and charged with withdrawals and an allocation of the Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund (the “Fund”) as investment options for participants.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. A participant vests in the Company’s matching and profit-sharing contributions, plus earnings thereon, at the rate of 20% per year of credited service. Full vesting also occurs on attainment of normal retirement age, disability, or death.

Participant Loans—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. Loans are repayable through payroll deductions over periods ranging up to 60 months, except for a primary residence loan for which the term may be extended to 10 years. Loans are secured by the balance in the participant’s account and bear interest at rates commensurate with local prevailing rates, as determined by the Plan’s recordkeeper, fixed over the life of the loan.

Payment of Benefits—Upon termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may elect to receive installment payments over a period not to exceed 10 years or a lump-sum amount equal to the vested value of his or her account.

In-service withdrawals are permitted upon attainment of age 59 1/2 or in the case of financial hardship.

Forfeited Accounts—Forfeited balances represent the nonvested portion of the participant accounts and excess Company contributions made to the Plan resulting from a correction of excess match contributions during 2024. As a result, for the year ended December 31, 2024, \$1,079,920 of the forfeiture accounts is included in the employer contributions amount reported in the statement of changes in net assets available for benefits. The Plan document permits the use of forfeitures to either reduce future Company contributions or pay certain Plan expenses. During 2024, plan expenses were reduced by \$47,247 from the forfeiture accounts. No forfeiture balance was used to reduce employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$1,507,896 and \$143,027, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, including mutual funds and the Fund. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and market risks. Overall market volatility includes global events which could impact the value of investment securities, such as a pandemic or an international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Concentrations of Investments—The Plan’s investment in the following fund accounted for greater than 10% of total investments:

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a

liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion on fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or Plan Sponsor as provided in the Plan document.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024 and 2023.

Excess Contributions Payable—The Plan is required to return contributions received during the year in excess of the IRC limits.

3. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Company and the Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan and related trust continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

5. FAIR VALUE MEASUREMENTS

Accounting Standards Codification 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1 which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3 which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund—Collective trust fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

Administrative revenues arise when investment managers return a portion of the investment fees to Fidelity Management Trust Company to offset the administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid. For the year ended December 31, 2024, no administrative revenue balance was used to offset Plan expenses. The Plan held undistributed administrative revenues of \$81,346 and \$51,224 as of December 31, 2024 and 2023, respectively.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

9. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

In 2024, 2023 and 2022, the Company remitted certain participant contributions and loan repayments totaling \$9,250, \$699,930 and \$287,982 respectively, to the trust later than required by the Department of Labor's Regulation 2510.3-102. The Company will file Form 5330 with the IRS and pay the required excise tax. The participant accounts of those directly impacted will be credited with the amount of investment income that would have been earned had the remittance been timely.

10. SUBSEQUENT EVENTS

For the year ended December 31, 2024 subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued. Effective March 1, 2025, the Plan joined Transamerica Retirement Solutions, LLC 401(k) Profit Sharing Plan. As a result, the Plan is now part of a pooled arrangement under the SECURE Act, whereby multiple unrelated employers participate in a single plan structure.

Participation in the pooled employer plan allows the Plan to benefit from economies of scale related to plan administration, investment selection, and compliance oversight. Plan assets, participant accounts, and plan records remain separately identifiable and are maintained in accordance with the provisions of the pooled employer plan.

The change in plan structure does not affect participants' eligibility, vesting provisions, or benefit entitlements under the Plan. All plan operations, including contributions, distributions, and other transactions, are administered in accordance with the terms of the pooled employer plan.
