NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Care-A-Lot Child Care Investment and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering all employees of DMK Endeavors, Inc., including those employed by its subsidiaries: Browncroft Day Care Center, LLC; Generations Child Care, Inc.; Care-A-Lot Child Care, Inc.; Care-A-Lot Child Care of Henrietta, Inc.; Care-A-Lot Child Care of Farmington, Inc.; Care-A-Lot Child Care of North Greece, Inc.; Victor Child Care Center, Inc.; Storybook Child Care, Inc.; and Bates-Rich Beginnings Child Care, Inc. (together, the "Company"). The Plan excludes non-resident aliens with no U.S. source income and residents of Puerto Rico. The Plan was initially effective as of January 1, 1998 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 29, 2023, the Generations Child Care, Inc. 401(k) P/S Plan (Generations) participants were merged into the Care-A-Lot Child Care Investment and Retirement Plan, at which point the Generation's Plan was terminated. Approximately \$719,000 of investments were transferred into the Plan from the Generations Plan in January 2024.

Administration -

The Company is the Plan Administrator. The Plan's assets are participant directed and are held in trust and managed by Principal Life Insurance Company, Principal Global Investors Trust Company and Principal Trust Company (the "Custodians" or "Principals") effective the beginning of 2024. Prior to 2024, the Plan's assets were managed by ADP (DMK Endeavors, Inc.) and Equitable (Generations Child Care, Inc. 401(K) P/S Plan). Administrative expenses are paid by the Company, except for administrative expenses related to personal retirement accounts, which are deducted from the related participants' accounts.

Eligibility -

All employees who have attained 18 years of age, with the exception of non-resident aliens and residents of Puerto Rico, and who have completed 180 days of service are eligible to begin salary deferrals on the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements.

The Plan has adopted and implemented an automatic enrollment provision. Participants who meet the eligibility requirements above will be automatically enrolled in a designated target date fund at a 3% deferral rate on a pre-tax basis until changed by the participant. The automatic escalation provision for the participants who are automatically enrolled is 1% annually until the deferral percentage equals 10%.

1. DESCRIPTION OF PLAN (Continued)

Contributions -

Participants may make voluntary pre-tax and post-tax contributions in the form of salary reductions up to 90% of their annual compensation, as defined, subject to certain limitations under the terms of the Plan and Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes matching contributions equal to 100% of the first 3% of participant elective deferrals and 50% of the next 2% of participant elective deferrals. The Company may also make profit sharing contributions to the Plan on a discretionary basis. Profit sharing contributions are allocated to participants based on the percentage of their respective compensation divided by total compensation of all participants eligible for the profit share. To be eligible for profit-sharing contributions, participants must be employed on the last day of the Plan year and have worked a minimum of 1,000 hours in the Plan year. No profit-sharing contributions were made to the Plan during 2024.

Investment Options -

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options as indicated by the Plan sponsor, which provide diversified investment allocations. Participants may change their investment options electronically at any time during the year.

Participant Accounts -

Participants' accounts are credited with their contributions and allocations of (a) the Company's contribution and (b) the Plan's earnings. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their own salary and wage deferrals and Company matching contributions, plus actual earnings thereon. Profit sharing contributions vest based on years of continuous service. A participant is 20% vested after two years of service, and vests 20% per year until they are 100% vested after six years of credited service or upon death, disability, or reaching the age of 65.

Forfeitures -

Any forfeitures arising under the Plan are applied against future employer contributions to the Plan or employer administrative expenses related to the Plan. Forfeiture amounts of \$1,176 were used to reduce administrative expenses during 2024.

Notes Receivable from Participants -

Participants may borrow up to the lesser of 50% of their vested account balances or \$50,000, subject to a minimum loan of \$500. Participants may choose an amortization schedule of up to five years, unless the note is used for a primary residence, in which case the amortization schedule may be up to 20 years. Principal and interest are paid through payroll deductions. Interest on notes receivable from participants is charged at the prime rate at the time of loan origination plus 2% (9.50% at December 31, 2024).

1. DESCRIPTION OF PLAN (Continued)

Benefit Payments -

On termination of service due to health, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account, or annual installments over a specified period. Vested balances that do not exceed \$5,000 may only be distributed in a single lump-sum payment. Additionally, the Plan provides for in-service withdrawals once a participant reaches age 59 ½ even if still employed.

Hardship Withdrawals -

Hardship withdrawals from the Plan are permitted from fully-vested accounts. Hardship withdrawals can only be made if there is an immediate and heavy financial need, as defined in the plan document.

Plan Termination -

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts then credited to the account of any affected participant shall become 100% vested and shall not thereafter be subject to forfeiture.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting -

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States (GAAP).

Investments -

Investments in mutual funds are stated at fair value based on quoted market prices. Investments in pooled separate accounts and common collective trust funds are valued at the net asset value of the underlying shares held by the Plan. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held, during the year. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

Contributions Receivable -

Contributions from Plan participants and the related employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payments of Benefits -

Benefit payments are recorded when paid.

Fair Value Measurement -

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). There were no changes in valuation techniques in 2024. The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access. All of the Plan's investments are valued utilizing level 1 inputs.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 3 inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation methodologies used for assets measured at fair value are as follows:

Pooled separate accounts - Valued at the net asset value ("NAV") of the underlying shares held by the Plan at year-end.

Mutual funds - Stated at fair value based on quoted market prices.

Common collective trust funds - Valued at the net asset value ("NAV") of the underlying shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts in the financial statements, supplemental schedule and accompanying notes. Actual results could differ from those estimates. Significant estimates included in these financial statements include investment valuations, as described above.

Risks and Uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

Income Taxes -

The Plan sponsor is required to determine whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions.

Events Occurring After Reporting Date -

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 14, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

4. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024.
- Notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment activity, including interest income on loans to participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on Schedule I.

5. TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are held in pooled separate accounts and common collective trust funds managed by the Custodian. Therefore, these transactions qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

7. NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS

For the Plan year 2024, the Plan Sponsor did not remit participant contributions and employer matching contributions for nine pay periods to the custodian in a timely manner based on when the contributions were withheld from the participants' paychecks as required under Department of Labor Regulations §2510.3-102. The delinquent participant contributions totaled \$24,813 during the year ended December 31, 2024. Of this amount, \$1,809 was not deposited into the Plan prior to year-end and is included in the participant receivable on the Statement of Net Assets. The remaining \$23,004 was deposited into the Plan prior to year-end. The delinquent employer matching contributions totaled \$10,417 and are included in the employer contributions receivable on the Statement of Net Assets.

7. NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS (Continued)

Once discovered, the Company filed IRS Form 5330 to report and pay an excise tax with respect to the late remittances, and the participant accounts were credited with the amount of investment income that would have been earned had the participant contributions and employer matching contributions been made on a timely basis. Lost earnings related to participant contributions totaling \$198 have been recorded as part of the participant contributions receivable as of December 31, 2024 and lost earnings related to employer contributions totaling \$715 have been recorded as part of the employer contributions receivable as of December 31, 2024. All lost earnings were deposited into the Plan during 2025.
