We are required to be independent of the Glow Networks 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Glow Networks 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that,

individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Glow Networks 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate that raise substantial doubt about the Glow Networks 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedule of Assets (held at end of year) is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial

statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Glow Networks 401(K) Plan (The “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

On July 13, 2020, total assets transferred to the Plan of the Company were \$4,454,780.29.

General

The Plan is a defined contribution 401(k) plan established by Glow Networks Inc (the “Company”) on January 01, 2020, but elective deferral provision started July 10, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Administration

The Plan administrator manages the operation and administration of the Plan. The Company has contracted with Alerus Financial, N.A to act as the trustee, and a third-party administrator to process and maintain the records of the participant data. The Company is the Plan sponsor and serves as the plan administrator.

Eligibility:

An employee will be eligible to participate in the Plan when he/she has completed three months of service and has attained age 21. However, he/she will become a Participant in the Plan once he/she reaches the Entry Date as described below.

Entry Date: An employee’s Entry Date will be the first day of the plan year quarter coinciding with or next following the date on which he/she satisfies the eligibility requirements.

Participant Contributions:

Employee contributions to the Plan are elective deferrals (generally means pre-tax deferrals and Roth deferrals) of the employee’s compensation made through a direct reduction of compensation in each payroll period. The maximum tax-deferred contribution may not exceed \$23,000 for 2024, adjusted for inflation. Catch up contributions up to a maximum of \$7,500 were allowed for 2024 under IRS regulations for the 50 or older participants.

Employer contributions:

Employers may make a discretionary matching contribution equal to a uniform percentage or dollar amount of employee elective deferrals. Each year, Employer will determine the formula for the discretionary matching contribution. Matching contributions and profit-sharing contributions by the Company are discretionary. During 2024, the Company did not match employee contribution and no profit-sharing contribution.

Rollover:

Employees may roll over eligible amounts from other qualified plans or IRA to the Plan. Employee may reduce, or defer entirely, the tax due on your distribution through use of one of the following methods:

1. 60-day rollover
2. Direct rollover

Participant Accounts

Each participant's account is credited with (i) the participants contributions, (ii) the Company's matching contribution, (iii) their share of the Company's additional discretionary contributions, if any, (iv) net earnings (loss) on their account and (v) charged with allocation of administrative/investment expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participants' vested account.

Investment:

The Plan provides investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time. If participants do not direct the investment of applicable Plan accounts, then their accounts will be invested in accordance with the default investment alternatives established under the Plan.

Rollover Contributions:

Employees may roll over eligible amounts from other tax qualified employer-sponsored retirement plans to the Plan. Such contributions are deposited in the appropriate investment of funds in accordance with the participant's direction and the Plan's provisions.

Vesting

Each participant is always 100% vested meaning that a participant will be entitled to all the amounts in his/her accounts attributable to the following contributions:

- Salary deferrals including Roth 401(k) deferrals and "catch-up contributions"
- Employer matching contributions
- Employer Nonelective contributions
- "Rollover" contributions

Forfeitures:

Forfeitures are a non-vested portion of participants' accounts that are lost upon termination of employment. As of December 31, 2024, and December 31, 2023, the forfeiture account balance was \$0.

Payment of Benefits

Upon normal retirement, termination of service, disability, death or separation from service, participants receive their vested benefit in his or her account as a lump sum distribution.

Hardship Withdrawals

A participant may request hardship withdrawal under certain conditions as specified in the Plan. Hardship withdrawals must be approved by the Plan Administrator.

Notes Receivable from Participants and Deemed Distributions:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Under certain circumstances, a loan that is in default may be considered as a distribution from the Plan and could be considered taxable income to participant.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess, if any, of participants highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over participant's current outstanding balance of loans as of the date of the new loan; or 50% of the vested account balance. However, a participant may have no more than one outstanding loan at any one time. Loan transactions are considered a directed investment of participant's account under the Plan. All payments of principal and interest by participants on a loan will be credited to participant's account. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence.

The loans are secured by the vested balance in the participant's account provided the outstanding balance of participant's all loans do not exceed 50% of participant's vested interest in the Plan and bear commercially reasonable rate of interest. The loan will provide at least quarterly payments under a level amortization schedule. The participants repay the loan by agreeing to payroll deduction, payment by check (for prepayments or payments by terminated participants only).

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties:

The Plan provides various investment options in any contribution of equity, fixed income, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported to be of fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement for discussion of fair value measurements. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. No allowance for credit losses has been recorded on December 31, 2024, or 2023. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Excess Contribution Payable:

The Plan is required to return contributions to participants in the event that certain non-discrimination tests defined under the IRC are not satisfied. Amounts payable to participants for contributions more than amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability. As of December 31, 2024, and 2023, there was no excess contribution payable balance.

Administrative Expenses

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Other related expenses are separately included in the Statement of Changes in Net Assets Available for Benefits as administration fees.

**NOTE 3. RISK AND UNCERTAINTIES**

The Plan provides various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, overall market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 4. FAIR VALUE MEASUREMENTS**

Fair Value Measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024, and 2023

*Mutual Funds and Unit Investment Trusts:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5: CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A.

**NOTE 6: RELATED PARTY TRANSACTIONS**

The Plan's investments in the shares of registered investment companies are managed by Alerus Financial, N.A. Alerus Financial, N.A is the Trustee as defined by the Plan and therefore, these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan issues loans to participants, which are secured by the balances in the participant's account. These transactions also qualify as party-in-interest transactions.

**NOTE 7: INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated June 30, 2020, from the IRS. The Plan has been amended since; however, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believe that the Plan is qualified, and the related trust is tax- exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8: SUBSEQUENT EVENT**

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. The Plan has concluded that no events or transactions have occurred which would require adjustments or disclosures in the financial statements.
