Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Additional Information**

## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of SDI International Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all employees of SDI International Corp (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain IRS limitations.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

#### Vesting:

Participants are immediately vested in their salary deferral and rollover contributions, plus actual earnings thereon.

#### Investment Options:

Participants direct contributions into various investment options offered by P&A Retirement Services. Participants may change their investment options at any time.

### Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years, unless the loan is used to acquire a principal residence. The loans are secured by the vested balance in the participant's account. The loans bear interest at a rate equal to 1% above the prime rate, which is fixed for the duration of the loans. Repayments on principal and interest is paid ratably through payroll deductions.

#### Payment of Benefits:

Upon termination of service, a participant may elect to receive benefits in accordance with available options pursuant to the terms of the Plan.

### 2. Summary of Significant Accounting Policies:

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Inputs to the valuation methodology for mutual funds are unadjusted quoted prices for identical assets in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

### **Payment of Benefits:**

Benefits are recorded when paid.

### **Administrative Expenses:**

Certain accounting and administrative expenses are paid by the Sponsor. Expenses related to investment activity are paid by the Plan.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 17, 2025, the date the financial statements were available to be issued.

### **3. Financial Information Certified by the Trustee:**

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Mid Atlantic Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024 that the information below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments.
- Statement of Changes in Net Assets Available for Benefits – Investment income.
- Schedule of Assets (Held at End of Year) – all items except notes receivables from participants.

### **4. Plan Termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time or terminate the Plan subject to the provisions of ERISA.

### **5. Tax Status:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

### **6. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SDI International Corp. 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of SDI International Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all employees of SDI International Corp (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain IRS limitations.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

#### Vesting:

Participants are immediately vested in their salary deferral and rollover contributions, plus actual earnings thereon.

#### Investment Options:

Participants direct contributions into various investment options offered by P&A Retirement Services. Participants may change their investment options at any time.

### Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years, unless the loan is used to acquire a principal residence. The loans are secured by the vested balance in the participant's account. The loans bear interest at a rate equal to 1% above the prime rate, which is fixed for the duration of the loans. Repayments on principal and interest is paid ratably through payroll deductions.

### Payment of Benefits:

Upon termination of service, a participant may elect to receive benefits in accordance with available options pursuant to the terms of the Plan.

### 2. Summary of Significant Accounting Policies:

#### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Inputs to the valuation methodology for mutual funds are unadjusted quoted prices for identical assets in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

### **Payment of Benefits:**

Benefits are recorded when paid.

### **Administrative Expenses:**

Certain accounting and administrative expenses are paid by the Sponsor. Expenses related to investment activity are paid by the Plan.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 17, 2025, the date the financial statements were available to be issued.

### **3. Financial Information Certified by the Trustee:**

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Mid Atlantic Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024 that the information below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments.
- Statement of Changes in Net Assets Available for Benefits – Investment income.
- Schedule of Assets (Held at End of Year) – all items except notes receivables from participants.

### **4. Plan Termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time or terminate the Plan subject to the provisions of ERISA.

### **5. Tax Status:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

### **6. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
