Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

The Plan is a defined contribution plan covering all employees of Vacation Innovations, LLC (the "Company"), who have completed six months of service, are age twenty-one or older and are not union employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute up to 100% of compensation, as defined in the Plan, subject to Internal Revenue Code limitations. Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. The Plan allows the Company to make both discretionary matching contributions and profit sharing contributions. The Company did not make or elect to make any discretionary matching or profit sharing contributions during 2024 or 2023. The Plan also includes a Safe Harbor provision which requires the Company to make minimum qualified matching contributions in accordance with requirements of the Internal Revenue Code. Currently, the Company matches 100% of participant contributions up to the first 6% of Plan compensation, as defined in the Plan under the Safe Harbor provision. Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may also invest in self-directed brokerage accounts.

Voluntary "rollover" contributions may be accepted by the Plan under certain terms and conditions.

A. Description of the plan (continued):

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) forfeitures of terminated participants' non-vested accounts, (c) Plan earnings and (d) Plan administrative expenses, as required. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in all their contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings is based on years of service. A participant vests at 20% annually, starting with one year of service, until fully vested upon completion of five years of credited service. Any participant employed at the date of total and permanent disability, death or the attainment of normal retirement age, as defined, is deemed to be 100% vested.

Participant notes receivable:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 reduced by the highest outstanding loan balance in the participant's account or 50% of their vested account balance, whichever is less. Loan terms may not exceed five years unless for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator at the time of issuance. Principal and interest are repaid ratably through payroll deductions.

Payment of benefits:

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum payment equal to the vested value of his or her account. Participants who continue in the employment of the Company may request a pre-retirement distribution of defined amounts under certain hardship conditions, as defined in the Plan.

A. Description of the plan (continued):

Payment of benefits (continued):

The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59½ or under certain qualifying conditions, as defined by the Plan.

Forfeited accounts:

Forfeited accounts represent non-vested Company contributions forfeited by employees who terminate their employment or withdraw from the Plan. Forfeitures are retained by the Plan and used to reduce future Company discretionary contributions and administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

B. Summary of significant accounting policies:

Basis of accounting:

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles (GAAP).

Use of estimates:

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Investment valuation and income recognition (continued):

The change in fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gains or losses on investments are the difference between the proceeds received and the fair value of the investment sold at the beginning of the Plan year.

Participant notes receivable:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of benefits:

Benefits are recorded when paid.

C. Information prepared and certified by the Custodian:

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for certain investments.

Other than the self-directed brokerage accounts managed by Charles Schwab and Raymond James, the investment information included in the accompanying financial statements and supplemental schedules was obtained from data that has been certified as complete and accurate to the Plan Administrator by John Hancock Trust Company LLC ("John Hancock"), a Custodian of the Plan, at December 31, 2024 and 2023. Incorporation of this financial information in the accompanying financial statements and supplemental schedules is based solely on those certifications.

The investment income related to investments maintained by John Hancock reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024 was certified by John Hancock.

D. Fair value measurements:

The Fair Value Measurements and Disclosures Topic of FASB ASC requires disclosure of a fair value hierarchy of inputs the Plan uses to value an asset or a liability.

The three levels of the fair value hierarchy are described as follows:

- Level 1: Quoted prices (unadjusted) in active markets for identical assets and liabilities. For the Plan, Level 1 inputs include marketable securities that are actively traded.
- Level 2: Inputs other than Level 1 that are observable, either directly or indirectly. The Plan did not have any Level 2 assets at December 31, 2024 or 2023.
- Level 3: Inputs that represent financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. The Plan did not have any Level 3 assets at December 31, 2024 or 2023.

The determination of where assets and liabilities fall within this fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed Brokerage Accounts: Primarily consists of mutual funds, common stock and interest-bearing cash accounts that are valued on the basis of readily determinable market prices.

D. Fair value measurements (continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Stable value fund:

The Plan has a traditional, fully benefit-responsive investment contract (the "Contract") with John Hancock. John Hancock maintains the contributions in a common collective trust. The Contract is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. This Contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the Contract, plus investment income credited to the

Contract based on contract rates currently earned by John Hancock, less funds used to make benefit payments to participants and to pay administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value of this traditional investment contract at December 31, 2024 and 2023 was \$71,865 and \$61,917, respectively. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the Contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with John Hancock. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

F. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

G. Tax status:

The Plan has adopted a prototype plan that has been determined by the Internal Revenue Service, in an opinion letter dated June 30, 2020, to be in accordance with applicable sections of the Code. The Plan Administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

H. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

I. Administrative expenses:

Administrative expenses associated with custody and recordkeeping are paid through forfeited accounts or by the Company. Loan and other transaction fees are charged to participants. The Company provides certain accounting and management services to the Plan at no charge and pays for the annual audit of the Plan.

J. Related party transactions:

Certain Plan investments are shares of funds managed by John Hancock, Charles Schwab and Raymond James, the Custodians as defined by the Plan, and therefore these transactions qualify as exempt party-in-interest transactions.

K. Subsequent events:

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
