INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AIP-ECS Holdings, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of AIP-ECS Holdings, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. AIP-ECS Holdings, LLC 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN

The following description of the AIP-ECS Holdings, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of AIP-ECS Holdings, LLC and affiliates (collectively, the Company, Plan Sponsor, or Plan Administrator). Jones-Bell, LLC dba ECS Environmental Solutions and KCH Services, Inc. are affiliates which have adopted this Plan as participating employers. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee (Investment Committee) determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by John Hancock Life Insurance Company (U.S.A.) (John Hancock), the custodian and qualified institution for the Plan which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee and provides certain recordkeeping services. Loren D. Stark Company (Loren) acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

Employees may become a participant of the Plan if they have reached twenty one years of age or older. An eligible employee may enter the Plan on the first day of the calendar month coinciding with or subsequent to the date of hire.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

AIP-ECS Holdings, LLC 401(k) Plan Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN (Continued)

The Company makes a safe harbor matching contribution equal to 100% of participant deferrals that do not exceed 1% of compensation plus 50% of participant deferrals between 1% and 6% of compensation. The Company may also make matching contributions equal to a discretionary percentage, up to a maximum of 4%, of the participants' compensation. The Company may also make a discretionary profit sharing contribution as well. There were no discretionary matching or profit sharing contributions during 2024. Company safe harbor matching contributions totaled \$213,448 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are automatically vested in Company contributions upon death, disability or retirement. Vesting in the Company's contributions plus actual earnings thereon varies based upon the type of Company contribution and is based on years of service as defined in the Plan document. The following schedule describes the participant's level of vesting after each year of service.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account. The loan interest rate is set 1% above the prime rate, as defined. The principal and interest is paid ratably through monthly payroll deductions or by check.

Benefit Payments

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive a lump-sum distribution based on the valuation of the participant's accounts as of the date of termination. If the vested account balance does not exceed \$5,000, the Plan Sponsor may pay the distribution in a direct rollover to an individual retirement annuity plan designated by the Plan administrator. Also, if a participant has reached the age of 70½, certain rules require these participants to take minimum distributions. These distributions may be paid in the form of an annuity.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,943 and \$11,852, respectively. Forfeitures can be used to reduce administrative expenses or employer contributions to the Plan. In 2024, administrative expenses were reduced by approximately \$3,400 from forfeiture nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 15, 2025. See Notes 8 and 9 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in the financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by the qualified institution:

- a) Total cash, investments, at fair value; and notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Net appreciation in value of investments and interest income from notes receivable information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c) All amounts included in Note 4, *Fair Value Measurements*;
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Variable annuities valued at net asset value (NAV) per share as determined by the issuer based on market quotations of the underlying investments or prices obtained from independent sources who may employ various pricing methods to value the underlying securities. The pooled separate accounts balance as of December 31, 2024 and 2023 of \$2,905,074 and \$2,139,422, respectively, are measured at fair value using the NAV per share (or its equivalent practical expedient); therefore, they have not been classified in the fair value hierarchy, in accordance with ASU 2015-07.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: TAX STATUS

The Plan adopted Loren D Stark's Volume Submitter Profit Sharing Plan. The IRS has determined and informed Loren by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan holds notes receivable from participants. As a result, these receivables and all transactions relating to these receivables are considered party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Certain Plan investments are managed by John Hancock. John Hancock is the custodian and record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan incurs expenses related to general administration, recordkeeping services and investment advisory services. These expenses qualify as party-in-interest transactions.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 8: PROHIBITED TRANSACTIONS

During 2024 and 2023, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in prohibited (or a non-exempt) transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these non-exempt transactions in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is correcting these non-exempt transactions by funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' account if the late remittances had been made on a timely basis. Lost earnings are not significant and therefore, are not included in the accompanying financial statements.

In 2024, the Company discovered errors related to the administration of the auto-enrollment provision of the Plan whereby certain eligible employees were not enrolled in a timely manner. These errors related to 2024 and prior years. The errors related to 2023 and prior totaled \$95,731 and the errors related to 2024 totaled \$70,970. The Company made a qualified non-elective contribution (QNEC) of \$95,731 in 2025 to correct these 2023 and prior errors and intends to make a QNEC contribution related to the 2024 errors. The Plan recorded corrective contributions receivable in the accompanying financial statements as of December 31, 2024 and 2023. The Company will also calculate and submit lost earnings in conjunction with these QNEC contributions.

Note 9: SUBSEQUENT EVENTS

In 2025, the Plan was amended effective January 1, 2025. Under the amended plan, participants are now required to be twenty one years of age or older and complete 90 days of service to be eligible to participate in the Plan.
