1. Description of Plan

The following description of Bowser Automotive, Inc. Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Bowser Automotive, Inc., Bowser Hyundai, L.L.C., Bowser Cadillac, L.L.C., Bowser Chevrolet, Inc. of Beaver, and Bowser Chevrolet of Monroeville, L.L.C. (Company), who have completed three months of service and are age twenty-one or older. These employees are eligible for the deferrals described below. Employees who have completed one year of service and are age twenty-one or older are eligible for the Company matching contributions as described below. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants who have completed three months of service may contribute up to the maximum dollar limit of pre-tax annual compensation allowed for by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company presently contributes 50% of the amount contributed by a participant who has completed one year of service, limited to 2% of the participant's total compensation. Participant contributions and employer matching contributions of certain highly compensated participants may also be limited based on contribution non-discrimination tests described in Internal Revenue Code ("IRC") Sections 401(k) and 401(m).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company matching contributions, allocations of the Plan's investment earnings, forfeited participant balances, and charged with an allocation of administrative expenses. Allocations are based on the participants' relative account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant's account attributable to employer matching contributions plus earnings thereon vest according to the following schedule:

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options.

Payment of Benefits

Participants are eligible to receive distributions upon reaching normal retirement age of 65, termination, or separation due to death or disability. In service distributions are also allowed upon attaining age 59 ½. Distributions from the Plan may be made either as a lump sum or, if applicable, by partial withdrawals or installments. Partial withdrawals or installments are only permitted for required minimum distributions under Code Section 401(a)(9).

Forfeited Accounts

Forfeitures may be used to pay any administrative expenses of the Plan. Forfeitures of matching contributions can be used to reduce the employer's matching contributions or allocated to participants. The ending balance of the forfeited non-vested accounts as of December 31, 2024 was \$371, and \$0 as of December 31, 2023. During 2024, employer contributions were reduced by \$37,963 from forfeited nonvested accounts (\$12,137 in 2023), with the remaining balance allocated to participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time. In the event of Plan termination, the respective participant interest, net of any termination fees, will become fully vested.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The administrative expenses of the Plan, if not paid by the Company, are paid first from the forfeitures, if any, and then from the Plan. All such costs and expenses paid from the Plan shall, unless allocable to the accounts of particular participants, be charged to the accounts of all participants as provided in the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Reclassification

Certain prior period balances have been reclassified to conform to the current year presentation.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

3. Investments – Unaudited

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company (AUL), a OneAmerica company, as trustee, has certified the completeness and accuracy of all investment information reflected in (1) the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, (2) the December 31, 2024, schedule of assets (held at end of year), and (3) the related investment activity reflected in the statements of changes in net assets available for benefits during the plan years ended December 31, 2024 and 2023.

4. Fair Value Measurements

U.S. GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for an asset or liability is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan assets measured at fair value:

Mutual funds: Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Investment Contract with Insurance Company

During the year ended December 31, 2018, the Plan entered into a benefit-responsive investment contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan.

Since this investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. AUL has determined that contract value approximates fair value. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was 2.00% for the year ended December 31, 2024 and 1.25% for the year ended December 31, 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA of 1974. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. Income Tax Status

The Plan utilizes a volume submitter plan adopted through AUL. The volume submitter plan obtained its latest determination letter as of June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Although the Plan has been amended or restated since receiving the determination letter, the Plan administrators believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax is included in the accompanying financial statements.

Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Transactions with Parties-In-Interest

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds shares of mutual funds and a guaranteed investment contract managed by AUL or an affiliate of AUL. AUL is the trustee of the Plan; therefore, these are considered party-in-interest investments. Global Retirement Partners serves as the Plan's investment advisor and is therefore also considered a party-in-interest. Dunbar, Bender & Zapf, Inc. prepares the Plan's form 5500 and is therefore also considered a party-in-interest. The auditor is also considered a party-in-interest for audit services provided to the Plan.
