In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (held at end of year) as of December 31, 2024, and Schedule of Reportable transactions for the year ended December 31, 2024, together referred to as "supplemental schedules" are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – DESCRIPTION OF PLAN

The following brief description of the Meacham & Apel Architects, Inc. Cash Balance Pension Plan (the Plan) is provided for general information purposes. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General Information

The Plan is a cash balance defined benefit plan established January 1, 2016, covering substantially all employees of Meacham & Apel Architects, Inc. (the Plan Sponsor or the Company) who have met the eligibility requirements. The Plan provides a guaranteed benefit to participants which is available to participants upon termination of employment or death. The Plan is funded entirely by contributions made by the Company to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is qualified under the Internal Revenue Code (the Code). The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The plan was amended on June 16, 2023, to place a freeze on benefit accruals for all active participants.

Eligibility

Generally, all employees of the Company who are over the age of 21 and have provided one month of service are eligible to participant. Certain classes of employees, including those covered by collective bargaining agreements and/or those who are non-resident aliens are not eligible to participate in the Plan.

Participant Benefits

Participants who meet the eligibility criteria, are provided with a vested retirement benefit which is determined based on a predetermined benefit formula (the Benefit Formula) under the Plan. The Benefit Formula provides for a contribution credit plus guaranteed interest credit, funded by contributions made by the Company to the Plan annually. The funded contributions are credited to each participant's hypothetical cash balance account based on the Benefit Formula. Participants will receive a contribution credit for each year they complete a year of accrual service. A participant is 100% vested after three years of service or upon attainment of normal retirement age.

Benefit Payments

Participants are entitled to full accrued pension benefits at the later of normal retirement age of 65 or their 3rd anniversary of joining the Plan. The Plan will credit the participant's hypothetical cash balance account with all or a portion of the participant's principal credit at the end of each period based on the service requirements, the Benefit Formula and the guaranteed interest credit. Upon termination of employment, the participant is entitled to receive a distribution from the Plan.

Benefit Payments (continued)

The amount of the distribution is equal to the present value of the participant's vested accrued benefit under the Plan at the time of the termination of employment.

Distributions are payable in one of the following forms, at the participant's direction:

- Qualified Joint and Survivor Annuity
- Lum sum payouts
- Single life annuity
- Joint and survivor annuity 50%, 75% or 100%

Death and Disability Benefits

If a vested participant dies before his or her annuity start date or after the age of 65 but before his or her annuity starting date, the participant's beneficiary is entitled to the participant's hypothetical cash balance account.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no approved but unpaid distribution requests as of December 31, 2024 or 2023.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer portion of contributions. As of December 31, 2024, there was no indication and no approval from the Company calling for termination of the Plan. Effective May 31, 2025, the Plan was terminated and all amounts will be distributed to participants in 2025. Upon making the decision, all participants became immediately 100% vested in their portion of employer contributions.

Investment Options

The Plan's assets are invested in accordance with the investment policies of the Plan. The Plan currently invests in various mutual funds.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Fees related to the administration of the Plan are allocated to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan were \$15,731 and \$12,927, for the years ended December 31, 2024 and 2023, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE C – ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to retired or terminated employees or their beneficiaries, beneficiaries of employees who have died, and the present employees or their beneficiaries.

Benefits payable under all circumstances (retirement, death, disability and termination of employment) are included to the extent they are deemed attributable to employee service rendered prior to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, withdrawal, retirement or disability) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations were as follows:

- Investment return on plan assets at an effective rate of 5.31% and 5.20% as of January 1, 2024 and 2023, respectively.
- Discount rates of 5.50% and 4.75% for plan years 2024 and 2023, respectively.
- Normal retirement age of 65.
- Life expectancy of participants based on the Society of Actuaries PRI-2012 mortality table for males and females for employees and annuitants projected generationally with Scales MP-2021 male and female rates for plan years 2024 and 2023.

The net change in the actuarial present value of accumulated benefits at January 1, 2024 and 2023, is the result of benefits accumulated, discounts for interest, changes in participant mix, actuarial experience gains and losses, and changes in actuarial assumptions.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors would be applicable in determining the actuarial present value of accumulated plan benefits. The Company's decision to terminate the plan in 2025 (see Note A) did not impact the 2024 or 2023 actuarial assumptions as this decision was not known and participants were not effected during 2024 or 2023.

NOTE D – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds and money market funds are stated at fair value as defined by observable quoted prices in active markets (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – RISKS AND UNCERTAINTIES

The Plan provides various investments. The underlying investment securities are exposed to various risks, such as interest rates, market and credit risks. Due to the level of risks associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants’ individual account balances.

NOTE F – TAX STATUS

The Plan adopted a form of a prototype plan sponsored by JH Benefits LTD. The prototype plan received an opinion letter dated November 16, 2018 from the IRS, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) of the Plan if the Plan has taken an uncertain tax position that are more likely than not would not be sustained upon examination by the IRS. The Plan has taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G – PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

NOTE H – SUBSEQUENT EVENTS

In connection with the preparation of the Plan’s financial statements as of and for the year ended December 31, 2024, events and transactions subsequent to December 31, 2024 through October 15, 2025 have been evaluated by the plan administrator for possible adjustment and/or disclosure. Except as disclosed in Note A, no other events requiring financial statement adjustment and/or disclosure have been identified.
