Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Southern Eagle Sales & Service, L.P. Local 270 Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - in liquidation as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits - in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis

As discussed in Note 7 to the financial statements, management of Southern Eagle Sales and Service, L.P., the Plan's Sponsor, amended the Plan effective March 28, 2022 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting used in presenting both the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of reportable transactions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following brief description of the Southern Eagle Sales & Service, L.P. Local 270 Pension Plan (the Plan) is intended to give a general summary of its principal provisions. Participants should refer to the Plan Document for complete information.

Except as otherwise indicated, the following descriptions of the Plan's terms and operations relate to the period prior to the plan termination process.

Purpose of the Plan

The Plan, which was established effective April 1, 1977, is a defined-benefit plan which provides normal retirement, early retirement, disability, or death benefits to substantially all employees covered by the collective bargaining agreement between the Teamsters Local No. 270 of New Orleans, Louisiana and Southern Eagle Sales & Service, L.P. (the Company).

Plan Administration

The Plan Administrator is the Company. The Company appoints an officer as the Plan Trustee, as required, to administer the Plan. The Plan Trustee is responsible for benefit payments from the trust fund, according to information submitted by the Plan Administrator, and oversight of the administration of the Plan. The Plan Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Pension Benefits

Under the Plan's provisions, each participant who retires at age 65 (normal retirement) is entitled to a unit of monthly pension equal to \$17.50 multiplied by the period of credited service in years and completed fractions, thereof, up to a maximum of 30 years. A year of credited service is earned for each calendar year during which an individual completes 1,800 hours of service. During each calendar year in which the individual has less than 1,800 hours of service, the individual earns 1/12 of a year for every 150 hours of service (with any remaining hours equal to 75 or more counting as 1/12 of a year).

Vesting service is used in determining eligibility for early retirement and disability benefits. A year of vesting service is earned for each calendar year during which an individual completes at least 1,000 hours of service. Plan participants become fully vested after five years of vesting service.

Death and Disability Benefits

If an active employee dies, is married, and is eligible for early retirement, then the surviving spouse will receive a benefit equal to the value of the employee's accumulated pension benefit as if the employee retired on the day immediately preceding death and had made a timely election to receive benefits in accordance with the 50% contingent annuitant option designating the spouse as the contingent annuitant.

Note 1. Description of the Plan (Continued)

Death and Disability Benefits (Continued)

If an active employee dies, is married, but not eligible for early retirement, then the surviving spouse will receive a benefit equal to the value of the employee's accumulated pension benefit as if the employee was terminated on the day immediately preceding death, subject to the earliest date on which the employee could have commenced receiving benefits or any date after but before the employee's normal retirement date, chosen by the surviving spouse, and had made a timely election to receive benefits in accordance with the 50% contingent annuitant option designating the spouse as the contingent annuitant.

Active employees who become totally disabled receive annual disability benefits that are equal to the equivalent normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age, at which time disabled participants will receive the normal retirement benefit computed as though they had been employed to normal retirement age, with their annual compensation remaining the same as at the time they became disabled.

Funding Policy

Annually, an independent actuary performs a valuation of the Plan to determine the status of the fund and the normal cost and contribution limits prescribed by the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's funding policy is for the Company to contribute an amount that will meet or exceed the annual ERISA minimum funding requirement. The method of valuation employed by the actuary is the unit credit accrued liability method as mandated under the Pension Protection Act of 2006. For the years ended December 31, 2024 and 2023, the independent actuary calculated employer contribution requirements of \$1,042,214 and \$-0-, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan during 2022, management determined that liquidation of the Plan is imminent. As a result, the financial statements for both 2024 and 2023 have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of plan assets available for benefits and the actuarial present value of accumulated plan benefits as the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

Valuation of Investments

There were no investments remaining in the Plan as of December 31, 2024.

All investments in the 2023 statement of net assets available for benefits – in liquidation are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Under the trust agreement, the Company may pay all expenses incurred in the administration of the Plan, including trustee fees, but is not obligated to do so. Administrative expenses were paid by the Plan and the Company for the years ended December 31, 2024 and 2023. Certain administrative expenses incurred in connection with general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits - in liquidation. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits - in liquidation.

Note 3. Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits was \$3,122,823 as of December 31, 2023. All plan benefits were fully vested. This amount was determined as of the end of the plan year and based on the assumptions that the Plan was terminating and liquidation was determined to be imminent. Previously, the actuarial present value of accumulated plan benefits was determined as of the beginning of the plan year using going concern assumptions. Due to the plan termination, and determination that liquidation was imminent, the valuation date and assumptions were changed.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 6. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by Lincoln. Lincoln is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Note 7. Plan Termination

The Company made contributions to the Plan in accordance with the minimum funding requirements established by the Internal Revenue Service (IRS) that would ensure that plan assets were sufficient to pay Plan participants' accrued benefits. In March 2022, the Company's management adopted an amendment to terminate the Plan effective as of a date determined by the Plan Administrator. As a result, management determined that liquidation was imminent.

In October 2022, a Notice of Intent to Terminate Plan advising that an application was to be filed was distributed to Plan participants and subsequently, the application for approval of the Plan's termination was filed with the IRS. In addition, in October 2023, a Notice of Plan Benefits was distributed to plan participants, and in June 2023, a Standard Termination Notice was filed with the Pension Benefit Guaranty Corporation (PBGC). The Notice of Plan Benefits is a statement of a participant's accrued benefit under the Plan, including an estimate of the amount of a single cash payment to which the participant would be entitled following the receipt of plan termination approval. As a result of the resolution to terminate the Plan, each employee with an accrued benefit under the Plan had the following choices to have the present value of their accrued benefit: (a) used to purchase an annuity under the Contract or (b) distributed in a single cash payment either (i) directly to them, or (ii) as a direct rollover by the Plan's trustee into the participant's rollover Individual Retirement Account (IRA).

Each employee with an accrued benefit under the Plan whose present value was \$5,000 or more had the option to have the present value of their accrued benefit used to purchase an annuity under a single premium paid-up group annuity contract (the Contract) or distributed in a single cash payment directly to them. Each former employee with an accrued benefit under the Plan whose present value was over \$1,000 but less than \$5,000 had the option to have the present value of their accrued benefit distributed in a single cash payment either (i) directly to them, or (ii) as a direct rollover by the Plan's trustee into the participant's rollover IRA. If the present value was \$1,000 or less, it was distributed automatically in a single cash payment directly to the employee or former employee.

There were no benefit payments made in conjunction with the plan termination during the year ended December 31, 2023.

Total single cash payments made in conjunction with the Plan termination during the year ended December 31, 2024 were \$2,705,003. These amounts are included in benefit payments in the statement of changes in net assets available for benefits - in liquidation..

Note 7. Plan Termination (Continued)

In February 2024, the Contract was purchased from plan assets by United of Omaha Life Insurance Company (United) for \$1,082,183

Retirees and beneficiaries receiving pension benefits when the Contract was purchased now have such benefits paid by United under the Contract. Benefit payments by United began as of May 1, 2024. The Contract provides that United has the obligation to pay all benefits under the Contract without the change and in accordance with the elections that were made at the time benefit payments began.

Note 8. Tax Status

The Plan obtained its latest determination letter on March 31, 2010, in which the IRS states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various pooled separate account investments. Underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits - in liquidation.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
