REPORT OF INDEPENDENT AUDITORS

To the Retirement Plan Administrative Committee of
The American National Bank of Texas Employee Stock Ownership Plan

Opinion

We have audited the financial statements of The American National Bank of Texas Employee Stock Ownership Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

A. Description of the Plan

General

The following brief description of The American National Bank of Texas Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by American National Bank of Texas (the “Company”), a wholly owned subsidiary of The ANB Corporation (the “Corporation”). Participants should refer to the Plan document for more complete information. The Company’s corporate offices are located in Terrell, Texas.

Prior to 2016, the assets were part of The American National Bank of Texas ESOP and 401(k) Profit Sharing Plan. Effective January 1, 2016, the Company created two separate plans, The American National Bank of Texas Employee Stock Ownership Plan and The American National Bank of Texas 401(k) Profit Sharing Plan. The Plan was restated effective January 1, 2022, and is a defined contribution plan eligible to all employees of the Company who have completed 1,000 hours of service to the Company by the last day of the Plan year, except for union employees, leased employees, or non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to permit eligible Employees to obtain a beneficial interest in the stock of the Corporation and to provide deferred compensation benefits to participants and beneficiaries.

Contributions

The Company makes discretionary contributions to the Plan which are determined by the Board of Directors. Participants must be: (1) employed on the last day of the year, and complete 1,000 hours of service during the year; or (2) have died, retired, or suffered disability during such year to be eligible to receive discretionary matching contributions. The Company elected to make discretionary contributions to the Plan of \$220,629 and \$971,584 for the years ended December 31, 2024 and 2023, respectively. Contributions were not funded until the subsequent year; therefore, they were recorded as employer receivables as of December 31, 2024 and 2023.

Voting Rights

Each participant is entitled to instruct The American National Bank of Texas Trust Department (the “Trustee”) in the manner of voting the number of shares of common stock which have not been allocated to the participant’s ESOP account. If voting instructions are not timely received by the Trustee, the Trustee shall vote, to the extent consistent with ERISA, in the same manner as the shares for which the Trustee does receive instructions from participants.

Each participant's account is credited with the allocations of: (a) the Company's contribution; (b) Plan earnings; and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Vesting in Company contributions, plus actual earnings thereon is as follows:

In the event of disability or death, the participant will become fully vested.

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of rollovers or lump sum payments. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited.

Forfeitures

Forfeited non-vested accounts may be used to restore forfeitures, reallocated to participants, or reduce Company contributions. As of December 31, 2024 and 2023, such forfeited non-vested amounts totaled \$30,739 and \$27,263, respectively. For the years ended December 31, 2024 and 2023, there were \$173,207 and \$281,944, respectively, of forfeitures which were reallocated to participant accounts and no forfeitures were used to offset employer contributions or restore forfeitures.

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. Substantially all administrative expenses are paid by the Plan. Expenses paid by the Company, if any, are excluded from the accompanying financial statements.

A. Description of the Plan – continued

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations must include a put option. The put option is a right to demand that the Corporation buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Corporation can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Corporation common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account and effective January 1, 2021, must make the election during the annual election period beginning on the first day after close of each Plan year and ending 90 days after the date that the December 31 value of the Company stock is provided to participants. Diversification is offered to each eligible participant over a six-year period.

In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

C. Fair Value Measurements – continued

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan’s investments are as follows:

- Interest-bearing cash is valued based on the underlying cash component as of the measurement date and classified within Level 1 of the valuation hierarchy.
- The ANB Corporation common stock was valued by an independent third party as the stock is not traded on a securities exchange. The valuation is based on a multiple of current earnings less an appropriate discount. The multiple chosen is consistent with multiples of similar companies based on current market price and is considered to be Level 3 of the valuation hierarchy.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels.

For the year ended December 31, 2024, there were purchases of 146 shares of the Company's common stock for \$275,428 and sales of 540 shares of the Company's common stock for \$1,015,200. For the year ended December 31, 2023, there were purchases of 60 shares of the Company's common stock for \$133,800 and sales of 480 shares of the Company's common stock for \$1,030,561.

D. Line of Credit

The Plan has a line of credit agreement with The Independent Bankers Bank with a credit limit of \$2,000,000. There was no outstanding balance at December 31, 2024 and 2023. The line of credit was to mature on April 20, 2025, and was renewed to extend the maturity to April 20, 2026, as discussed in Note I. The line of credit is secured by 250,000 shares of The American National Bank of Texas common stock owned by the Corporation and has an interest rate equal to the U.S. Prime Rate applicable to such interest period, which at December 31, 2024 and 2023, was 8.50% and 7.50%, respectively. The line of credit was fully repaid in January 2023.

E. Tax Status

The Plan obtained its determination letter as of September 12, 2018, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("Code"). The Plan has been amended since receiving the determination letter.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

F. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant's accounts will become 100% vested.

G. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Investments in shares of the Corporation's common stock and interest-bearing cash held at the Company qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investments activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

H. Risks and Uncertainties

The Plan invests in the common stock of the Corporation, which is not traded on a securities exchange. The common stock is exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with the common stock, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. Subsequent Events

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available for issuance.

On April 20, 2025, the line of credit was renewed to extend maturity to April 20, 2026.
