Years ended December 31, 2024 and 2023

**1. Description of Plan**

The following description of the Sound Community Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established effective January 1, 2002. The Plan is a defined contribution Plan established to provide retirement benefits for employees of Sound Community Services, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

All employees who have reached the age of 21 are eligible to make salary reduction contributions.

**Contributions**

Plan participants may contribute between 1% and 100% of compensation, as defined in the Plan, subject to the limitations of the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participants' Accounts**

Each participant's account is credited with the participant's salary deferral contributions and allocations of Plan earnings. There may also be administrative expenses charged, some of which may be based on the participant's transactions, as defined by the Plan. Allocations of investment income are based on participant earnings (net of investment expenses), account balances, or specific participant directed transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Vesting**

Participants are immediately 100% vested in any salary deferral and rollover contributions made to their accounts plus actual earnings thereon.

Notes to the Financial Statements

**1. Description of Plan (continued)**

**Investment Options**

A participant may direct contributions to any of the investment options offered by the Plan, as selected by the Plan Administrator in accordance with the Plan's investment policy, with various levels of risk tolerance. Participants may transfer their investments and modify the direction of future contributions among the various options.

**Retirement, Death and Disability**

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

**Participant Withdrawals**

Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Distributions will be paid in a lump sum or in installments over a number of years, based upon election of the participant or as defined in the Plan. If for any reason his or her vested account balance does not exceed \$1,000, the Plan Administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance is between \$1,000 and \$5,000, the Plan Administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take in-service withdrawals from the Plan upon attainment of age 59 ½.

**Notes Receivable from Participants**

Loans from the Plan are available to participants and are collateralized by a participant's account balance, with repayments made through weekly payroll deductions. Loans must be approved by the Plan Administrator, and a participant may have only one loan outstanding at any time. Loans are issued for not less than \$1,000 and are limited to a maximum of the lesser of 50% of a participant's account balance or \$50,000. Interest on loans is charged based on the prime rate at the beginning of the calendar year plus 1%. Loans outstanding at December 31, 2024 bear interest at a rate ranging from 5.0% to 9.50% with maturities expiring through 2028. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

**Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, Plan participants will become 100% vested in their entire account balances.

**1. Description of Plan (continued)**

**Administrative Expenses**

The Plan Sponsor pays certain Plan expenses, including legal, audit and certain investment advisory fees. Expenses of the Plan, to the extent they are not paid by the Plan Sponsor, may be paid out of the assets of the Plan provided that such payment is consistent with ERISA. Such expenses include, but are not limited to, fees incurred in connection with the payment of benefits, investment fees and certain professional and administrative fees. Expenses that relate solely to a specific participant may be assessed against such participant's individual account balance.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, as further discussed in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefits are recorded when paid by the Plan.

**2. Summary of Significant Accounting Policies (continued)**

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Risks and Uncertainties**

The Plan holds various investment options in mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**3. Unaudited Information - Certified by the Trustee**

Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated interest and dividends, net appreciation / depreciation in fair value of investments and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the Trustee, as of and for the years ended December 31, 2024 and 2023. This information has not been audited by independent accountants.

**4. Fair Value Investments**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

**4. Fair Value Investments (continued)**

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following represents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Interest Accumulation Account**

The Plan offers an interest accumulation account with Mutual of America Life Insurance Company, which is comparable to a cash equivalent and therefore is excluded from the fair value leveling table. The Interest Accumulation Account is completely liquid. There are no front-end or back-end charges; the interest rate credited to investments is a current rate, and is not dependent upon the length of time the assets are invested; requests for withdrawal can be made at any time and are processed on the day they are received and not depended upon the Agency having to liquidate securities to generate payment; and the value of the Account is the redeemable value, which equates fair value and includes no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request. The value of the Interest Accumulation Account was \$74,118 and \$319,897 at December 31, 2024 and 2023, respectively.

The crediting interest rate for the Interest Accumulation Account, as determined periodically by the issuer, results in an effective annual yield of not less than 0.15% but not greater than 3.00% for the years ended December 31, 2024 and 2023.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, no further contributions could be made.

**7. Income Tax Status**

The Internal Revenue Service issued an opinion letter dated March 22, 2019, indicating that the volume submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Related Party and Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds certain investments in cash equivalents, interest accumulation accounts and mutual funds maintained by Mutual of America Life Insurance Company, trustee and recordkeeper. These transactions and the Plan's payment of fees to those noted above, qualify as party-interest transactions. Notes receivable from participants and interest also reflect party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**9. Subsequent Events**

Plan management has evaluated events and transactions for potential recognition or disclosure between December 31, 2024, and October 14, 2025, which is the date the financial statements were available to be issued.
