Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PPC Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the PPC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

The following description of the PPC Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by PPC Partners, Inc. (the Company or Employer) and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan covers all nonunion employees of the Company's subsidiaries, including CarolinaPower, Inc., MetroPower, Inc., MP Systems, Inc., and Pieper Electric, Inc. All nonunion employees who have completed at least 30 days of service with the Company, as defined in the plan document and are age 18 or older are eligible to participate. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of the available investment options.

Contributions

Each year participants may contribute up to 100% of pre-tax annual compensation, subject to the limits imposed by the Internal Revenue Code (Code) of \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of \$7,500 during 2024 and 2023, in accordance with the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Beginning in 2023, new plan participants are auto enrolled at a deferral rate of 6% unless elected otherwise under a qualified automatic contribution arrangement. Previously, participants were enrolled under an automatic contribution arrangement. Participants who are auto enrolled will have their deferral rate increased automatically by 1% each yearly date to a maximum rate of 10%.

In 2023, the Company amended the plan to adopt the qualified automatic contribution arrangement (QACA) safe harbor match. These contributions are calculated as 100% of the participant contribution that is not over 2% of compensation, plus 50% of participant contributions that are over 2%, but not over 6% of compensation.

The Company may also make discretionary profit sharing contributions. The Company did not make any discretionary profit sharing contributions during the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's matching and discretionary contributions and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides that each participant directs the investment of his or her account in any combination into a number of investment funds. The Plan currently offers various registered investment companies, common or collective trusts, and pooled separate accounts as investment options for participants.

Vesting

Participants are immediately vested in their salary reduction and rollover contributions plus earnings (losses) thereon. Participants who leave the Plan because of death, early or normal retirement or disability retirement, as defined in the Plan are considered 100% vested. All Company contributions and related earnings are considered

100% vested in accordance with provisions of the Plan. Company safe harbor matching contributions and related earnings and Company profit sharing contributions and related earnings thereon vested in accordance with provisions of the Plan as follows:

In 2023, the Company adopted different vesting schedules for discretionary contributions and QACA safe harbor match contributions. QACA safe harbor matching contributions and earnings thereon are 100% vested after one year of service in accordance with provisions of the Plan.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan document. The Plan provides for normal retirement at age 65 or their age on the date five years after their earliest entry date. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment, installments or an annuity. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan document. Additionally, participants aged 59 ½ may withdraw any part of their eligible vested account balance of elective deferral contributions, matching contributions, discretionary contributions, and rollover contributions.

Forfeitures

Any forfeitures due to nonvested Company contributions are maintained as investments in the Plan and may be used to pay administrative expenses or to offset future Company contributions at the Company's direction. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$7,853, respectively. In 2024 and 2023, the Company's contributions were reduced by \$184,510 and \$120,355, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Registered investment companies are valued at the closing price reported on the active market on which the individual securities are traded. Pooled separate accounts are valued at estimated fair value. The fair value of the common or collective trust guaranteed investment contracts is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The common or collective trust and guaranteed interest account consist of guaranteed investment contracts that are not considered fully benefit-responsive investment contracts. See Note 3 for additional fair value measurement disclosure.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses incurred by the Plan are paid by the Company.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; and other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The common or collective trust investment consists of the Principal Stable Value Fund which is valued at fair value based on the net asset value (NAV) information reported by Principal Life Insurance Company based on the market value of its underlying investments which contain synthetic investment contracts. The common or collective trust can be redeemed at NAV as of the measurement date on a daily basis.

The guaranteed investment contract is available under a group annuity contract issued by Principal Life Insurance Company. The investment option provides for a guarantee of principal and interest. Contributions and transfers allocated to this investment option will be credited interest at a guaranteed interest rate Principal Life Insurance Company declares for a set period of time. Guaranteed interest rates for new allocations are subject to change daily and each amount allocated to the guaranteed interest account will earn interest based on this guaranteed interest rate in effect for the date that the amount is allocated to this guaranteed interest account. The guaranteed investment contract is deemed to be non-fully benefit responsive and is also recorded at fair value, determined by the custodian, using the contract's market value adjustment provisions for early terminations of such contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the trustee; has certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate as of December 31, 2024. Additionally, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the trustee; Principal Life Insurance Company; and Principal Global Investors Trust Company have certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate as of December 31, 2023:

- Cash and investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- The information included in the supplemental schedules of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of registered investment companies or units of common or collective trusts managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain investment management fees are included in the net appreciation in fair value of investments. Fees paid by the Plan for legal, accounting and other professional services were rendered primarily by parties-in-interest. Administrative expenses paid by the Plan during 2024 and 2023, totaled \$224,023 and \$187,142, respectively. The Employer provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any termination of the Plan or upon complete or partial discontinuance of contributions, the accounts of each participant would become fully vested.

Note 7. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$24,154 were not remitted within the required time period for the year ended December 31, 2024. These were corrected in the year in which the late remittance occurred.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit sharing plan sponsored by Principal Life Insurance Company. This plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the prototype constitutes a qualified plan under Section 401 of the Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Subsequent Events

Effective January 1, 2025, the PPC Retirement Plan transferred their assets from Principal to Charles Schwab. In preparation for the transfer, a portion of the assets were liquidated and held in cash at December 31, 2024. On January 1, 2025, approximately \$93,304,086 consisting of in-kind transfers and cash were received by Charles Schwab. By February 25, 2025, the remaining \$411,596 was distributed to participants or transferred to Charles Schwab.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
