Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of Rock-It Cargo 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a single-employer defined contribution 401(k) plan covering eligible employees of Rock-It Cargo USA LLC (the "Company" or "Plan Sponsor") except for employees covered by certain collective bargaining agreements, nonresident aliens, Puerto Rican employees, and leased employees. Effective January 1, 2024, all former employees of two acquired employers, CARS USA Shipping, LLC ("CARS") and Dell Will Customs Brokers USA ("Dell Will"), are currently not eligible to participate in the Plan. All employees who have met the age and service requirements are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was formed in September 2018. The Plan Sponsor's employees who were either participants or eligible to participate in the Plan Sponsor's former Plan, the Rock Solid 401(k) Plan, are eligible to participate in the Plan. Participants in the Rock Solid 401(k) Plan were permitted to rollover their account balances, including their notes receivable from participants to the Plan.

Contributions - Participants may contribute up to 90% of their eligible compensation as pre-tax or Roth contributions, as defined by the Plan Document, up to the maximum allowable by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan Document. Unless elected otherwise, each eligible employee will be automatically enrolled in the Plan with an initial pre-tax deferral of 6% of eligible compensation.

For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 50% of a participant's elective deferral, not to exceed 6% of compensation for each payroll period. For the year ended December 31, 2024, the Company contributed \$818,506 of discretionary employer matching contributions.

Profit sharing nonelective contributions may be contributed at the option of the Company. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. Employees must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year to be eligible for profit sharing nonelective contributions. There were no profit sharing nonelective contributions made for the year ended December 31, 2024.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contributions, the Company's matching contributions, and earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) **Description of plan (continued)**

Vesting - Participants are immediately vested in their contributions, qualified nonelective contributions ("QNEC"), and actual earnings thereon. Employees who have reached their early retirement age are 100% vested in matching contributions. All other employees are subject to the following vesting schedule for employer matching contributions:

Notes receivable from participants - In accordance with the Plan, notes receivable from participants are not permitted; however, notes receivable from participants in the Rock Solid 401(k) Plan were permitted to be grandfathered into the Plan. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024 and 2023, the Plan has one outstanding note receivable, which matures in 2035.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or his or her beneficiary(ies) may elect to receive either a lump-sum amount or an annuity equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in installments or as a lump-sum distribution.

Forfeited accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts were \$2,424 and \$19,427, respectively. Forfeited accounts may be used to pay Plan expenses and to reduce employer contributions in accordance with the Plan Document. For the year ended December 31, 2024, administrative expenses were paid from forfeited nonvested accounts in the amount of \$39. Additionally, forfeited nonvested accounts reduced employer contributions in the amount of \$60,406 during the year ended December 31, 2024.

(2) **Summary of significant accounting policies**

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition (continued) - Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

(3) Information prepared and certified by the trustee and insurance company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company ("ETC"), the trustee of the Plan, and Empower Annuity Insurance Company ("EAIC"), the provider and certifier of the guaranteed investment contract (See Note 5).

(4) Fair value measurements

Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(4) Fair value measurements (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All of the Plan's investments at fair value as of December 31, 2024 and 2023, were Level 1 investments within the fair value hierarchy.

(5) Investment contract with insurance company

The Plan has a fully benefit-responsive guaranteed investment contract with EAIC. EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTES TO FINANCIAL STATEMENTS

(5) Investment contract with insurance company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan Document (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable to occur that might limit the ability of the Plan to transact at contract value with the contract issuers or the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of a material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

(6) Related-party transactions and party-in-interest transactions

Certain Plan investments are managed by ETC and EAIC, the trustee and provider of the insurance investment contract, respectively. Fees paid to the Plan's recordkeeper for the year ended December 31, 2024, were \$63,446. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(7) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions (if any).

(8) Tax status

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed trustees of such in a letter dated September 16, 2022. The plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize the tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Delinquent participant contributions

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2023, untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$79,897. In March 2024, the Company corrected and funded the lost earnings related to the untimely employee contributions.

(11) Correction of operational failures

During 2024 and 2023, the Plan Sponsor detected certain operational errors related to contributions for 2024 and 2023, respectively. The Plan Sponsor is currently evaluating the corrective contributions for the 2024 and 2023 Plan years, to ensure contributions are consistent with Plan terms and IRS rules. As of the date of these financial statements, this evaluation is ongoing and the contribution amounts reported in the financial statements do not include such corrections. The required corrective contributions will be made in accordance with the Plan provisions and regulatory guidance.

(12) Subsequent events

Effective January 1, 2025, the Plan name was changed to GCL 401(k) Plan.

In January 2025, the Plan changed the trustee and custodian from ETC to Principal Trust Company. The transfer of the Plan's assets occurred on January 7, 2025.

On January 14, 2025, the CARS 401(k) Plan was merged into the GCL 401(k) Plan resulting in approximately \$730,000 of assets transferred into the Plan.

On February 3, 2025, the SOS Global Express, Inc. 401(k) Plan was merged into the GCL 401(k) Plan resulting in approximately \$10,800,000 of assets transferred into the Plan.

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.
