## 1. Description of the Plan

The following description of the Subaru of America, Inc. Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

Subaru of America, Inc. (the Company) previously established the Subaru of America, Inc. Health Benefit Plan, the Subaru of America, Inc. Life and Accident Plan, the Subaru of America, Inc. Disability Income Plan, the Subaru of America, Inc. Medical Care Reimbursement Plan, the Subaru of America, Inc. Dependent Care Reimbursement Plan (the Prior Plans) and the Subaru Employee Welfare Benefit Trust (the Trust) to provide various welfare benefits for eligible employees and former employees of the Company and its participating affiliates.

Effective January 1, 2006, the Company merged all Prior Plans into the newly established Plan so that such combined plans form one welfare benefit plan for purposes of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The conditions of the Trust have remained the same, since it was last amended December 18, 2013. The Plan and the Trust are intended to constitute a plan and trust under Section 125 of the Internal Revenue Code (IRC), as amended, and are meant to comply with the applicable provisions of the IRC and with the applicable provisions of ERISA.

If the Plan and Trust are terminated, all contributions shall cease as of the date of termination. Assets remaining in the Trust after termination will be used for the payment of (1) benefits to employees with respect to claims arising prior to such termination, (2) reasonable and necessary expenses incurred in such termination and (3) taxes, until all assets of the Trust are liquidated.

### Defined Benefit Welfare Benefits

The Plan provides health benefits to participants to provide for hospitalization, major medical, prescription drugs, vision and dental benefits. Disability benefits provide for short-term and long-term disability replacement income. Life and accident benefits provide for death benefits. All full-time and certain part-time employees, retirees and dependents, as defined in the plan document, are eligible to participate in the Plan. Participation in the Plan by eligible employees is voluntary. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Company contributions to the Plan are determined actuarially on the basis of plan benefits provided and the age, sex and number of employees and dependents of employees who participate in the Plan. Participants may elect to make pre-tax or after-tax contributions depending on their benefit.

Retirees may make contributions to the Plan for postretirement health care coverage.

The claims for self-insured benefits, which include hospitalization, major medical, prescription drugs and dental, are processed by the Plan's third-party providers under administrative service agreements. The third-party providers pay the claims direct to or on behalf of the participants and then are reimbursed by the Trust. Despite the Plan's utilization of third-party providers and processors, the ultimate responsibility for payment to the participants is retained by the Plan.

The cost of the postretirement benefits provided under the Plan is shared by the Company and the Plan's retirees. Retirees' contributions are based on the participant's age at retirement, date of retirement and years of credited service. A retiree who was hired prior to January 1, 2006, but terminates employment after January 31, 2006, is required to pay 30%, 40% and 55% of the estimated cost of premiums under the Plan if the retiree's age plus years of credited service is greater than 75 years, between 70 and 74 years, or between 65 and 69 years, respectively.

A retiree hired after January 1, 2006 is required to pay 35%, 45% and 60% of the estimated cost of premiums under the Plan if the retiree's age plus years of credited service is greater than 75 years, between 70 and 74 years, or between 65 and 69 years, respectively. In addition, retirees hired prior to January 1, 2006 are required to pay 55% of the estimated cost of premiums for spouses and eligible dependents. Retirees hired after January 1, 2006 are required to pay 60% of the estimated cost of premiums for spouses and eligible dependents. Premiums paid by the Plan or Trust are recorded in the Statements of Changes in Net Assets Available for Benefits.

### Stop Loss Coverage

The Plan has entered into an experienced-rated stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount).

Premiums for stop-loss insurance and other fully insured benefits are paid by the Trust and are recorded as group insurance premiums in the accompanying Statement of Changes in Net Assets Available for Benefits. Premium surpluses are recorded as a receivable from the insurance carrier. There were no receivables related to surpluses at December 31, 2024 and 2023. There were \$4,371,137 in stop loss payments received by the Plan, which are recorded as an offset to claims paid in the accompanying statement of changes in net assets available for benefits.

### Flexible Spending Arrangement

Participants may elect to make pretax contributions to the Plan for eligible medical care and dependent care reimbursement benefits through a flexible spending account (FSA). Claims are paid from the FSA account when submitted to the Plan for reimbursement. Under the provisions of the Plan, participants have until March 31 of the year following the period of coverage to file claims for reimbursement of expenses incurred during such period. Amounts contributed to the FSA account by participants in excess of claims submitted through March 31 of the following plan year are forfeited by participants and used by the Company to reduce its contributions to the Plan. Reimbursements to participants from the FSA during the plan year ended December 31, 2024 totaled \$720,624.

### Medicare Subsidy

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 as described in Note 5.

## 2. Summary of Significant Accounting Policies Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; claims incurred but not reported; postretirement benefit obligations; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan obligations at December 31 for claims incurred by active participants but not reported (IBNR) at that date, for postretirement health and life insurance benefits and for future disability payments to members considered disabled at December 31 are estimated by the Company and the Plan's actuary. The postretirement benefit obligations are reported at present value.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by investment advisors. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

### Administrative Expenses

All administrative expenses associated with providing benefits to the participants of the Plan are paid by the Plan and are recorded as administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits. All trustee, audit and actuarial fees of the Plan are paid by the Company and are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

### Payment of Benefits

Premiums paid by either the Company or the trust are recorded as group insurance premiums in the accompanying Statement of Changes in Net Assets Available for Benefits. Claim payments are recorded when paid by the third-party claims processor.

The Plan's benefit obligation is in excess of the net assets available for benefits and the Plan's policy is to fund the Plan on any shortfalls in payment of benefits on an as-needed basis.

### Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The exchange-traded funds are valued at the closing price reported on the active market on which the individual securities are traded.

U.S. Treasury STRIPS (Separate Trading of Registered Interest and Principal of Securities) are United States bonds that are sold at a discount to their face value and pay full face value at their maturity. No interest payments are received by STRIPS holders. The coupons are sold as separate investments. STRIPS are not issued or sold directly to investors but can be purchased and held only through financial institutions and government securities brokers and dealers. STRIPS are valued using inputs derived from or corroborated by observable market data by correlation for similar assets in inactive markets.

The money market fund is valued at quoted net asset value of shares held by the Plan at year-end.

### 4. Postretirement Benefit Obligations

Under the provisions of the Plan, the Company provides certain postretirement health care benefits and life and accident benefits to substantially all employees who have at least ten years of service and are age 55 or greater. Additionally, the Company provides certain death benefits and pays stated percentages of medical expenses incurred by retirees and their spouses after subtracting payments by other providers, including Medicare and after the stated deductible has been met.

The amounts reported as the postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to participants' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligations represent the amounts to be funded by contributions from the Company, retiree contributions and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The obligation for COBRA benefits is based on the actual number of employees utilizing COBRA benefits as of the measurement date and claim payment history and includes an estimate for claims incurred by COBRA participants that have not been reported.

The actuarial present value of the expected postretirement benefit obligation is determined annually by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate the future annual incurred claims costs per participants and to adjust such estimates to reflect the time value of money (through discounts for interest) and probability of payment (by means of decrements, such as those for death, termination or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by Medicare, the retired participants and other providers.

The significant actuarial assumptions used in the valuation as of December 31, 2024 and 2023 were (a) life expectancy of participants (using the Pri-2012 base tables with white collar adjustment for employees and retirees with generational improvement using the Mercer MMP-2021 scale), (b) retirement age (it was assumed that all participants will retire between the ages of 55 and 65), (c) the portion of employees with spouses (it was assumed that 60% of active employees will have spouses at their retirement), (d) health care cost trend rates for medical benefits as of December 31, 2024, 6.24% was assumed for 2025, reducing to 4.00% in 2048; and for dental benefits as of December 31, 2024, 4.92% was assumed for 2025, reducing to 4.00% in 2048; medical benefits as of December 31, 2023, 6.74% was assumed for 2024, reducing to 4.00% in 2048; and for dental benefits as of December 31, 2023, 5.00% was assumed for 2024, reducing to 4.00% in 2048 and (e) a discount rate of 5.66% for 2024 and 5.01% for 2023.

The changes in the actuarial assumptions as disclosed and other actuarial gains and losses resulted in a decrease of the postretirement benefit obligation of \$2,693,852 for the year ended December 31, 2024.

### 5. Medicare Prescription Drug, Improvement and Modernization Act of 2003

In December 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the Act) was signed into law. The Act introduces a prescription drug benefit under Medicare Part D and also provides for a tax-free federal subsidy to sponsors of retiree health care benefit plans that provide an actuarially equivalent level of prescription drug benefits. Benefits under the Plan have been evaluated and found to be actuarially equivalent to the Medicare Part D.

The Plan is not directly entitled to the Medicare subsidy nor are the participant benefits affected by the subsidy as the subsidy is provided to the plan sponsor. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan's postretirement benefit obligation differs from the Company.

### 6. Benefit Obligations and Claims Incurred But Not Reported

The Plan's deficiencies in assets over benefit obligations at December 31, 2024 and 2023 relate primarily to the postretirement and postemployment benefit obligations and claims incurred but not reported, the funding of which is covered by future contributions from the Company, retirees and participants.

Claims incurred but not reported are estimated by the Plan's management using accepted factors based on claims data provided by the Plan's third party providers. The amounts are paid by the Plan only if claims are submitted and approved for payment.

The weighted average health care cost-trend assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation by \$14.9 and \$14.3 million as of December 31, 2024, and 2023, respectively.

### 7. Tax Status

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS) dated May 24, 1982, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC as a Voluntary Employee Beneficiary Association (VEBA) Trust. The Plan and Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes the related Trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risk and Uncertainties**

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

In addition, the Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$32,137,868 and \$30,254,753, respectively, that were concentrated in two funds.

### **9. Related-Party and Party in Interest Transactions**

The Plan holds a money market account managed by Wilmington Trust, the custodian of the Plan. The Plan receives contributions from the Company for welfare benefits and administrative expenses. A tax deduction by the Company for its contributions made to the Plan may be taken only to the extent that the contribution amount does not exceed the actual benefit costs for the plan year and amounts reasonably and actuarially necessary to fund claims incurred but unpaid (including administrative costs associated with such claims). As discussed in Note 2, the Plan pays expenses incurred under several arrangements with service providers. These transactions are party in interest transactions under ERISA.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **10. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for the purposes other than for exclusive benefit of the Plan's participants.
