We have performed audits of the financial statements of S.S. Steiner, Inc. Employees 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

**Note 1. Description of Plan**

The following is a brief description of the S.S. Steiner, Inc. Employees 401(k) Plan (the “Plan”) which provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan was established on July 1, 2009, for the benefit of the non-unionized employees of S.S. Steiner, Inc., and its affiliated companies (the “Company” or “Employer”). The affiliated companies include Hops Extract Corporation of America, Golden Gate Hop Ranches, Inc., and Stadelman Fruit, L.L.C. The Plan is a defined contribution plan subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). The Plan was amended and restated effective July 1, 2020.

***Eligibility***

An employee became eligible to participate in the Plan after completing one full year of service, which was defined as 1,000 hours, and attaining the age of eighteen. An eligible employee who had satisfied the eligibility requirements could become a participant in the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year.

Effective July 1, 2020, the Plan was amended to reduce the eligibility period for entry into the Plan from one full year of service to 60 days after their date of hire, and an eligible employee is permitted to enter the Plan upon satisfying eligibility requirements. Participants will be eligible to make employee contributions after 60 days, and participants will be eligible for employer contributions after one full year of service.

***Contributions***

Participants may elect to contribute pre-tax or Roth deferral contributions, up to the maximum amount permitted by the Internal Revenue Code. Participants may also make rollover contributions from other qualified plans.

The Company is required to make matching contributions equal to 100% of the participant’s pre-tax and Roth deferral contributions that do not to exceed 3% of their compensation and 50% of the participant’s pre-tax and Roth deferral contributions that exceed 3% of the compensation not to exceed 5%.

***Participant Loans***

Participants are permitted to borrow up to 50% of their vested account balance up to a maximum of \$50,000. The term of the loan cannot exceed five years except when the loan is used to acquire or construct a principal residence, which can be repaid over a longer period. Loans are repaid through payroll deductions and monitored by the plan administrator. The loans are collateralized by the balance in the participant’s account and bear interest at rates commensurate with the prevailing rate, as determined by the plan administrator. At December 31, 2024, interest rates on the outstanding loans range from 4.25% to 9.50%.

***Vesting***

Under the terms of the Plan, participants’ accounts are immediately vested in both the participant’s deferral contributions and the Employer matching contributions, and earnings thereon.

***Benefits Paid to Participants***

Upon normal retirement (65), death, disability or termination of service, vested benefits can be distributed in the form of a lump sum payment, as described by the plan document. Participants can also make in-service withdrawals upon early retirement age (59 ½).

***Participant Accounts***

A participant's deferral contributions and employer matching contributions may be invested by participants into one or more of the investment options available to the Plan (participant directed).

***Administrative Expenses***

Administrative expenses consist of investment fees and plan maintenance fees, which are paid by the Plan, while all other administrative expenses are paid by the Company.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Benefits Paid to Participants***

Benefit payments to participants are recorded upon distribution.

***Subsequent Events***

The Plan has evaluated subsequent events through October 15, 2025, the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024 (and the accompanying schedule of reportable transactions for the year ended December 31, 2023)

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds: Mutual funds are stated at fair value based on unadjusted quoted prices in an active market for each share held by the Plan.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate

***Investment Contract With Insurance Company***

The Plan is party to a group annuity contract with ELAC and GWLAC as of December 31, 2024 and 2023, respectively, whereby ELAC and GWLAC maintains certain of the Plan's contributions in a guaranteed income account. The guaranteed income account is credited with earnings on the underlying investments and charged for Plan withdrawals, and administrative expenses are charged ELAC and GWLAC. The contract is fully benefit-responsive and is reflected in the financial statements at contract value.

Certain events could limit the ability of the Plan to execute transactions at contract value with GWLAC. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsors or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The group annuity contract does not permit ELAC and GWLAC to terminate the agreement prior to the scheduled maturity date.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Note 6. Tax Status**

On November 14, 2022, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress for any tax periods.

**Note 7. Risks and Uncertainties**

The Plan's investments are concentrated in a guaranteed interest account and mutual funds that invest in marketable equity, debt, and fixed income securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain equity, debt, and fixed income securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**Note 8. Party-in-Interest Transactions**

Certain investments were shares of funds managed by ETC, a custodian of the plan, as of and for the year ended December 31, 2024, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to ETC for recordkeeping services for the year ended December 31, 2024, amounted to \$27,529. Fees paid to an investment advisor amounted to \$37,620 for the year ended December 31, 2024.
