## INDEPENDENT AUDITOR'S REPORT

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1—DESCRIPTION OF PLAN

The following description of the Woltz & Wind Ford, Inc. and Washington Ford, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan became effective on January 1, 1996. It is a defined contribution plan covering all regular full-time employees of Woltz & Wind Ford, Inc. and Washington Ford, Inc. (the “Company”) who have completed one year of service and are age 21 or older. A year of service is defined as twelve consecutive months during which an employee is credited with 1,000 hours of service. A one-year “break” occurs in any year during which the employee fails to complete more than 500 hours.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligible individuals are permitted to enter the Plan on January 1st or July 1st of the plan year coincident with or next following the date on which he/she attains age 21 and completes one year of service. However, each employee of Washington Ford, Inc. who has completed one year of service and has attained age 21 as of December 15, 1997, shall commence participation in the Plan for purposes of Company contributions effective December 15, 1997, and with respect to elective contributions effective January 1, 1998.

**Contributions** – Participants may elect to contribute up to a maximum of 100% of his or her compensation subject to IRS dollar limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. A deferral election may not be made retroactively, and a participant’s election to commence elective deferrals shall remain in effect until modified or terminated. A participant may elect to change the percentage of his or her deferral as of the first of every quarter.

The Company’s Board of Directors determines the amount of any discretionary employer contributions. Woltz & Wind Ford, Inc. and Washington Ford, Inc. separately determine the amount of contributions that shall be allocated to their respective employees. The employer discretionary contribution for the Plan year made for an allocation group will be allocated to each eligible participant who is a member of that group in the ratio that the compensation of each eligible participant who is a member of that allocation group bears to the total compensation of all eligible participants who are members of that group. The allocation groups are: Group 1 – Non-Select Woltz & Wind Ford, Inc. Employees; Group 2 – Non-Select Washington Ford, Inc. Employees; Group 3 – Owners. For 2024 and 2023, a contribution of 1.5% of salary was made subject to the maximum salary allowed by the IRS for Groups 1 and 2. Group 3 allocation was made at 4.5% times the allowable salary, which was \$15,525 and \$14,850 for 2024 and 2023, respectively.

**Participant Accounts** – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings (losses) and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, with at least 1,000 hours of service required to be credited for a year of service. Company matching and discretionary contributions vest over a six-year vesting schedule based on years of service, as follows:

During 2008, one of the Plan's sponsors obtained the franchise rights to McCrackin Ford. Any employees hired at this time from McCrackin Ford were given credit for their years of service at McCrackin Ford.

**Payment of Benefits** – Upon termination of service, participants are eligible to receive a distribution equal to the value of the participant's vested interest in his or her account. Distributions are generally payable via either a lump-sum cash payment or cash installments. A participant's account may be distributed as soon as practicable after the 12-month anniversary of the participant's termination.

**Pre-Retirement Distributions** – Hardship distributions are available subject to certain limitations as defined in the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has met any of the following criteria: the participant must have reached normal retirement age, met early retirement requirements, have been a participant for at least 15 plan years, or attained the age of 62.

**Forfeited Accounts** – Forfeited nonvested accounts are allocated to remaining active participants by reducing the current-year employer contributions. During 2024 and 2023, employer contributions were reduced by \$10,075 and \$14,450, respectively.

**Plan Expenses and Costs** – Plan expenses and costs for the custodian/trustee are paid from the Plan. The fees for the required audit of the Plan are paid by the Company. No fees or costs are charged to the plan by the administrator or the trustees.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

investments held by the Plan are stated at fair value, except for the investment contracts (Note 5), which are stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

All investments are considered to be participant-directed.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA plan document sponsored by Dunbar, Bender & Zapf, Inc. The IRS has determined by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 3—INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN / TRUSTEE (UNAUDITED)**

Effective April 1, 2024, the Plan switched from Lincoln National Life Insurance Company (custodian) to Fidelity Management Trust Company (custodian/trustee) as the custodian/trustee of the plan. The applicable custodian/trustee of the Plan has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023, in accordance with DOL Regulation 2520.103-5. Such information includes the composition, cost and current value of all investments held, and the contract value of the investment contracts, as of December 31, 2024 and 2023, and the interest, dividends, and net appreciation (depreciation) in fair value of investments for the years then ended.

**NOTE 4—FAIR VALUE MEASUREMENTS (UNAUDITED)**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*            Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund which represents the net asset value of the investments held by the fund at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded.

*Pooled separate accounts:* Valued at net asset value (NAV), the values of the pooled separate accounts are expressed in units as determined by valuing the underlying assets owned by the fund, minus its liabilities, and then dividing the value of the entire account by the total number of units in the plan account. There are no unfunded commitments, and the redemption frequency is daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5—INVESTMENT CONTRACTS WITH INSURANCE COMPANY (UNAUDITED)**

The Plan holds investment contracts with The Lincoln National Life Insurance Company (the Stable Value Fund). These accounts represent fully benefit-responsive investment contracts. They are stated at contract value on the Statements of Net Assets Available for Benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Lincoln seeks to preserve the principal investment and earnings but cannot guarantee that they will be able to do so. These accounts have certain restrictions that may impact the ability to collect the full contract value. Market value adjustments and surrender charges could limit the ability of the Plan to initiate and complete a transaction at contract value. A market value adjustment is a feature of the contract that protects Lincoln and its clients against sudden movements in the bond markets and offsets losses if assets are sold at a loss.

Lincoln reserves the right to terminate the contract if there is a breach of contract, if the Plan fails to meet the applicable requirements of the Code, or if the account has not met certain growth benchmarks as defined by Lincoln. The Plan's management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

The methodology used to calculate the interest crediting rate for the Guaranteed Account is discretionary to Lincoln. The crediting rate is set to be at least as high as the guaranteed minimum interest rate for a given contract. It is communicated to the plan sponsor before it goes into effect and is guaranteed for at least one quarter. The average crediting rates as reported by Lincoln were 4.00% and 2.54% for the years ended December 31, 2024 and 2023, respectively. The credited interest rates for the Stable Value Fund are determined based on the performance of The Lincoln National Life Insurance Company's general account and may be changed quarterly. Participants are allocated interest on the investment contracts based on the average rate earned.

**NOTE 6—AMENDMENT AND TERMINATION**

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion, by written action of the Plan Committee, to amend the plan, terminate the plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying or otherwise adversely affecting any benefit to a participant that is a "protected benefit" within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company's contributions.

The Plan was last amended on April 1, 2024 to include the custodian/trustee switch from Lincoln National Life Insurance Company to Fidelity Management Trust Company.

**NOTE 7—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

As of December 31, 2023, certain funds of the Plan were invested in pooled separate accounts and investment contracts managed by The Lincoln National Life Insurance Company, which was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services were included in net appreciation (depreciation) in fair value of the pooled investments, as they were paid through revenue sharing rather than a direct payment.

As of December 31, 2024, certain funds of the Plan are invested in mutual funds managed by Fidelity Investment Company, who is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

During the years ended December 31, 2024 and 2023, administrative fees of \$21,512 and \$5,140, respectively, were paid by the Plan to the custodian/trustee, which qualify as party-in-interest

transactions. Other direct fees paid to Lincoln totaled \$17,440 and \$61,266 during 2024 and 2023, respectively. The Plan sponsor also pays certain fees and expenses of the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9—SUBSEQUENT EVENTS**

Management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor's report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
