Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the 403(b) Thrift Plan of Eva's Village, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan of Eva's Village, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

The following description of the 403(b) Thrift Plan of Eva's Village, Inc. (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution plan covering all employees of Eva's Village, Inc. (the Organization). All employees become eligible to participate in the elective deferrals in the Plan on the first day of the month immediately after their hire date. Employees become eligible for employer contributions after he or she has completed two years of service, and attained at least 1,000 hours of service in each year. The Plan is subject to the provisions of ERISA. The Board of Directors of the Organization is responsible for oversight of the Plan. The Board of Directors also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act). The Plan intends to formally execute the required Plan amendments for these provisions by December 31, 2026.

The following descriptions of the Plan below have been updated with the provisions of the SECURE 2.0 Act that impact the Plan.

Contributions

Each year's participants may elect to make a basic contribution to the Plan by authorizing his or her compensation to be reduced by any percentage or whole dollar amount, as defined in the Plan. No employee is permitted to make a basic contribution in excess of the dollar limitation specified in the Internal Revenue Code at the beginning of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Organization may make a discretionary contribution to the Plan each Plan year. The Organization made a discretionary contribution of 2% of annual compensation for eligible employees for the two years ended December 31, 2024 and 2023 in the amount of \$107,826 and \$91,011, respectively.

Participant accounts

Each participant's account is credited with the participant's contributions and the Organization's discretionary contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are 100% vested in employer contributions.

1. Description of Plan (continued)

Plan loans

Plan loans are made directly from funds owned by Mutual of America Life Insurance Company and not from the participant's accounts. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the assets in the participant's account and have interest rates set at 5.85%. These loans, which are not assets of the Plan, were \$26,502 and \$37,860 at December 31, 2024 and 2023, respectively.

The loans must be paid back within five years. Principal and interest are paid ratably by the participant over the life of the loan through payroll deductions.

Payment of benefits

A participant may request a payment of benefits if they (a) become terminated, (b) become disabled, (c) reach age 65, or (d) on account of hardship. Participants may elect to receive a payout as a lump sum payment, a partial payment, a direct rollover, installment payments, and annuity contracts (if assets are held in a custodial account), or defer payments until age 73. Participants are allowed to receive hardship distributions for certain events as described in the Plan. Hardship distributions are required to be paid as lump sum payments.

In the event of a participant's death, any death benefit payable to a beneficiary will be distributed in the form of a qualified joint and survivor annuity if he or she has a spouse or a single sum payment to the beneficiary if the participant does not have a spouse. The spouse may elect to start receiving the death benefit on any first day of the month on or after the participant died and by the date the participant would have been required to take minimum distributions. If the spouse dies before benefits start, the participant's vested account, determined as of the date of the spouse's death, shall be paid to the spouse's beneficiary.

2. Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 8 for discussion of fair value measurements.

The Plan's investments in the interest accumulation account is reported as cash equivalents. The characteristics of this investment are comparable to cash equivalents in that there are no front or back-end charges, so that the investments are completely liquid; the interest rate credited to the investments are at the current rate and are not dependent upon the length of time the assets are invested; withdrawals can be made at any time and are processed on the same day; and the value shown on the statement is the redeemable value of the investment as there are no deferred sales charges, load assessment, or interest rate adjustments that would affect a withdrawal request.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and capital gains are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the discretionary contribution from the employer are recorded in the year in which participant compensation is earned.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of Plan loans are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Tax status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan Administrator believes that the terms of the Plan have been prepared to conform with the requirements of the Code, and is currently being operated in conformity with the applicable requirements of the Code and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024, the Plan Administrator believes that based on evaluation of the Plan's tax positions that any liability as a result of uncertain tax positions would not be material. Management continually evaluates expiring statutes of limitations, changes in tax law, and new authoritative rulings to assist in evaluating the Plan's tax positions. Accrued interest and penalties associated with uncertain tax positions, if any, would be recognized as part of the income tax provision. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The Plan maintains its investments with an investment manager. Exposure to credit risk is reduced by placing such investments in high quality financial institutions and by following an investment strategy which utilizes a wide range of diversified funds.

5. Certified investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (the trustee of the Plan).

6. Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the entire account balance will be distributed to the participants.

7. Transactions with parties-in-interest

Certain Plan investments are managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment manager services are included as a reduction in the net appreciation in fair value of investments. Investment advisory and administrative expenses relating to the maintenance of the Plan are paid from the Plan assets. Direct fees paid by the Plan during the year ended December 31, 2024 were \$1,802.

The Plan Administrator pays for professional fees relating to services provided to the Plan. Fees paid on behalf of the Plan during the year ended December 31, 2024 were \$17,500. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged.

8. Fair value measurements of investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad criteria data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgment by the Plan. The Plan considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, provided by multiple, independent sources that are actively involved in the relevant market. The categorization of an investment within the hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan's perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in registered investment companies are valued at the daily closing price as reported by the fund and are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Effective June 26, 2025, the Organization's board of directors approved a resolution to terminate its contract with Mutual of America Life Insurance Company (Mutual) and transfer all the Plan assets held by Mutual to The Lincoln National Life Insurance Company. Plan assets were transferred during August 2025.
