INDEPENDENT AUDITOR'S REPORT

The Trustees
Harmons Employee Welfare Benefit Plan

Opinion

We have audited the financial statements of Harmons Employee Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial status of Harmons Employee Welfare Benefit Plan as of December 31, 2024 and 2023 and the changes in its financial status for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

General information about Harmons City, Inc. (the Company) for the Harmons Employee Welfare Benefit Plan is outlined below. Participants should refer to the Plan agreement for a more complete description of the provisions of the Plan.

General

Effective June 1, 1979, Harmons City, Inc. which operates grocery stores in Utah, adopted a group insurance plan which covers medical, dental, vision, life, and accidental death and disability benefits for eligible employees. The Plan provides health, dental, accidental death and disability benefits to substantially all employees of Harmons City, Inc. The Plan was a partially self-insured program designed to pool and spread health care risks of participants from inception to January 31, 2005. The medical health plan was changed to a fully-insured plan and was brought into the Trust from February 1, 2005 through December 31, 2011; the dental plan has always been self-insured and part of the Trust. Effective January 1, 2012, the insurance coverage for medical claims was changed from fully insured to partially self-insured. There were no changes made to vision, life, and accidental death and disability benefits which remain fully insured; dental claims remain self-insured. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan agreement has no provision for postretirement benefits.

Eligibility

Employees become eligible to participate in the health plan and dental care benefits on the first day of the month following two months of continuous full-time employment.

Contributions

The Plan is funded through contributions made by Harmons City, Inc. and employees covered under the Plan. The required monthly contribution is determined by the third-party administrator at the beginning of each plan year. The employees pay a set amount each month depending upon whether they are classified as single, two-party with dependents, or family; the Company pays the balance of the required monthly contribution.

Benefits

The Plan provides health benefits (medical, surgical, limited dental, vision, limited mental illness and hospital care benefits and benefits in the event of sickness, accident, or death) covering participants as described in the Plan's agreement and in the summary plan description. Life insurance in the amount of \$20,000 is provided for eligible full-time employees and greater coverage is available at an individual employee cost.

Plan Benefits

Contributions received are held in a trust by the Trustee and are invested and reinvested to establish funding reserves for the payment of benefits, premiums, and other expenses of operating and maintaining the Plan. Benefits for medical, dental, vision, life, accidental death and disability, and specific and aggregate stop-loss coverage were either self-insured or provided by third-party providers. Money is transferred from the trust to the various providers as claim expenses and other premiums become due.

NOTES TO THE FINANCIAL STATEMENTS

Participant Termination

Participant coverage will terminate in accordance with the provisions of the Plan as follows: (1) on the day in which enrollment terminates, (2) when average hours worked falls below 32 hours per week, or (3) the date a spouse or child fails to meet the eligibility requirements or is terminated.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan's financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Cash and Cash Equivalents

For reporting purposes, the plan considers all cash and cash equivalents which are not subject to withdrawal restrictions or penalties, and certificates of deposit with original maturities at the time of purchase of 90 days or less to be cash or cash equivalents.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – ADMINISTRATIVE COSTS

For 2024 and 2023, the Plan paid for the expenses associated with administering the Plan.

NOTE 4 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Principal Custody Solutions is the Plan record keeper and has administrator responsibilities. These functions qualify as parties-in-interest. Administrative fees paid by the Plan to Principal Custody Solutions were \$12,500 for both of the years ended December 31, 2024 and 2023.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 5 – BENEFIT OBLIGATIONS

The Plan document provides for no postretirement benefits. The amount of benefit obligation outstanding as of December 31, 2024 and 2023 was provided by third-party health and dental providers. The amounts were based on information provided by their actuarial departments. The obligation amount was equal to the actual claims paid during the twelve-month period from January 1, 2024 through December 31, 2024 plus an estimate for incurred but not reported (IBNR) claims. It is at least reasonably possible that these estimates of claim obligations will differ from the actual amount to be incurred. The IBNR claims at December 31, 2024 and 2023 relate to both the health and dental plans.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the plan subject to the provisions set forth in ERISA.

NOTE 7 – TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code. Accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various cash equivalents. Cash equivalents are exposed to various risks, such as interest rates and credit risks.
