## Independent Auditor's Report

### Opinion

We have audited the financial statements of Southern California Pipe Trades Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Southern California Pipe Trades Defined Contribution Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Southern California Pipe Trades Defined Contribution Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Southern California Pipe Trades Defined Contribution Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule H, line 4i-schedule of assets held at end of year and schedule H, line 4a-schedule of delinquent participant contributions as of or for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 - Description of the Plan**

The following brief description of the Southern California Pipe Trades Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

### **General**

The Plan, a multiemployer plan, was established in 1991 and maintains a defined contribution plan for the eligible participants covered by collective bargaining agreements between the union members in District Council 16 of the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada (United Association) and employers in the plumbing and pipe fitting industry in Southern California. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (Trustees) and is governed by a joint board consisting of equal representation from the participating employers and the union.

### **Benefits**

Upon retirement, disability or death, a participant or their beneficiary is entitled to receive a lump-sum amount equal to their individual account balance. A terminated participant may withdraw their entire individual account balance, if they meet certain plan requirements. If the participant is unable to work due to a disability, they may receive a distribution based on the value of their account. If a participant meets the Plan's rules for a termination distribution and has an account balance of \$1,000 or less, they may automatically be paid a lump sum distribution. Participants are eligible for hardship withdrawals as defined in the Plan document. Participants are not required to take a distribution when they retire, except that, generally, they may not postpone the payment of benefits beyond the April 1st following the year in which they reach age 72.

### **Eligibility**

An employee may participate in the Plan if they are working in a job covered under a collective bargaining agreement, or by some other written agreement that provides for coverage by the Plan. The employee will be automatically enrolled in the Plan unless they choose to opt-out.

### **Contributions**

Participants may contribute a portion of their current wages to a maximum limit of \$23,000 for the year ending December 31, 2024, and \$22,500 for the year ending December 31, 2023. Participants age 50 and over by the end of the plan year may defer an additional "catch-up" contribution of up to \$7,500 per year during 2024 and 2023. Contributions are accepted in \$0.25 per hour increments. In addition, participants may designate all or a portion of their employee contributions as Roth contributions. All employees are auto-enrolled in the plan at \$0.50 per hour; participants can elect to opt-out, change their contribution rate and/or change to the after-tax Roth 401(k) by completing an enrollment/change/opt-out form and submitting it to their employer.

Employers may contribute non-elective contributions to the Plan on a participant's behalf if required by the collective bargaining agreement. The principal hourly contribution rate in effect for the Plan is \$0.25 - \$6.50 for the year ended December 31, 2024 and \$0.20 - \$5.00 for the year ended December 31, 2023.

## **Participant Accounts**

Each participant's account is credited with the participant and employer contributions (if any); contributions forwarded from another fund; plus, rollovers from another plan and investment gains; less investment losses, administrative fees and benefit payments.

## **Participant Fees**

Effective April 1, 2023, administrative fees are \$6.45 per quarter if the individual account balance is \$2,000 or less and \$24.90 per quarter if the individual account balance exceeds \$2,000. The Qualified Domestic Relations Order (QDRO) administrative charge is the lesser of \$550 or 10% of the balance of the account; each spouse's account is charged one-half.

## **Vesting**

Participants are immediately vested in their contributions and employer contributions plus actual earnings or losses thereon less fees and expenses.

## **Investment Options**

Upon enrollment in the Plan or at selected intervals thereafter, a participant may elect to direct contributions or investment balances within the investment options of the Plan. Participants may change their investment options daily. If a participant does not direct the investments of their individual account, their balance, plus any future contributions, will be invested in the default option selected by the Trustees.

## **Plan Termination**

It is intended that this Plan will continue indefinitely, but the Trustees reserve the right to change and/or discontinue the Plan at any time. If the Plan is terminated, the Trustees will pay the expenses of the Plan, arrange for a final audit, give any notice, prepare and file any reports which may be required by law, and apply the assets of the Plan in accordance with the Plan including amendments adopted as part of the termination until the assets of the Plan are distributed. Under no circumstances will any portion of the Plan revert or inure to the benefit of an employer or the union.

The Plan termination rules were amended to reflect that in the unlikely event the Plan is terminated and if there are Plan participants (or missing beneficiaries) who cannot be located after a diligent search has been made, the missing participant's (or missing beneficiary's) account will be rolled over to an individual retirement plan (IRA) in the name of the missing participant (or missing beneficiary).

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

### **Employer Contributions, Participant Contributions, Contributions Receivable, and Allowance for Credit Losses**

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer. Contributions from participating employers (401(a)) are based on a rate per hour for covered employees and are payable to the Plan during the subsequent month. Contributions from participants are based on a rate per hour for covered employees and are payable to the Plan as of the earliest date the contribution could reasonably be segregated from the employer's general assets.

Contributions due but not paid prior to year-end are recorded as contributions receivable. Management of the Plan evaluates participating employers' and participants' contributions receivable periodically for potential credit losses based on historical experience as well as current and reasonable and supportable forecasted economic conditions. As of December 31, 2024 and 2023, there was no allowance taken.

The Plan has an employer payroll audit system in place in which the employers are randomly audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits and are recorded as contributions when collected.

### **Reciprocity and Allowance for Credit Losses**

The Plan has various reciprocal agreements in place with other collectively bargained Local Unions. If a participant works under the jurisdiction of another collectively bargained agreement, the contributions will be transferred to the participant's home Local Union as soon as administratively feasible. For the years ended December 31, 2024 and 2023, the Plan recognized \$3,955,885 and \$4,960,174, respectively, of reciprocal cash payments in accordance with these agreements with the participating local unions. Reciprocal payments received are included in the employer's contributions in the statements of changes in net assets available for benefits.

As of December 31, 2024 and 2023, the reciprocal contributions receivable was \$283,027 and \$266,966, respectively. The receivable is included in the employer contributions receivable in the statements of net assets available for benefits. No allowance for credit losses as of December 31, 2024 and 2023, was necessary for reciprocal payments due to the Plan.

Payments made to other plans for reciprocal contributions collected on behalf of those plans are recorded when paid. Outgoing reciprocal payments are netted against the related reciprocal contributions received with no material effect on the statements of net changes in net assets available for benefits.

## **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

## **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on the Form 5500 due to different reporting requirements on the Form 5500.

## **Expenses**

The Plan's expenses are paid by the Southern California Pipe Trades Administrative Corporation (SCPTAC) as provided in the Plan Document. Certain expenses incurred in connection with the general administration of the Plan that are paid by SCPTAC are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

The Plan shares certain administrative expenses with a related plan. In computing these allocated costs, various factors were considered, including time spent, costs incurred, and volume of transactions relating to the Plan in relation to the other plans.

## **Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual fund) – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds – valued at the NAV of units of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

### Note 4 - Tax Status

The Plan obtained its latest determination letter on September 20, 2011, in which the IRS states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 - Related Party Transactions and Administrative Expenses**

The Plan pays fees for several arrangements with service providers and affiliated entities. These transactions are considered exempt party-in-interest transactions under ERISA.

The Plan is allocated general and administrative expenses from SCPTAC, a California nonprofit mutual benefit corporation, created on January 1, 1996, for the administration of the Southern California Pipe Trades Trust Funds. The allocations are determined by management, and the Trustees believe that these allocations are based on customary and reasonable rates and that such service occurred in the normal course of operations. The amount charged by SCPTAC to the Plan for the years ended December 31, 2024 and 2023 was \$811,052 and \$734,608, respectively. At December 31, 2024 and 2023, \$293,570 and \$0, respectively, was due to SCPTAC for reimbursement of administrative costs.

In addition, SCPTAC collects employer contributions on behalf of the Plan. These contributions are forwarded to the Plan on a regular basis. At December 31, 2024 and 2023, amounts due from SCPTAC for contributions from employers and participants and fees from participants received were \$2,212,249 and \$3,426,965, respectively.

**Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 7 - Delinquent Participant Contributions**

Some contributing employers have failed to remit to the Plan certain employee elective deferrals within the period prescribed by DOL regulations. The Plan has in place specific procedures to correct late payments of employee elective deferrals. The Plan has contacted those employers regarding making the necessary payments to affected participants' accounts for potential lost income due to the delay.

**Note 8 - Plan Amendment**

Effective January 1, 2023, the Plan was amended to update the required beginning date to be April 1 following the year a Participant reaches the applicable age required for a minimum distribution. For those Participants who reach age 72 after December 31, 2022, and age 73 before January 1, 2033, age 73; or for those Participants who reach age 74 after December 31, 2032, age 75.

### **Note 9 - Transfer in from Qualified Plan**

In December 2024, the Landscape, Irrigation and Lawn Sprinkler Industry Defined Contribution Pension Plan merged with Southern California Pipe Trades Defined Contribution Plan. The participant account balances were transferred into the Plan in 2025.

An aggregate of \$9,420,089 was transferred into the Plan during the year ended December 31, 2024.
