### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the accompanying financial statements of the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion***

We do not express an opinion on the financial statements referred to above of the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

***Basis for Disclaimer of Opinion***

The 403(b) Thrift Plan for Employees of the Science Museum of Minnesota has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements referred to above may have been affected by these conditions.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the 403(b) Thrift Plan for Employees of the Science Museum of Minnesota and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan for Employees of The Science Museum of Minnesota (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective on January 1, 1983, and amended throughout the years to comply with tax legislation. The Plan was most recently restated on June 29, 2020 with a retroactive effective date of January 1, 2010 as part of the remedial amendment period to adopt a prototype 403(b) plan document. The Plan covers employees of The Science Museum of Minnesota (the Employer). The Plan excludes certain nonresident aliens who have no earned income from sources within the United States, and employees whose employment is governed by a collective bargaining agreement under which retirement benefits are the subject of good faith bargaining are excluded from participating in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for the oversight of the Plan and along with the external investment advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Subsequently, the Plan was restated on January 1, 2025 to adopt provisions of a safe harbor matching contribution to replace current provisions of the employer matching contributions.

**Eligibility**

Salary Deferrals – Employees are eligible to participate in the salary reduction arrangement in the Plan immediately upon hire.

Employer Matching Contributions – Employees are eligible to participate in Employer matching contributions after the completion of one year of service in which they completed at least 1,000 hours of service and the attainment of age 21 or older.

**Contributions**

Participants may elect to make contributions, on a pre-tax or after-tax Roth basis, up to 100% of their eligible compensation. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows for special 403(b) catch-up contributions for those with 15 years of service subject to plan provisions. Participants direct the investment of contributions into various investment options offered by the Plan.

The Employer will make matching contributions of 100% up to 4% of the employee's eligible compensation deferred for the year ended December 31, 2024.

Contributions are subject to certain limitations.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions and the Employer's matching contribution, and an allocation of plan earnings or losses. Allocations are based on participant earnings or losses, or account balances, as defined. Participants direct the investment of their accounts into certain investment options offered under the Plan. Current employee and Employer contributions are only invested in the Mutual of America investment options. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Employer matching contributions plus actual earnings thereon.

**Plan Loans**

Participants may borrow amounts from TIAA and Mutual of America Life Insurance Company (MOA), the insurance carriers, in an amount up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account whereby 110% of the loan balance is set aside in the TIAA Traditional Annuity and MOA Interest Accumulation as security for the loan. The loans bear interest at a variable rate based on the Moody's Corporate Bond as determined by the insurance carriers. Loan terms are up to five years, except for loans to fund the purchase of a principal residence, for which the loan may be repaid over a reasonable period that may not exceed 10 years. As the loan is repaid, the amount of the security account is reduced by the payment amount. Because TIAA and MOA are the lenders, a portion of the interest payments are returned to TIAA and MOA. At December 31, 2024, interest rates of outstanding loans ranged from 3.50% to 5.85%. The amount held as security for loans was \$76,784 and \$98,980 for the years ended December 31, 2024 and 2023, respectively.

**Benefit Payments**

Upon termination of employment, including death, disability or retirement, participants may elect a benefit payment in the form of a single sum payment, a qualified joint and survivor annuity payment, or a purchase of a nontransferable annuity contract providing substantially nonincreasing payments. Participants who have reached age 70½ and continue employment must begin distributions no later than April 1 following the year employment is terminated. The Plan allows for hardship distributions and in-service distributions subject to plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

The Employer pays certain administrative expenses on behalf of the Plan. Investment related fees are included in the net appreciation in fair value of investments.

**Subsequent Events**

In preparing these financial statements, the Employer has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

TIAA and CREF and Mutual of America Life Insurance Company (MOA), the qualified institutions, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*Sub-Accounts of Variable Annuities:* Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*General Account:* Valued at fair value by TIAA and CREF by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

**NOTE 5 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANY**

The Plan invests in the TIAA Traditional Annuity, which is a fixed-dollar annuity investment product offered by TIAA, an insurance company. TIAA and CREF maintain a portion of the contributions in a general account, which is called the Traditional Annuity – Benefit Responsive, a traditional fully benefit-responsive guaranteed investment contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan also has an insurance contract with MOA. As part of the contract, MOA maintains a portion of the contributions in an "interest accumulation account," a traditional fully benefit-responsive guaranteed investment contract. The account is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by MOA.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA and CREF and MOA, represent contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due under this portion of the contracts is dependent on the issuer's ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

As part of the contracts, TIAA and CREF also maintains a portion of the contributions in a "guaranteed account", which is called the Traditional Annuity – Non Benefit Responsive. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA and CREF. The guaranteed account is included in the financial statements at fair value because it is nonfully benefit responsive. The Traditional Annuity is subject to a 10-year withdrawal period. Upon termination of the contract, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Annuity accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account divided by the number of remaining payments. The average yield based on annualized earnings and based on the interest rate credited to participants was 4.61% for the year ended December 31, 2024.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although there has been no expression of intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 8 PLAN TAX STATUS**

The Employer adopted a prototype document and the Plan is placing reliance on an opinion letter dated March 31, 2017 received from the Internal Revenue Services (IRS) on the prototype plan indicating that the prototype plan is qualified under Section 403(b) of the Internal Revenue Service (IRC) and is, therefore, not subject to tax under current income tax law. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 SCOPE LIMITATION**

The Plan has not maintained sufficient accounting records and supporting documents related to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, plan management was unable to determine the extent to which the accompanying financial statements and supplemental schedule may have been affected by these conditions.

As a result of the inability to obtain plan level information prior to January 1, 2009, certain participant account information could not be obtained from the Plan's third-party administrators in order to adequately complete testing of transactions from and allocations to participant accounts. The Plan administrator is aware of these limitations with the providers and believes a good faith effort was made to obtain this information. Since January 1, 2010, participant information necessary to adequately test transactions from and allocations to participant accounts exists and such tests as deemed necessary have been completed.

**NOTE 10 RELATED PARTY TRANSACTIONS**

The Plan investments are managed by TIAA and CREF and MOA, the qualified institutions. Therefore, all investment transactions qualify as party-in-interest transactions.

**NOTE 11 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The Plan holds investments in pooled separate account #2 with Mutual of America, as classified in the financial statements included herein. The pooled separate account did not file a Form 5500 for the direct filing entity. Therefore, the underlying assets, which are deemed to be sub-accounts of the pooled separate accounts, have been reported on Form 5500, Schedule H, as mutual funds.
