NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Mercer Advisors Inc. 401(k) Plan (the "Plan") provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Mercer Advisors Inc. and subsidiaries (the "Company" or "Employer"). Participants become eligible to make elective deferrals and receive the employer matching contributions once they have completed one month of service and are age twenty-one or older. Employees must have two years of service to be eligible for employer discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined by the Plan, up to the IRC annual limits. The aggregate amount of such elective deferrals is contributed to the trust on a pre-tax or Roth basis. Each year, at the Company's discretion, it contributes the lesser of 50% of the participant contributions or 3% of the participant compensation. The Company elected to make a matching contribution for the years ended December 31, 2024 and 2023. Additional discretionary profit-sharing contributions may be made at the option of the Company's board of directors. No discretionary profit-sharing contributions were made during 2024.

Investments

Investments are held in participant-directed accounts. The participants select the percentage of contributions to be allocated to each investment option. Participant's contributions are withheld from their paychecks and remitted to the Plan. The participant's accounts are credited with the actual earnings on the underlying investments and are charged for Plan withdrawals. Earnings on investments include interest income, realized and unrealized gains and losses, and dividends.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contributions, and an allocation of the Plan's income and expenses as well as allocations of the Company's profit-sharing contributions and Plan earnings. Allocations are based on account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and any discretionary profit-sharing contributions plus actual earnings thereon. For employer's matching contributions and earnings, the vesting is over a four-year period as follows: 25% after two years of service, 50% after three years of service and 100% after four years of service. Early vesting to 100% also occurs in the event of death or disability of the participant.

Notes Receivable From Participants

Participants in the Plan may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loan transactions are treated as transfers between the investment fund and the loan fund and participants may not have more than two loans outstanding at a time. Monthly repayments are automatically deducted from the participant's wages. Loan terms range from one to five years, or greater

than five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear an interest rate of 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum equal to the value of the participant's vested account balance, or take installment payments over a specified period of time, not exceeding the life expectancy of the participant and beneficiary.

Forfeited Accounts

Forfeited accounts will be used to reduce future employer contributions, or in the event there are no employer contributions, forfeitures are used to pay administrative expenses or allocated to the participants. At December 31, 2024 and 2023, forfeited account balances totaled \$146,521 and \$125,973, respectively. Forfeitures totaling \$213,546 were used to reduce Company contributions during 2024.

Income Taxes

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the plan administrator and advisory committee believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America ("US GAAP") requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements and have found none. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Newport Trust Company, LLC, (the "Trustee") as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Accounting and certain administrative expenses incurred in the administration of the Plan are either paid by the Company or are paid with forfeitures and are not allocated to individual participant accounts. Notes receivable from participants also constitute exempt party-in-interest transactions.

NOTE 5 - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits as of December 31, 2024.
- Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.

NOTE 6 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology may include: quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds Valued at the net asset value ("NAV") of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. As of December 31, 2024 and 2023, the Plan did not classify any assets as Level 2 or Level 3.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan investments in funds which invest in securities of foreign countries, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those securities of comparable U.S. companies.

NOTE 8 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued. No subsequent events were identified that required adjustment to or disclosure in the financial statements.
