## INDEPENDENT AUDITORS' REPORT

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from American United Life Insurance Company as of December 31, 2024 and for the period from October 1, 2024 to December 31, 2024 and Transamerica Life Insurance Company Inc. for the period from January 1, 2024 to September 30, 2024 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section,

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### **Report on the 2023 Financial Statement**

Plan management is responsible for the preparation and fair presentation of the accompanying 2023 financial statement of the plan, which comprise the statement of net assets available for benefits as of December 31, 2023 and the related notes to the financial statement, in accordance with GAAP. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the 2023 financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2023 financial statement.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The Sid Grinker Restoration 401(k) Plan ("the plan"), previously known as the Sid Grinker Restoration, Inc. Employees' Profit Sharing Plan, follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 14, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Sid Grinker Restoration, Inc. is the plan sponsor, employer and plan administrator. Prior to October 1, 2024, Sikich, LLP was the third-party administrator who performed various compliance testing as tax counsel and Transamerica Life Insurance Company Inc. ("Transamerica") was the investment agent and recordkeeper that maintained investment and participant records and was the custodian of the plan's pooled separate account and stable value investments. Effective October 1, 2024, American United Life Insurance Company ("AUL"), a OneAmerica company, became the plan's investment agent that holds custody of the plan's pooled separate account and stable value investments, recordkeeper that maintains investment and participant records and third-party administrator that performs various compliance tests as tax counsel. Charles Schwab & Co., Inc. ("Charles Schwab") is the custodian of the plan's self-directed brokerage account. RBC Wealth Management is the plan's investment advisor for the pooled separate account and stable value investments. An officer of the plan sponsor is the trustee.

**Investments** - The plan sponsor determines the investments available to plan participants. The self-directed brokerage accounts are selected by eligible participants electing this option. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in the fair values of investments bought, sold or held during the year is reflected in the accompanying statement of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Pooled separate accounts** - The pooled separate accounts are valued at the net asset value ("NAV") as provided by AUL/Transamerica. The NAV is generally based on the fair value of the underlying mutual fund investments held by the separate accounts less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined that the separate account would sell the investment for an amount different than the reported NAV. The AUL pooled separate accounts are not direct filing entities. The Transamerica pooled separate accounts were direct filing entities.

*Self-directed brokerage account* - Primarily consists of common stocks valued at the daily closing price as reported by the investment. The investments are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

**Investments at contract value** - Effective October 1, 2024, the plan has a fully benefit-responsive stable value investment contract ("Stable Value Account") through a group annuity contract issued by AUL. AUL maintains the contributions to this investment account in a general account which is invested in a conservatively managed, diversified portfolio consisting primarily of fixed-income investments with the objective to maximize long-term, risk-adjusted returns. AUL is contractually obligated to repay the principal and a minimum rate of interest for the life of the contract.

Amounts contributed to the Stable Value Account earn interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by AUL; determined at least annually. The average yield earned by the fund was 2% in 2024.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Stable Value Account contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Liquidation of the entire Stable Value Account contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different than the contract value. This total liquidation is a contingent event, which cannot be initiated by the participants and can only be initiated by the trustee upon termination of the plan or contract.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator was not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

Prior to October 1, 2024, the plan had a fully benefit-responsive stable value investment through a group annuity contract issued by Transamerica. Transamerica paid interest and guaranteed the plan's capital deposit regardless of the activity in the general account. The investment was not considered a Guaranteed Investment Contract or Common/Collective Trust as there were no specific underlying securities and no stated minimum or maximum interest rates. The investment, as a deposit liability of Transamerica with no underlying assets, had no direct investments on behalf of the plan. The investment value was based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica's insurance ratings. The effective annual interest rate was established every six months. Interest was credited, based upon the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. The average yield earned by the fund was 2.26% in 2024. There was no market value adjustment from contract value deducted from plan assets at the time of liquidation.

### 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective April 1, 1996 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Prior to October 1, 2024, employees were eligible to participate in the plan once they had completed one month of employment and had reached age eighteen. An employee was able enter the plan on the first day of the month following or coinciding with meeting the eligibility requirements. Effective October 1, 2024, the service requirement was eliminated and employees can now enter plan immediately upon becoming eligible.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 3% of compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans. There were no such contributions in 2024.
- c. Safe harbor matching contributions are required to be made equal to 100% of the first 5% of employee compensation contributed to the plan as elective deferral contributions in 2024. These contributions are funded coinciding with each payroll with an annual true up contribution.
- d. The plan sponsor may make additional employer nonelective contributions at its discretion. No discretionary nonelective contributions were made in 2024.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contribution. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor matching contributions and related earnings. Participants begin vesting in any employer nonelective contributions and related earnings upon two years of service, at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability, or attainment of normal retirement age (as defined in the agreement) while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age while employed. Distributions may be in the form of a single lump sum, installments, or partial withdrawals. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals are allowed upon attaining the age of 59½.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees, loan fees, and investment advisory fees on the self-directed investment accounts and non-participant directed charges for service and administrative fees. Non-participant directed fees are allocated to the participants on an account value basis.

**Forfeitures** - Forfeited nonvested accounts may be used to pay plan expenses or reduce the amount of employer contributions. There were \$74,000 of forfeitures used to reduce safe harbor matching contributions in 2024. Unapplied forfeitures were \$39,000 as of December 31, 2024. There were no unapplied forfeitures as of December 31, 2023.

**Notes receivable from participants** - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may not have more than two loans outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had repayment schedules through July 2054 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

AUL/Transamerica manage/managed certain plan investments (see Note 6) and are/were the investment agents that hold/held custody of the pooled separate account and stable value investments, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to the investment agents were insignificant in 2024. AUL/Transamerica provide/provided certain administrative services to the plan pursuant to services agreements between them and the plan sponsor. AUL/Transamerica receive/received revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to AUL/Transamerica for their administrative services to the plan.

In addition, Charles Schwab manages certain plan investments in connection with the self-directed brokerage account. Any transactions between Charles Schwab, the plan sponsor and the plan are considered party-in-interest transactions. Direct fees paid to Charles Schwab were \$13,000 in 2024.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in any employer nonelective contributions and related earnings.

### 5. INCOME TAX STATUS

Prior to October 1, 2024, the plan was operating under a Sikich LLP Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan that received a favorable opinion letter on June 30, 2020. Effective October 1, 2024, the plan adopted a OneAmerica Financial Partners Inc. Non-Standardized Pre-Approved Profit Sharing Plan with CODA that received a favorable opinion letter on August 19, 2020. The favorable opinion letters from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
