We have performed an audit of the financial statements of the iostudio, LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) *Description of Plan*

The following description of the iostudio, LLC (“Company”) 401(K) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more detailed description of the Plan’s provisions.

(a) *General*

The Plan is a defined contribution plan covering all employees of the Company who are twenty-one and over and have completed three months of service. Employees may enroll on the first day of the month after fulfilling the age and service requirements. The Plan is administered by the Company in accordance with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 26, 2023, the Plan changed service organizations providing recordkeeping and custodial services. All Plan assets were transferred to the new service organization at fair value. See Note 9 for more information related to the transfer.

(b) *Contributions*

Each year, participants are permitted to make pre-tax contributions or elect to reduce their compensation to make Roth 401(K) contributions at rates of at least 1% up to 100% of eligible earnings, as defined by the Plan. Contributions are subject to a maximum annual amount as determined under applicable law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as determined by the Internal Revenue Service (“IRS”) and ERISA. Participants may also contribute amounts representing distributions from other qualified deferred benefit or defined contribution plans (“rollover”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to opt-out of the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible pre-tax compensation and their contributions invested in a designated balanced fund until changed by the participant.

Each payroll period the Company makes a safe harbor matching contribution to the Plan for eligible participants. The Company will match 100% of the first 3% of the eligible participant’s compensation contributed to the Plan and 50% of the next 2% of the eligible participant’s compensation contributed to the Plan.

The Company may make, at its discretion, profit sharing and matching contributions to the Plan. The Company did not make discretionary profit sharing or matching contributions during 2024.

(c) *Participant Accounts*

Each participant's account is credited with the participant's and the Company's contributions and any rollovers, an allocation of Plan earnings, and may be charged with some or all of the costs and expenses of operating the Plan. Allocations are based on participant earnings, account balances, or election of investment options, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) *Vesting*

Participants are immediately vested in their contributions made and the Company's discretionary profit sharing and matching contributions plus actual earnings thereon.

The Company's safe harbor matching contributions vest in accordance with the following schedule:

<u>Years of Vesting Services</u>	<u>Vesting Percentage</u>
Less than one year	0%
One but less than two years	50%
Two or more years	100%

(e) *Payments of Benefits*

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments over a period not to exceed the life expectancy of such participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants with vested account balances less than \$1,000 are immediately distributed as a lump-sum under the terms of the Plan without the participant's consent, unless the participant has made a timely rollover election to an Individual Retirement Account or other qualified arrangement.

(f) *Investment Options*

Investments are made as directed by the Plan's participants. Company contributions are invested in the same manner as participant elective contributions. The Plan currently offers various pooled separate account investment options and a guaranteed investment contract issued by Standard Insurance Company ("SIC") (See Note 9).

(g) Forfeitures

Upon termination of employment, the unvested portion of the participant's account is forfeited. Forfeitures are retained in the Plan and may first be used to pay administrative expenses and fees and then to reduce Company contributions to the participants remaining in the Plan. During the year ended December 31, 2024, forfeitures totaling \$996 were used to reduce Company contributions to participants and forfeitures totaling \$2,258 were used to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$2,550 and \$0, respectively.

(h) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes 100% vested in the aggregate value of his or her account regardless of each participants current vesting percentage and is entitled to receive the balance in his or her account (after payment of all expenses and proportional adjustment of such expenses and any investment gains or losses).

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP") and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(b) Contributions Receivable

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for credit losses was necessary at December 31, 2024.

(c) Investment Valuation and Income Recognition

The Plan's investments are primarily stated at fair value, with the exception of its fully benefit-responsive investment contract, which is stated at contract value (see Note 4). If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contracts and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payments of Benefits

Benefits are recorded when paid.

(e) Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, if any, are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for annual participant account maintenance and fees related to distributions to participants are included in administrative expenses and are charged to participant accounts.

(f) Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain amounts reported in the financial statements. Actual results could differ from those estimates.

(g) Date of Management's Review and Subsequent Events

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The Plan accounts for its financial assets and liabilities in accordance with Accounting Standards Codification 820, Fair Value Measurement (“ASC 820”), which are carried at fair value on a recurring basis in the financial statements. ASC 820 establishes a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels are defined as follows:

- Level 1:** Quoted price (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2:** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in market that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3:** Unobservable inputs that reflect a reporting entity’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for investments measured at fair value:

Pooled separate accounts: Pooled separate accounts (“PSAs”) are valued using net asset value (“NAV”) as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. PSAs invest primarily in mutual funds, domestic equity securities, and fixed maturity securities. The Plan has concluded that the reported NAVs approximate the fair value of the investment. Participant transactions may occur on a daily basis. The ability to exchange with units of PSAs may be restricted in the event that participants engage in trading patterns which are detrimental to the PSA or underlying investment. Investment funds may be subject to certain trading restrictions that apply to transfers into an investment fund. Transfers out of a PSA are allowed at any time. At December 31, 2024 and 2023, there were no unfunded commitments related to the PSAs.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes this valuation method is appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial investments could result in a different fair value measurements at the reporting date.

(4) Fully Benefit-Responsive Investment Contract

The Standard Stable Asset D Account ("Stable Value Fund") is a fully benefit-responsive investment contract and is reported at contract value on the statements of net assets available for benefits. Benefit responsiveness is defined as the extent to which a contract's terms and the Plan permit or require participant initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents participant contributions, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses.

The Stable Value Fund is a general account backed group variable annuity contract issued by Standard Insurance Company ("SIC"), is backed by the creditworthiness of the issuer, and has no maturity date. There are not any specific securities in the general account that back the investments in the account. SIC is contractually obligated to repay the principal and a specified crediting interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of SIC or otherwise. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account at contract value within reasonable time frames. Restrictions apply to the aggregate movement of funds to other investment options. There is no event that is probable that limits the ability of the Plan to transact at less than contract value with SIC. There are also no events or circumstances that are probable that would allow SIC to terminate the group variable annuity contract with the Plan and settle at an amount different from contract value.

(5) Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated November 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan, as restated, is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to the applicable statute of limitations.

(6) Information Prepared and Certified by Custodian

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Custodian, Standard Insurance Company. This information has not been audited by the independent auditors.

(8) **Related Party and Party-in-Interest Transactions**

Plan assets include investments in various pooled separate accounts and a guaranteed investment contract managed by Standard Insurance Company and/or their affiliates. Standard Insurance Company is the custodian and recordkeeper of the Plan. Therefore, these investments represent party-in-interest transactions under the provisions of ERISA. Fees paid to Standard Insurance Company for their services provided totaling \$10,608 were paid by the Plan and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain investment advisory services are provided by Northwestern Mutual Wealth Management Company ("Northwestern"). Fees paid to Northwestern for their services provided totaling \$16,628 were paid by the Plan and are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Plan audit fees paid to the Plan auditor totaling \$11,849 were paid by the Plan and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain administrative services are provided by July Business Services, LLC (the Plan's third-party administrator). Fees paid to July Business Services, LLC for their services provided totaling \$10,440 were paid by the Plan and are included in administrative expenses on the statement of changes in net assets available for benefits.

All identified party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

(9) **Cash**

Effective December 26, 2023, the Plan changed service organizations servicing the Plan from Transamerica Retirement Solutions to Standard Retirement Services, Inc. In connection with the change in service organizations, Plan assets totaling \$6,222,689 were transferred to the new service organization. The assets were received by Standard and invested effective January 2, 2024.
