### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Standard 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## The Standard 401(k) Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of The Standard 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Summary Plan Description and may request a copy of the Plan Document from the Plan Sponsor for more detailed information.

**General** – The Plan is a voluntary deferred compensation plan under Section 401(k) of the Internal Revenue Code (“the Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Sponsor and custodian is Standard Insurance Company (“Standard”), and the Plan recordkeeper and administrative service provider is Standard Retirement Services, Inc. (“Standard Retirement Services”). Both Standard and Standard Retirement Services are wholly owned subsidiaries of StanCorp Financial Group, Inc. (collectively, “StanCorp and subsidiaries”). The Plan Sponsor controls and manages the operation of the Plan.

On April 1, 2024, StanCorp and subsidiaries closed on the acquisition of the life and disability businesses from Elevance Health, Inc. (“Elevance”). The 472 Elevance employees who supported the acquired life and disability businesses joined as employees in these new subsidiaries of StanCorp and subsidiaries as of April 1, 2024. During the year ended December 31, 2024, rollovers to the Plan from Elevance employees were \$23,488,635 and loans from Elevance employees in the amount of \$959,728 were transferred into the Plan from the Elevance qualified plan.

**Eligibility** – All new employees of StanCorp and subsidiaries, except leased employees, union employees, interns and individuals not eligible based on written agreement, enter the Plan on the date of hire.

Participants are eligible for a matching contribution following the date of hire. Employees are also eligible for a non-elective contribution following the date of hire and are not required to contribute to the Plan to receive this contribution.

### Contributions

*Participant contributions* – Participants may elect to make traditional contributions (pre-tax) or Roth contributions (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

Each year, participants may contribute a percentage of eligible compensation to the Plan, ranging between 1% and the maximum percentage legally permissible, which is determined by the Code.

*Employer match and non-elective contributions* – StanCorp and subsidiaries match 100% of up to 5% of eligible compensation that a participant contributes to the Plan. The non-elective contribution is set at a uniform rate of 4% of eligible compensation effective immediately upon hire.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s elective contributions, StanCorp and subsidiaries’ matching contributions, the non-elective contribution, if applicable, and net investment earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Upon enrollment in the Plan, participants may direct their contributions and the employer contributions in 1% increments to a number of funds that are administered and maintained by Standard. The Plan offers 27 pooled separate account investments and a deposit administration contract as investment options for participants. Participants may change or transfer their investment options daily.

**Vesting** – Participants are immediately fully vested in both their elective contributions and StanCorp and subsidiaries’ matching contributions. Eligible participants are fully vested in the non-elective contributions after three years of service or upon reaching normal retirement age while employed.

**Withdrawals and distributions** – Upon termination of service due to death, disability, or retirement, a participant, or their designated beneficiary in the case of death, may elect to receive benefits in a lump sum, in quarterly partial distributions or in payments from the participant’s account until the vested account balance is exhausted. Distributions are made as soon as administratively possible to electing employees who terminate employment or retire, or to the beneficiaries of deceased participants. Withdrawals may be made in the case of hardship or certain other circumstances as described in the Plan Document. Participants may leave their funds in the Plan if the participant’s account balance is greater than \$5,000 or they may request a direct rollover into an individual retirement account (“IRA”) or to another eligible plan that accepts direct rollovers. Participant account balances below \$5,000 will be automatically distributed upon termination. Funds remaining in the Plan continue as tax deferred and are invested at the participant’s direction. Federal law requires participants begin receiving required minimum distributions after age 72.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan Document, plan loans will bear a reasonable rate of interest determined by the interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic area as StanCorp. Principal and interest is paid ratably through semimonthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.25% to 9.50% with various maturities through February 2052.

**Administrative expenses** – Administrative expenses are paid by StanCorp and subsidiaries with the exception of an asset-based fee, loan initiation fees and lump sum distribution fees. The asset-based fee is 0.01% of participants’ account balances and is reduced by any revenue received from providers of the underlying mutual funds.

**Forfeitures** – Forfeitures are the non-vested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan, must be used before year end and will be used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,907 and \$9,255, respectively. For the years ended December 31, 2024 and 2023, employer matching contributions were reduced by \$451,925 and \$400,485, respectively, from forfeited non-vested accounts.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments reported at fair value consist of pooled separate accounts. The deposit administration contract is reported at contract value. The Plan’s custodian, Standard, certifies the contract value of the deposit administration contract and the fair market value of the investments in pooled separate accounts. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measurement for assets invested in a fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 3).

*Pooled separate accounts* – Units held in pooled separate accounts are valued using the net asset value (“NAV”) practical expedient of the pooled separate accounts as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the pooled separate accounts, minus its liabilities, and then divided by the number of units outstanding.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation or depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Document.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance; thus, they are not separately disclosed in the accompanying financial statements. Participants are assessed separate fees for the administration of loans and repayments thereof, as well as investment advisory services, and such fees are separately disclosed in the financial statements. All other administrative expenses related to the Plan are paid by the Plan Sponsor and are excluded from these financial statements.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

On April 1, 2025, StanCorp and subsidiaries closed on the acquisition of the life and disability business from American Heritage. There were 959 new employees who joined in this new subsidiary of StanCorp and subsidiaries as of April 1, 2025. Rollovers to the Plan have totaled \$61,470,226.

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Deposit Administration Contract**

The Plan invests in a fully benefit-responsive investment contract (“FBRIC”) with Standard. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rates are based on a formula established by the contract issuer and ranged from 4.10% to 3.50% during 2024, and 3.60% to 3.00% during 2023. The crediting rate is reviewed on an annual basis for resetting and may not be less than 1%. The FBRIC does not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

The contract meets the FBRIC criteria and, therefore, is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan’s ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Standard may terminate the contract with 30 days advance written notice to the contract owner. Upon such notice, the contract may be subject to a market value adjustment upon payout.

### **Note 4 – Tax Status**

The Plan Document is a Volume Submitter Profit Sharing defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated the Plan as then designed, was in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has concluded there were no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5 – Risks and Uncertainties**

The Plan invests in various securities and insurance contract including pooled separate accounts and a deposit administration contract. These investments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term, and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The financial instruments may subject the Plan to concentrations of risk. The contract value of the deposit administration contract are dependent on the ability of Standard to honor its contractual commitments as the issuer. Investments in pooled separate accounts are subject to changes in the market values of the underlying securities.

### **Note 6 – Certified Investment Information**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Standard, a qualified institution:

- Investments in pooled separate accounts and the deposit administration contract, and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest on deposit administration contract, and interest income on notes receivable from participants reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the Schedule of assets (held at end of year).

### **Note 7 – Party-in-Interest Transactions**

Standard is the custodian and the Plan Sponsor. Plan investments include shares of pooled separate accounts and a deposit administration contract maintained by Standard. Therefore, investment transactions with these funds qualify as exempt party-in-interest transactions.

### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, Standard has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in all benefits earned to that date and plan assets would be available for distribution to participants. Distributions to each participant at termination would be based on the value of that participant's account.
