Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JMB-III Holdco, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

Opinion

Basis for Opinion

Notes To Financial Statements

NOTE 1. PLAN DESCRIPTION

The following description of the JMB-III Holdco, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company who have 30 days of service and have attained age 21. The Plan is subject to the provisions of ERISA. The retirement advisory committee is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Ascensus Trust Company (Ascensus) is responsible for investing and managing the Plan assets, subject to the direction of the Plan participants.

Effective August 1, 2024, the Board of Managers of the Company approved an amendment to suspend participant loans. No further loans were allowed after this date.

Effective September 29, 2024, the Plan Sponsor changed from M3, LLC to JMB-III HoldCo, Inc. Concurrent with the change in Plan Sponsor, the Plan name was amended from M3 Accounting Services, Inc. 401(k) Plan to JMB-III, HoldCo, Inc. 401(k) Plan.

Effective September 29, 2024, the Plan was frozen. No new participants were allowed to enter the Plan, and no further contributions were allowed after this date.

Contributions

Prior to the Plan being frozen, each year, participants were able to contribute an amount equal to any whole percentage of compensation between 1% and 50%. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company contributed 100% of the first 6% as an employer safe harbor matching contribution. The Company was also able to make additional discretionary employer profit-sharing contributions to the Plan from available business profits. The Company did not make any discretionary employer profit-sharing contributions for 2024. Contributions were subject to certain IRS limitations.

The Plan recorded employer and employee contributions receivable when compensation was paid and deferrals were withheld. In accordance with ASC 326, *Financial Instruments – Credit Losses*, no allowance for credit losses was recorded at December 31, 2024 and 2023, as employer and employee contributions receivable had never historically incurred losses and current conditions and supportable forecasts showed zero risk of nonpayment.

NOTE 1. PLAN DESCRIPTION (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and any Company safe harbor matching contributions, as well as allocations of the additional discretionary employer profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon as well as the Company's matching and additional discretionary employer profit-sharing contribution portion of their accounts plus actual earnings thereon.

Notes Receivable from Participants

Prior to August 1, 2024, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The plan administrator determined what the appropriate interest rate would be at any given time by following procedures that consider interest rates issued by lending institutions under similar circumstances. Principal and interest was paid ratably through payroll deductions or by check. Effective August 1, 2024, no new notes receivable from participants are allowed.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or an annuity. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of these financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE 2.**SUMMARY OF ACCOUNTING POLICIES (CONTINUED)****Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's retirement advisory committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated to participants' accounts and are included in administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Company has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements that would have a material impact on its financial statements. In October 2025, the Plan Sponsor notified the recordkeeper of the Plan Sponsor's intention to terminate the Plan by November 30, 2025. Upon Plan termination, all participants will become fully vested. The Plan Sponsor intends that all Plan assets be distributed from the Plan to the participants as soon as reasonably practicable after the termination date.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Stable Value Collective Trust Fund: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily with no advance notice requirement. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year end.

NOTE 5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments consist of ownership in mutual funds and stable value collective trust fund managed by Ascensus. Ascensus is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in administrative expenses and net appreciation in fair value of investments.

NOTE 6. TAX STATUS

The Non-Standardized Prototype Plan has received a notification letter from the Internal Revenue Service that the Plan has been approved as to the form under Section 401(a). The Plan Trust Agreement has been approved under Section 501(a) of the Internal Revenue Code (IRC). The Prototype Plan received its favorable notification letter from the Internal Revenue Service on June 30, 2020. The Plan has been amended since the favorable notification. The plan administrator believes that the Plan is still designed and is currently being operated in compliance with the applicable requirements of the IRC even after the amendments.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7.**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
