Independent Auditor's Report

To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ingerman Group 401(k) Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit.] The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ingerman Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

(1) DESCRIPTION OF PLAN

The following brief description of the Ingerman Group 401(k) Plan provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Ingerman Management Company, Inc. and its commonly-controlled affiliate, Ingerman Construction Management, (collectively, the "Company"), who are age 18 or older and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Any eligible employee will be considered a "participant" in the Plan.

Contributions

Participants may contribute a percentage of their compensation on a pretax tax or after tax basis, not to exceed the maximum amount allowable under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company has elected a "safe harbor" employer matching formula for the Plan after a 6 month service requirement is met by the participants. As such, employer matching contributions to the Plan are equal to the sum of 100% of participant deferrals up to 3% of compensation plus 50% of participant deferrals that exceed 3% of compensation limited to 5% of the participant's compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their elective contributions and the employer safe harbor matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Subject to certain limitations, each participant may borrow amounts from their account as defined in the Plan. The terms of such loans are determined by the guidelines defined in the Plan, and are in conformance with Internal Revenue Service guidelines. The maximum amount available for borrowing is 50% of the participant's account balance, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with the local prevailing rates. Principal and interest are paid ratably through payroll deductions or electronic funds transfer.

Payment of Benefits

Upon a participant's retirement, death, disability, or termination of employment, the participant's account will be available for distribution as soon as reasonably practical following the termination date. In addition, hardship distributions are permitted if certain criteria are met. The Plan provides that participants may receive in-service distributions of any or all of their account as of the date they attain age 59½.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") as set forth in the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fixed group annuity contract (see Note 5). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

(3) INFORMATION PREPARED AND CERTIFIED BY TRUSTEES

Lincoln Financial Group Trust Company, Inc. was the trustee of the Plan as of and for the year ended December 31, 2024 and Fidelity Management Trust Company was the trustee of the Plan as of and for the year ended December 31, 2023. Effective January 1, 2024, the Plan changed its trustee from Fidelity Management Trust Company to Lincoln Financial Group Trust Company, Inc. and its record keeper from Fidelity Workplace Services, LLC to Lincoln Retirement Services Company, LLC. The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the respective trustees have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

(4) FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurement and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities as of the reporting date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Unobservable inputs that are not corroborated by market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective/Collective Investment Trusts: Valued using the respective Net Asset Value (“NAV”) as reported by such trust funds using the number of units held by the fund. NAV is used as a practical expedient to estimate fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

In accordance with U.S. GAAP, the Plan measures investments at fair value. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023:

(5) FIXED ANNUITY CONTRACT

The Lincoln National Life Insurance Company's grouped fixed annuity contract is a fully benefit-responsive investment contract and is reported at contract value on the statements of net assets available for benefits. Benefit responsiveness is defined as the extent to which a contract's term and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents participant contributions, plus earnings at guaranteed crediting rates, less participant withdrawals. The guaranteed minimum interest rate is 1%.

The fully benefit-responsive investments have certain restrictions. There are no events or circumstances that are probable that would allow Lincoln to terminate the group fixed annuity contract with the Plan and settle at an amount different from contract value.

The fixed annuity contract is a group fixed annuity contract, backed by the creditworthiness of Lincoln National Life Insurance Company, which has no maturity date. Deposits made to this investment contract are deposited in a general account. Lincoln National Life Insurance Company is contractually obligated to repay the principal and a specified crediting interest rate that is guaranteed to the Plan. The crediting interest rate is reviewed on a semi-annual basis for resetting. There are no reserves against contract value for credit risk. Participants may ordinarily direct permitted withdrawals of all or portions of their account at contract value within reasonable time frames. Restrictions apply to the aggregate movement of funds to other investment options.

(6) PARTY-IN-INTEREST TRANSACTIONS

Lincoln Financial Group Trust Company, Inc. is the trustee and Lincoln Retirement Services Company, LLC is the recordkeeper for the Plan for 2024 and Fidelity Management Trust Company was the trustee and Fidelity Workplace Services, LLC was the recordkeeper for the Plan for 2023. Therefore, the services provided to the Plan qualify as party-in-interest transactions. Certain investment advisors provide investment management services to the Plan, which qualify as party-in-interest transactions.

(7) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Under the terms of the Plan, participants are always 100% vested in all employer safe harbor matching and nonelective contributions. Therefore, in the event of Plan termination, participants would remain fully vested in their employer contributions, and Plan termination would not result in any change to their vested status.

(8) TAX STATUS AND COMPLIANCE MATTERS

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. No provision for income taxes has been included in the Plan's financial statements.

FASB ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. No liability for uncertain positions taken or expected to be taken has been recognized in the Plan's financial statements.
