To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Freeman 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.



Notes to Financial Statements

1. Description of Plan

General

Freeman 401(k) Plan (Plan) is a defined contribution and profit sharing plan covering all eligible United States employees of the Freeman Decorating Co. and various participating employers (collectively, Freeman or Company or Employer) who have completed thirty days of service. Some employees may not be eligible due to organized labor agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan administrator adopted a prototype plan administered by Fidelity Management Trust Company (Trustee). The following descriptions provide only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

During October 2024, the Company sold a wholly-owned subsidiary, Convention Data Services, LLC. As a result of this transaction the effected employees' account balances were transferred to Maritz Holdings Inc. Employee's Investment Plan. Net assets transferred out of the Plan totaled \$13,835,080 during the year ended December 31, 2024.

Contributions

Each year, participants may voluntarily contribute up to 75% of their eligible pretax annual compensation, as defined by the Plan. A participant is automatically enrolled and considered to have made a pretax election in an amount equal to 3% of eligible compensation unless he or she elects otherwise. A participant who does not want the automatic pretax deferral equal to 3% of eligible compensation must make an active deferral election with Freeman either specifying some other amount as the pretax election or specifying that the participant does not wish to make any pretax contribution amount. Participants may also make voluntary after-tax contributions. Freeman may make discretionary matching contributions, as determined each year by the Board of Directors of Freeman. For the Plan year ended December 31, 2024, Freeman elected to match 50% of an employee's pretax contribution up to 6% of eligible compensation.

The Plan also offers catch-up contributions to participants who attained age 50 or older before the close of the Plan year. Participants may also make rollover contributions, which represent distributions from other qualified defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) Freeman's contributions (if any) and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant contributions and participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting

Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in the remainder of the account plus earnings thereon is based on years of service. A participant is 100% vested after three years of credited service.

Forfeitures

The Plan provides that forfeitures of terminated participants non-vested account balances may be used first to pay administrative expenses then used to reduce Freeman's contributions. At December 31, 2024 and 2023, \$895,923 and \$393,148 respectively, were available to pay future administrative expenses or to reduce Freeman's future contributions or plan expenses. Forfeitures used during the year ended December 31, 2024 totaled \$418,387.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as determined by the Plan administrator, in effect at the first of the month during which the loan was issued. A participant may have no more than two loans outstanding from the Plan at any time. Loan principal and interest are paid ratably through weekly or semi-monthly payroll deductions.

Termination of the Plan

While the Company has not expressed any intent to do so, it may terminate the Plan at any time. In the event the Plan is terminated, participants would become fully vested in their account balances, and net assets of the Plan would be distributed to participants in accordance with the provisions of the Plan.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive installment payments or a lump-sum payment equal to the value of the participant's account balance. Upon all other terminations of employment, a participant will receive a lump-sum payment equal to the value of the participant's vested account balance. Employees may also take hardship withdrawals on their fully vested account balance. There are also provisions for making withdrawals of pre-tax contributions upon attainment of age 59½ and of profit sharing and matching contributions in an amount based on the number of years of service.

Expenses

Certain administrative expenses are paid by the Plan and thus are a component of the statement of changes in net assets available for benefits included in plan expenses. Loan fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in plan expenses. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared under the accrual method in accordance with GAAP.

Estimates and Assumptions

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities. Actual results could vary from the estimates used in preparing the accompanying financial statements.

Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value, with the exception of the stable value fund noted below. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Plan participants have the option of investing in a stable value fund, which is a separately managed account on behalf of the Plan. The stable value fund purchases synthetic investment contracts (Synthetic GICs) on behalf of the Plan. These investment contracts are recorded at contract value (Note 5). Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Payment of Benefits

Benefits to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

3. Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 Prices or valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Interest-Bearing Cash Account

The interest-bearing cash accounts are stated at fair value based upon quoted market prices reflecting the fund's net asset value (NAV), as determined by their respective trustee. NAV is determined by subtracting expenses, charges, or other liabilities incurred or accrued by the funds from the value of the assets and dividing the result by the number of outstanding shares.

Self-Directed Brokerage Accounts

The self-directed brokerage accounts include investments in a) shares of common stock stated at fair value based upon quoted market prices, b) units of mutual funds stated at fair value based on quoted market prices reflecting the fund's NAV as determined by their respective trustee, c) government bonds, d) the interest-bearing cash accounts. The accounts consist solely of United States currency (cash), which the Trustee reports daily based on the amount of cash on deposit and e) other investments.

Mutual Funds

These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The Plan also holds other assets not measured at fair value on a recurring basis, including employer and participant contributions receivable. The fair value of these assets approximates the carrying amounts in the accompanying financial statements due to the short maturity of the instruments. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments are measured using Level 1 inputs.

4. Financial Information Certified by the Plan's Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by the Trustee and a party-in-interest as defined by ERISA, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

5. Fully Benefit-Responsive Investment Contract

The Plan has invested in a fully benefit-responsive investment contract. The investment contract represents units of various collective trust funds that invest primarily in guaranteed investment contracts or funding agreements, security backed investment contracts, separate accounts issued or wrapped by insurance companies, banks or other financial institutions, with the objective of providing a fixed income yield with minimal market-related risk. The fund may also invest in high quality money market instruments or other similar short-term investments. The fund provides for daily redemptions by the Plan at contract value.

Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Participants in fully benefit-responsive contracts may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan holds a direct interest in such contracts through its investment in a stable value fund. This investment is a fully benefit-responsive fund; however, it does contain several redemption restrictions including deferral of redemption requests resulting from closing or other disruption of financial markets or exchanges and, full or partial Plan administrator directed redemptions or terminations may be delayed for up to 365 days.

6. Tax Status

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has not been amended from the original prototype document, the Adoption Agreement has been amended. Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

7. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included as a reduction of the return earned on each fund. The Trustee provides certain administrative services to the Plan pursuant to an agreement between the Company and the Trustee. The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund or fund service providers exceeds the amount owed under the agreement between the Trustee and the Company, the Trustee remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses.

8. Subsequent Events

Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued and concluded that no additional disclosures are required.
