### Note 1: Description of Plan

The following description of the Raymond Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a profit sharing plan with elective deferral 401(k) features covering employees of the following employers (collectively, the "Employer") who have one year of service and are age 21 or older:

### Note 1: Description of Plan (Continued)

#### Contributions

Each year, participants may contribute up to 80% of pretax annual compensation, as defined in the Plan. Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. The Employer may make discretionary matching and/or nonelective contributions. During 2024, the Employer elected to make a discretionary matching contribution of 25% of the participant deferral amount up to 1% of eligible compensation. There were no discretionary nonelective contributions for the year ended December 31, 2024. Rollovers are not matched. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Employer discretionary matching contributions, as well as allocations of the Employer's discretionary nonelective contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting/Forfeitures

Participants are immediately vested in their deferral contributions and rollover contributions plus actual earnings (losses) thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service (25% per year after the first year of service). All forfeitures of nonvested balances upon termination are used to offset future Employer matching contributions or as an Employer nonelective contribution for the plan year in which the forfeiture occurs. The amounts of unallocated forfeitures at December 31, 2024 and 2023, were \$9,852 and \$5,302, respectively. During the year ended December 31, 2024, \$5,978 of forfeitures were used to to reduce Employer contributions.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service distributions are permitted in the event of financial hardship or attainment of age 59 ½.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Excess Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$30,566 and \$21,873 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025 and distributed the 2023 excess contributions prior to March 15, 2024.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to recordkeeping are charged to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* The OneAmerica Stable Value Fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the common/collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the common/collective trust fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner. Redemptions can occur daily with a one day notice, and there are no unfunded commitments at December 31, 2024 and 2023.

### Note 4: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and non-interest bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the Plan's Trustee.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

OneAmerica Retirement Services LLC is the Plan's third party administrator and recordkeeper. Fees incurred and paid by the Plan for recordkeeping services to OneAmerica were \$66,261 for the year ended December 31, 2024. Certain plan assets are managed by OneAmerica and the Trustee, therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. Fees paid to the auditor of the Plan were \$12,030 for the year ended December 31, 2024.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

### **Note 7: Tax Status**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan Document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
