Opinion

We have audited the accompanying financial statements of Musculoskeletal Institute of Louisiana, APMC Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) **Description of the Plan**

The following description of the Musculoskeletal Institute of Louisiana, APMC (the “Company”) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code of 1986, as amended, which provides retirement, disability and death benefits for eligible employees of the Company who are age twenty-one (21) or older and have attained one (1) year of service, as defined by the Plan. As of the plan year beginning January 1, 2010, the Plan is now operated as a “safe harbor” plan. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan as herein discussed is effective as of January 1, 2022.

Contributions and Allocations

Each year, eligible participants may contribute a percentage of their pretax annual compensation (“eligible compensation” as defined under the Plan), not to exceed maximum annual contribution limits established by the Federal Government. The annual elective deferral limitations for 2024 and 2023 totaled \$23,000 and \$22,500, respectively. In addition, during the year which a participant attains age fifty percent (50%) and in subsequent years, the participant may elect to make additional, pretax “catch up” contributions of up to \$7,500 for the years 2024 and 2023. Participants direct the investment of their contributions into various options offered by the Plan.

The Company may make safe harbor non-elective employer contributions to the Plan. The contributions are calculated at a rate equal to 3% of each eligible participant’s compensation. Participants are fully vested in all safe harbor non-elective employer contributions. During the year ended December 31, 2024, safe harbor non-elective contributions to the Plan totaled \$906,845.

The Company may make non-safe harbor non-elective contributions to the plan. The Company’s non-elective contribution may be determined as a uniform percentage of compensation or as a uniform dollar amount. Participants vest in employer non-safe harbor non-elective contributions according to the vesting schedules contained within these notes. During the year ended December 31, 2024, there were no non-safe harbor non-elective contributions made to the plan.

Rollover contributions are permitted by the Plan. Rollover contributions remain in segregated rollover accounts and are always one hundred percent (100%) vested. Rollover contributions may be withdrawn by the participant at any time.

Voluntary contributions are not permitted by the Plan.

(1) **Description of the Plan (cont.)**

Participant Accounts

Under the Plan, elective deferrals made by participants and any employer contributions are placed into investment accounts, as directed by the participant, which are then credited with gains and losses at each valuation date. Valuation is performed daily. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Under the Plan, participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Participants are vested in the Company's non- safe harbor contribution portion of their accounts plus actual earnings thereon based on years of continuous service. All participants are fully vested after completing at least six (6) years of service.

The vesting schedule for non-safe harbor matching and non-safe harbor non-elective employer contributions (including top-heavy) is as follows:

Completed Years of Service	Percentage Vested
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Participants may not have more than two (2) outstanding loans at a time.

Loans must be secured with an irrevocable pledge and assignment of the participant's vested interest in his or her account. No more than fifty percent (50%) of the balance in the participant's account may be considered by the Plan as security.

Loans bear interest at a reasonable fixed rate established by the Plan Administrator. This rate is set at the U.S. prime lending rate plus two percent (2%) when the loan is made.

Principal and interest is paid ratably as of each payroll withholding period by the participant, typically through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, participants under the normal retirement age of 65 (or early retirement if the participant is 59 1/2 and has completed 5 years of service), the participant receives either a lump sum or installment amount equal to the vested value of his or her account. Participants may, while still employed by the Company, make a withdrawal of all or any part of their account balance, subject to various restrictions as defined in the Plan agreement.

(1) **Description of the Plan (cont.)**

Hardship distributions are permitted by the Plan, provided the participant provides documentation demonstrating the existence of a hardship event, as defined by the Plan.

Forfeited Accounts

Forfeitures are amounts which cannot be paid to terminated participants because they were not one hundred percent (100%) vested upon separation from service with the Company. Forfeitures of Company contributions will be used to pay plan expenses and supplement employer contributions, respectively. The Plan had forfeited non-vested account balances totaling \$8,233 and \$7,384 as of December 31, 2024 and 2023, respectively. During the plan year ended December 31, 2024, the Plan did use \$7,384 of forfeitures to supplement employer contributions.

(2) **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits at the date of the financial statements and the changes in net assets available for Plan benefits during the reporting period and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Net appreciation (depreciation) in the fair value of Plan assets reflected in the Plan's statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income, including interest earned on notes receivable from participants, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses

(2) **Summary of Significant Accounting Policies (cont.)**

has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Loan defaults are considered to have occurred if any scheduled payment remains unpaid as of the end of the last day of the calendar quarter following the calendar quarter in which the required payment was due.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Although not required, the Company, as Plan Sponsor, may pay the related costs of administering the Plan. Expenses paid by the Company on behalf of the Plan are not reflected in the financial statements of the Plan.

(3) **Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are describes as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation

techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Insured savings accounts and money market funds

Balances in cash, certificates of deposit, and money market accounts are valued at their ending account balance, which equals fair value and are, therefore, classified in Level 1 of the fair value hierarchy.

Mutual funds

Mutual funds are registered investment company shares that invest principally in equity securities, fixed income instruments, and short-term instruments in accordance with each fund's investment objectives. Plan holdings are generally valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual fund fair values are based on quoted prices and are, therefore, classified in Level 1 of the fair value hierarchy.

Self-Directed Brokerage Accounts

Consists of cash and money market accounts valued at cost which approximates fair value, common and preferred stocks valued at current market prices, and mutual funds and exchange traded funds valued at NAV of shares held at year end. The mutual and exchange traded funds held in these accounts are deemed to be actively traded. These investments are categorized in Level 1 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) **Transactions with Parties in Interest**

For the year ended December 31, 2024, certain Plan investments included deposits into interest bearing cash accounts managed by Morgan Stanley, Raymond James, Vanguard, Royal Alliance, and Fidelity Investments. All are custodians of Plan assets and qualify as parties in interest.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

Additionally, Musculoskeletal Institute of Louisiana, APMC, the Plan sponsor, provides certain accounting and administrative services for which no fees are charged.

(5) **Plan Amendment or Termination**

The Company has reserved the right to terminate the plan or reduce or cease contributions at its discretion or to amend the plan at any time and in any respect. However, no amendment can reduce benefits already earned by the participants. In the event of termination, participants are entitled to the full amount in their account as of the date of termination, regardless of the percent vested at the time of termination.

(6) **Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving recognition of exempt status, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would

not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

(8) Subsequent Events

The Plan Administrator has evaluated all events or transactions that occurred after December 31, 2024 through October 14, 2025, which is the date the financial statements were available to be issued. There were no other material subsequent events requiring disclosure.
