Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan:

The following description of Soros Fund Management LLC Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all eligible employees of Soros Fund Management LLC (the "Company"). Eligible employees can participate in the Plan upon employment with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan adopted the Fidelity Volume Submitter Defined Contribution Plan (the "Fidelity Plan"). The Retirement Committee is responsible for oversight of the Plan. The Retirement Committee also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions:

Each year participants may contribute out of pretax annual compensation up to an amount allowable by Section 401(k) of the Internal Revenue Code. Effective June 1, 2023, the Plan adopted a Roth 401(k) feature where participants may contribute after-tax annual compensation up to an amount allowable by Section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing certain distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct their contributions into various investment options offered by the Plan.

Each year, the Company will make a Safe Harbor contribution in an amount equal to 3% of eligible participant compensation. The Company may also contribute to the Plan an amount determined by the Company in its sole discretion related to profit sharing. Additionally, each year, the Company may contribute to the Plan discretionary matching contributions equal to a percentage of eligible participant elective contribution deferrals which shall be determined based upon formulas determined by the Company. Company discretionary contributions for each Plan year are allocated among participants who do not exceed a predetermined threshold for total compensation for that year and who have been in service with the Company for a minimum of 1,000 hours and are either in service on the last day of the Plan year or have terminated service prior to the last day of the Plan year due to retirement, death or disability. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

At times, it may be necessary for the Company to make corrective contributions to the Plan to correct participant account balances. There were no corrective contributions to the Plan for the years ended December 31, 2024 and 2023.

Participant accounts:

Each participant's account is certified with the participant's contributions, an allocation of the Company's Safe Harbor contribution, the Company's profit sharing contribution (if applicable), the Company's matching contribution (if applicable) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the applicable Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions and employer Safe Harbor contributions plus actual earnings thereon. Effective for participants who complete an hour of service on or after July 1, 2011, Company profit sharing and matching contributions and earnings thereon will vest over four years, at a rate of 25% per year of continuous service. For all other participants, vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. These participants become 100% vested after six years of credited service. All participants become 100% vested if they are employed by the Company on or after their retirement age, or on the date their employment is terminated by death or disability.

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The Plan administrator determined the interest rate to be used for participant loans to be the prime lending rate plus 1% and directs Fidelity Management Trust Company ("Fidelity") to monitor the interest rate charged by the Plan. Principal and interest are paid ratably through semi-monthly payroll deductions and reinvested per the participant's current investment elections.

Payments of benefits:

On termination of the service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments not to exceed the participant's life expectancy or the joint and last survivor's life expectancy. A participant may also elect to defer receipt of his or her account balance if the vested account balance is greater than \$5,000.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$145,276 and \$129,507, respectively. These accounts will be used first to reduce Plan administrative expenses and then used to reduce employer contributions. Also in 2024, administrative expenses were reduced by \$35,386 from forfeited nonvested accounts and Company contributions were reduced by \$179,693 from forfeited nonvested accounts.

Note 2 - Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the Company are recorded in the year in which the participants' compensation is earned.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Operating expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Note 4 - Related-party transactions and party-in-interest transactions:

Certain Plan Investments are managed by Fidelity. Fidelity is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 - Income tax status:

The IRS has determined and informed Fidelity by a letter dated June 30, 2020, that the Fidelity Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and

that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Certified investments:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity, the trustee of the Plan.

Note 9 - Nonexempt transactions:

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024.
