Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Oerlikon USA 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

Basis for Opinion on the 2024 Financial Statements

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following brief description of the Oerlikon USA 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and was adopted by Oerlikon USA Holding, Inc. (the Company) effective July 1, 2014, and restated on January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following related employers were also participating employers in the Plan during 2024: Oerlikon AM US Inc., Oerlikon Balzers, USA, Inc., Oerlikon Friction Systems, Oerlikon Metco (US) Inc., and Oerlikon Textile Inc.

Eligibility

All active employees of the Company, excluding union employees, leased employees, residents of Puerto Rico, and non-resident aliens with no income from a U.S. source, are eligible to participate in the Plan upon hire date. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan.

Contributions

Eligible employees may elect to contribute, on a pretax basis or after-tax basis (Roth), up to 90% of their eligible compensation to the Plan, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible Participants are permitted to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan began operating under a qualified automatic contribution arrangement (QACA) in which eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled Participants have their deferral rate set at 6% with automatic annual increases equal to 1%, not to exceed a total of 15% of eligible compensation. Participants have the ability to opt out of automatic enrollments and automatic increases. The Company provides a QACA safe harbor matching contribution equal to 100% of the first 4% of the Participant's eligible compensation contributed to the Plan. Prior to this change, the Plan operated under a standard automatic enrollment arrangement and offered a safe harbor match, but it did not qualify as a QACA.

The Company may also make discretionary non-elective contributions. The Participant must be employed as of the last day of the Plan year and have 6 months of service to be eligible for any non-elective contributions that may be made for that Plan year. There were discretionary non-elective contributions of \$774,786 during the year ended December 31, 2024.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, rollovers, Company match, the Company's discretionary contributions, and earnings (losses) on the investments in their account. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

1. Description of the Plan (cont.)

Notes Receivable from Participants

A Participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A Participant may have only one loan outstanding at any time. Loans are repayable through weekly payroll deductions. Loans are secured by the balance in the Participant's account and bear interest at 1% plus the prime interest rate. Interest on all outstanding range from 4.25% to 9.50%. Loans must be repaid within 5 years unless used for the purchase of a primary residence, in which case the Plan administrator may permit a longer repayment term up to 10 years.

Payment of Benefits

A Participant becomes eligible for benefits at the normal retirement date (age 65), at early retirement date (age 55), upon termination from the Company, or at the date the Participant dies or becomes totally disabled. If a terminated Participant's balance vested balance is less than or equal to \$7,000, the amounts may be automatically distributed in the form of a rollover to an individual retirement account designated by the Company. In addition, a Participant is eligible to receive distributions without termination of employment upon attainment of age 59½ without penalty. A Participant may elect to receive the benefits either as a lump sum distribution, installment payments over a specified period of time, a direct rollover distribution, annuities, or withdrawals in the event of a financial hardship.

Vesting

Participants are immediately vested in their elective deferral contributions, and Company safe harbor matching contributions. Participants hired before January 1, 2024 are immediately vested in their QACA safe harbor matching contributions. The Participants become 100% vested in the discretionary non-elective contributions and QACA safe harbor matching contributions after 2 years of service. Participants who are members of certain classes, may receive different vesting schedules for specified contributions.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$78,408 and \$12,917, respectively. Forfeited balances of terminated Participants' non-vested accounts are used to reduce future Company contributions and to offset Plan expenses. During the year ended December 31, 2024, \$98 of forfeited funds were used to reduce Plan expenses.

Plan Expenses

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan administrator. These expenses may include, but are not limited to, legal fees, accounting fees, recordkeeping fees, investment-related expenses and other fees for services provided to the Plan.

The Plan participates in a revenue credit program. Income from the revenue credit program can be used to pay Plan administrative expenses or reallocated to Participants. The revenue credit program account balance was \$38,001 and \$95,947 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, revenue credits were used to offset Plan expenses in the amount of \$108,596.

2. Summary of Significant Accounting Policies (cont.)

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are stated at fair value, with the exception of fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement of that portion of net assets available for benefits because contract value is the amount Participants normally would receive if they initiate permitted transactions under the terms of the Plan.

Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). See Note 5 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan Participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company (Fidelity), the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from Participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from Participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fully Benefit-Responsive Investment Contracts (FBRIC)

The Plan holds a Principal Life Insurance Group Annuity Contract that is fully benefit-responsive. Principal Life Insurance is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by Principal Life Insurance Company. Principal Life Insurance provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts between 0.15% and 3%) and the potential for additional interest if declared by Principal. Additional interest, when declared, remains in effect for the declaration year, which begins each August 1. Additional interest is not guaranteed for future years. Contributions to a Participant's account in the Principal Life Insurance Group Annuity Contract are annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan.

The contracts meet the FBRIC criteria and therefore are reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by Participants if they were to initiate permitted transactions under the terms of the Plan. Contract values, as reported to the Plan by Principal, represent the accumulated cash contributions, interest credited to the Plan's contracts and transfers, if any, less any withdrawals and transfers, if any. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA; or (5) premature termination of the contract. In addition, certain events allow the issuer to terminate the contact with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the Participants.

5. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts - Valued at NAV per unit, at year-end. The NAV is used as the practical expedient to estimate fair value.

Common stocks - Common stocks held in the self-directed brokerage account are valued at the closing price reported on the active market on which the individual securities are traded.

Money market funds - Money market mutual funds held in the self-directed brokerage account are valued using the amortized cost method of valuation or penny-rounding method of pricing as permitted by Rule 2a-7 under the Investment Company Act of 1940, as amended, which approximates their fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by FMR LLC. The Internal Revenue Service (IRS) has opined and informed FMR LLC by a letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become 100% vested in their accounts.

8. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Certain plan investments are managed by Fidelity Investments, a Company related to Fidelity; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from Participants are defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Various administrative expenses of the Plan are paid directly by the Company.

9. Risks, Uncertainties, and Concentrations

The Plan's investments include mutual funds, a fixed annuity contract, and a common collective trust which invest in various types of common and other stock and debt instruments of various companies within various markets, including foreign markets. Investment securities are exposed to various risks, such as interest rate, market and credit risk. The fair value of investment securities fluctuates, and it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect Participant account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, 23% of the Plan's investments were invested in the Fidelity Investments, Growth Company Fund Class K6.

10. Delinquent Participant Contributions

During 2024, employee withholdings of \$63 were not remitted within the appropriate time period by the Company. These transactions constituted prohibited transactions as defined by ERISA. The Plan sponsor remitted these contributions to the Plan in 2024 and plans to remit lost earnings in 2025.

11. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

12. Subsequent Events

The Company has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
