1. Description of Plan

The following description of Synergic Healthcare Solutions, LLC 401(k) Profit Sharing Plan & Trust (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective September 1, 2009 and was subsequently amended to change the Plan name to Synergic Healthcare Solutions, LLC 401(k) Profit Sharing Plan & Trust and comply with various Internal Revenue Service (IRS) requirements and incorporate previous amendments. The Plan covers all employees of Synergic Healthcare Solutions, LLC, (the "Company" and "Employer") who have met certain eligibility requirements.

Effective January 1, 2023, the Plan was amended to eliminate the service requirements for participants to share in the allocation of profit sharing contributions.

Effective January 1, 2024 the Plan was amended and restated to make changes to Safe Harbor contribution provisions. Under the amended and restated Plan, the Company will make a Safe Harbor matching contribution equal to 100% of the matched employee contributions that are not in excess of 3% of the Plan compensation, plus 50% of the amount of the matched employee contributions that exceed 3% of the Plan compensation but that do not exceed 5% of the Plan compensation.

Eligibility

Employees of the Company who have attained age twenty-one and completed two months of service are eligible to participate in the Plan for purposes of making elective deferral contributions. Employees of the Company who have attained age twenty-one and completed 1,000 hours of service in a twelve consecutive month period are eligible to participate in the Plan for purposes of receiving Safe Harbor contributions and profit sharing contributions.

Contributions

After enrollment in the Plan, participants may elect to contribute up to 100% of their annual compensation as pre-tax or after-tax Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover contributions from another qualified plan or individual retirement account. Participants direct the investment of their contributions among various investment options offered by the Plan.

For 2023, the Company made Safe Harbor contributions not less than 3% of participant's compensation. Effective January 1, 2024, the Company will make Safe Harbor contributions equal to 100% of the matched employee contributions that are not in excess of 3% of the Plan compensation, plus 50% of the amount of the matched employee contributions that exceed 3% of the Plan compensation but do not exceed 5% of the Plan compensation. The Company made Safe Harbor contributions totaling \$146,541 and \$278,859 for 2024 and 2023, respectively. The Company also may make profit sharing contributions. There is no service requirement for a participant to share in the allocation of profit sharing contributions. There were no profit sharing contributions made in 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions, as well as investment earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, equally among participants or to specific participants for transactions specifically incurred by them. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contributions and the employer Safe Harbor contribution portion of their account plus actual earnings thereon and, if applicable, any amounts "rolled over" into their account. Vesting of the employer profit sharing contributions and earnings thereon is based on the participant's period of service with the Company. Participant's vest 20% per year beginning in the second year of service and are fully vested after six years. Participants who attain normal retirement age while employed or incur severance of employment as a result of death or disability become 100% vested.

Forfeitures

Forfeitures will be used to reduce future employer contributions or pay administrative expenses. There was no balance of forfeited non-vested accounts at December 31, 2024 and 2023.

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 minus the highest outstanding loan balance in the last twelve months or one-half of the present value of the vested account balance at the time of loan request. Loans must be for a minimum of \$1,000 and are limited to one loan per participant at a time. Loans to participants are secured by the participant's vested account balance. Interest rates are based on the Prime Rate at the time of the loan was created. Loans must be repaid within five years.

A participant's loan will be in default if not repaid in accordance with the repayment schedule and becomes payable in full upon termination of employment. Upon default, the entire balance will be reclassified as a distribution. An allowance for credit losses was not necessary at December 31, 2024 and 2023.

Payment of Benefits

Participants are eligible to receive a distribution upon termination of service, retirement, disability or death. Distributions will be made in one lump sum payment in cash or rolled over into an IRA account or another qualified plan or in annual or more frequent installments under a continuous right of withdrawal. Participants' account balances between \$1,000 and \$5,000, upon termination, will be rolled-over to an IRA if an election for distribution is not made by the participant. Participants with account balances less than \$1,000 are subject to involuntary cash-out upon termination of service. The Plan also allows in-service distributions from fully vested account balances for participants age 59½ or older. Hardship distributions for immediate and heavy financial need are not allowed for this Plan.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Company personnel provided administrative services to the Plan at no charge in 2024 and 2023. Administrative expenses include fees related to the administration of notes receivable from participants and withdrawals charged directly to the participant's account and certain investment advisory and recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value as reported to the Plan and certified by John Hancock Life Insurance Company (U.S.A.) (John Hancock). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest is recorded on an accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Contributions

Employee contributions are accrued when wages are paid. Employer contributions are accrued as of the end of the Plan year based on Plan compensation for the Plan year.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities, will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

3. Investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, a qualified institution.

While under the terms of the Group Annuity Contract with John Hancock, John Hancock reserves the right to impose redemption fees and restrictions for transfers from the pooled separate accounts. Specifically, participants are restricted to two transfers between investment options during a calendar month. Once this limit is met, a participant may transfer their full account balance to a money market or stable value fund and then would be restricted from making any further transfers for 30 days. In addition, John Hancock may impose other trading restrictions as they determine necessary such as: restricting the number of transfers in a specified time period, restricting the dollar amount of a transfer, restricting the method used to submit a transfer, restricting transfers into and out of certain investment options or applying redemption fees or other trading restrictions as requested by the underlying fund manager. John Hancock may also charge a termination fee at contract termination.

4. Fair Value Measurements

GAAP provides a framework for measuring fair value and has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other than publicly quoted prices that are observable, either directly or indirectly, and Level 3 inputs consist of unobservable inputs and has the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The level is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- **Pooled Separate Accounts:** As a practical expedient, the net asset value of the units of the separate account is the basis for measuring fair value. The pooled separate accounts invest in mutual funds or exchange traded funds. The fair values of the underlying fund investment are based on publicly quoted prices and are used in determining the net asset values of the pooled separate accounts.

In accordance with Financial Accounting Standards Board, Accounting Standards Codification 820-10, investments that were measured at net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

5. Tax Status

Effective January 1, 2022, the Plan adopted the CCH Incorporated, DBA FTWilliam.com Non-Standardized Pre-Approved Plan. The pre-approved plan obtained an opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

5. Tax Status (continued)

In order to maintain a qualified cash deferred arrangement under the IRS regulations, the Plan must satisfy the 401(k) non-discrimination requirements each year, which limit the percentage of compensation that can be contributed by highly compensated employees, as defined in the code, relative to the percentage of compensation contributed by non-highly compensated employees. The non-discrimination requirements were satisfied for both 2024 and 2023.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

7. Related Party and Party-In-Interest Transactions

The Plan has investments consisting of pooled separate accounts totaling \$4,411,593 and \$3,610,104 as of December 31, 2024 and 2023, respectively, which were managed by John Hancock. John Hancock is the trustee; therefore, these transactions qualify as party-in-interest.

Under the group annuity contract with John Hancock, John Hancock performs certain administrative and recordkeeping services. John Hancock receives revenue from the underlying mutual funds, trust or Exchange Traded Funds (underlying funds) and other fund-related sources. Such revenue received from the underlying funds is used to offset administrative and recordkeeping service fees.

John Hancock administrative and recordkeeping service fees of \$38,489 and \$21,896 for 2024 and 2023, respectively, are included in administrative expenses. Management fees related to the underlying funds are charged against the pooled separate accounts and are reflected in the return on investment.

The Plan also paid third party administration service fees of \$4,124 and \$6,612 for 2024 and 2023, respectively, and paid third party broker commissions of \$16,067 and \$1,136 for 2024 and 2023, respectively.

The Company also paid certain administrative expenses of the Plan.

8. Subsequent Event
