Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of StreamSets, Inc. Retirement Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. DECEMBER 31, 2024

NOTE 1: DESCRIPTION OF PLAN

The following description of the StreamSets, Inc. Retirement Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering eligible classes of employees of StreamSets, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan entry is on the date employees become eligible.

Eligibility - An eligible employee is any employee of the Company, excluding union employees, leased employees, and non-resident aliens. Employees are eligible to participate in the Plan immediately.

Contributions - Each year, participants may contribute up to 100% of pretax annual eligible compensation, as defined in the Plan. Participants may designate all or a portion of their elective deferral contributions as Roth elective contributions. A Roth contribution is defined as being made in lieu of all or a portion of the pretax elective deferral the participant is otherwise eligible to make under the Plan and treated by the employer as includible in the participant’s income. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan, including a well-diversified selection of registered investment companies and a broad range of investments through a self-directed brokerage window. Prior to January 1, 2024, the Company contributed a Safe Harbor match contribution equal to 100% of the participant’s deferrals that do not exceed 3% of compensation plus 50% of deferrals between 3% and 5% of compensation. Additionally, the Company may contribute, at its discretion, an additional matching contribution and/or profit-sharing contribution to the Plan. To be eligible to receive the discretionary profit-sharing contribution, participants must be employed on the last day of the plan year. For the year ended December 31, 2024, the Company contributed a discretionary matching contribution equal to 100% of the participant’s deferrals that do not exceed 3% of compensation plus 50% of deferrals between 3% and 5% of compensation. There were no discretionary profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and plan earnings, as well as charged with an allocation of administrative expenses that are paid by the Plan. Certain administrative expenses are netted against the earnings of the investment alternatives held by the participants. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions and the Company’s contributions, plus actual earnings thereon.

NOTE 1: DESCRIPTION OF PLAN - CONTINUED

Forfeitures - As of December 31, 2024 and 2023, the forfeiture account balance was \$0 and \$4,508, respectively. Forfeitures may be used to restore previously forfeited account balances, reduce Company contributions or to pay plan expenses. During 2024 and 2023, no forfeitures were used to reduce employer match contributions or administrative expenses.

Notes Receivable from Participants - Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance in the previous 12 months, or 50% of their vested account balance. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The interest rate is based on the prevailing rates available for similar loans. As of December 31, 2024, interest rate for outstanding loans was between 5.25% and 10.50%. Principal and interest are paid ratably through biweekly payroll deductions. A participant may have one loans outstanding at any time.

Payment of Benefits - Upon termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive all or any portion of their eligible account balance paid in a direct rollover to an individual retirement account or another eligible retirement plan or paid directly to the participant in a lump sum or partial payments. After separation of service, a participant may delay withdrawal until a future date, but the third-party administrator will automatically distribute balances of terminated participants that do not exceed \$5,000. If a participant's account balance is between \$1,001 and \$5,000, the plan administrator will automatically distribute the balance in a direct rollover to an IRA. Participant account balances that do not exceed \$1,000 will be distributed directly to the participant. A participant who has reached age 59½ may elect to withdraw all or a portion of his or her entire account while still employed. A participant can request a distribution of their rollover balance at any time.

As required under Section 401(a)(9) of the Internal Revenue Code (IRC), a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 73, or (ii) the year in which the participant retires.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the modified cash basis of accounting. Under the modified cash basis of accounting, certain income and expenses are recorded when received rather than when earned or incurred.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance, plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan agreement.

Contributions - Contributions are recorded when deposited.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from participants' accounts and other related expenses are charged directly to the participant's account and are included in administrative expenses. Certain administrative expenses of the Plan are netted against the investment earnings for the participant-directed investments.

Subsequent Events - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. Management has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Brokerage Accounts - Investments held in brokerage accounts are valued using quoted market prices at year end, when available. When quoted market prices do not exist, investments are valued using quoted prices for similar securities and valuations provided by alternative pricing sources supported by observable inputs.

Registered Investment Companies (Mutual Funds) - Mutual Funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has not considered normal plan operations such as participant and employer contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure. Fees for professional services rendered by all parties in interest were partially absorbed by the plan sponsor. Participant loan origination fees and disbursement fees are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

Effective August 26, 2024, the Company resolved to merge the Plan with and into the IBM 401(k) Plan. All assets were distributed from the Plan on December 6, 2024.

NOTE 7: TAX STATUS

The underlying prototype non-standardized profit-sharing plan with Cash or Deferred Arrangement has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan and related trust were designed in accordance with applicable sections of the IRC.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's Federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it was filed.

Because of the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

In the normal course of business, there may be commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the Company, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

Effective January 1, 2024, the Plan was restated to remove the Company's safe harbor match contribution.

NOTE 1: DESCRIPTION OF PLAN

The following description of the StreamSets, Inc. Retirement Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering eligible classes of employees of StreamSets, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan entry is on the date employees become eligible.

Eligibility - An eligible employee is any employee of the Company, excluding union employees, leased employees, and non-resident aliens. Employees are eligible to participate in the Plan immediately.

Contributions - Each year, participants may contribute up to 100% of pretax annual eligible compensation, as defined in the Plan. Participants may designate all or a portion of their elective deferral contributions as Roth elective contributions. A Roth contribution is defined as being made in lieu of all or a portion of the pretax elective deferral the participant is otherwise eligible to make under the Plan and treated by the employer as includible in the participant’s income. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan, including a well-diversified selection of registered investment companies and a broad range of investments through a self-directed brokerage window. Prior to January 1, 2024, the Company contributed a Safe Harbor match contribution equal to 100% of the participant’s deferrals that do not exceed 3% of compensation plus 50% of deferrals between 3% and 5% of compensation. Additionally, the Company may contribute, at its discretion, an additional matching contribution and/or profit-sharing contribution to the Plan. To be eligible to receive the discretionary profit-sharing contribution, participants must be employed on the last day of the plan year. For the year ended December 31, 2024, the Company contributed a discretionary matching contribution equal to 100% of the participant’s deferrals that do not exceed 3% of compensation plus 50% of deferrals between 3% and 5% of compensation. There were no discretionary profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

After separation of service, a participant may delay withdrawal until a future date, but the third-party administrator will automatically distribute balances of terminated participants that do not exceed \$5,000. If a participant's account balance is between \$1,001 and \$5,000, the plan administrator will automatically distribute the balance in a direct rollover to an IRA. Participant account balances that do not exceed \$1,000 will be distributed directly to the participant. A participant who has reached age 59½ may elect to withdraw all or a portion of his or her entire account while still employed. A participant can request a distribution of their rollover balance at any time.

As required under Section 401(a)(9) of the Internal Revenue Code (IRC), a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 73, or (ii) the year in which the participant retires.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the modified cash basis of accounting. Under the modified cash basis of accounting, certain income and expenses are recorded when received rather than when earned or incurred.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance, plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan agreement.

Contributions - Contributions are recorded when deposited.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from participants' accounts and other related expenses are charged directly to the participant's account and are included in administrative expenses. Certain administrative expenses of the Plan are netted against the investment earnings for the participant-directed investments.

Subsequent Events - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. Management has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Brokerage Accounts - Investments held in brokerage accounts are valued using quoted market prices at year end, when available. When quoted market prices do not exist, investments are valued using quoted prices for similar securities and valuations provided by alternative pricing sources supported by observable inputs.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

Registered Investment Companies (Mutual Funds) - Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has not considered normal plan operations such as participant and employer contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure. Fees for professional services rendered by all parties in interest were partially absorbed by the plan sponsor. Participant loan origination fees and disbursement fees are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

Effective August 26, 2024, the Company resolved to merge the Plan with and into the IBM 401(k) Plan. All assets were distributed from the Plan on December 6, 2024.

NOTE 7: TAX STATUS

The underlying prototype non-standardized profit-sharing plan with Cash or Deferred Arrangement has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan and related trust were designed in accordance with applicable sections of the IRC.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's Federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it was filed.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in shares of registered investment companies and various investments in self-directed brokerage account. These investments are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9: COMMITMENTS AND CONTINGENCIES

In the normal course of business, there may be commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the Company, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

NOTE 10: PLAN AMENDMENTS

Effective January 1, 2024, the Plan was restated to remove the Company's safe harbor match contribution.

Effective August 26, 2024, the Company resolved to merge the Plan with and into the IBM 401(k) Plan. All assets were distributed from the Plan on December 6, 2024.
