Note 1. Description of Plan

The following description provides only general information. Participants should refer to the plan agreement for more detailed descriptions of the Plan's provisions.

As of January 31, 2024 the plan name was formally changed from Driessen Water, Inc. 401(K) Plan to Culligan Ultrapure, Inc. 401(k) Plan (Plan). On this date, the plan sponsor was changed from Driessen Water, Inc. (EIN: 41-0849770) to Culligan Ultrapure, Inc. (EIN: 93-4378003).

During 2024, the Employer's Board of Directors approved the merger of the Plan into the Culligan Safe Harbor Retirement Savings Plan effective June 30, 2024. See Note 9.

General and Eligibility

The Plan is a defined contribution plan established on January 1, 1992, and amended and restated most recently on March 11, 2022, to comply with tax legislation. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Hand Benefits & Trust Company is the trustee, custodian and record keeper to the Plan.

The Plan covers all employees of Driessen Water, Inc. and Ultrapure & Industrial Services, LLC (collectively, Employer) who have completed the specified age and service requirements. Employees are eligible to participate in the Plan upon completing one month of service and attaining age 21. An employee meeting the age and service requirements may enter the Plan on the first day of each month after eligibility requirements have been met. The Plan excludes nonresident aliens with no U.S. source income, reclassified employees, and leased employees.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has elected to be a safe harbor plan. The Employer safe harbor matching contribution provision is 100% of the participants' deferrals that do not exceed 1% of the participants' compensation and 50% of the participants' deferrals between 1% and 6% of the participants' compensation. Each year, at its discretion, the Employer may also authorize a discretionary nonelective contribution. There were no Employer discretionary nonelective contributions for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into the various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon.

Vesting in the Company's safe harbor matching and discretionary nonelective portion of their accounts, plus actual earnings thereon, is based on years of service.

Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 up to 50% of their total vested account balance, not to exceed \$50,000, reduced by the highest outstanding loan balance during the preceding twelve months. The loans are secured by the vested balance in the participant's account and bear interest of 2% above the prime rate, which is determined daily based on *The Wall Street Journal*. On December 31, 2024, interest rates on outstanding loans ranged from 5.25% to 10.50%. General purpose loans are repayable over a maximum of five years and principal residence loans are repayable over a maximum of fifteen years. The number of loans that may be outstanding from the Plan to a single participant at any one time is limited to one.

Payment of Benefits

Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive the value of the vested interest in their account in the form of a lump-sum distribution. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. Participants may also receive an in-service distribution upon attaining age 59½, disability, or in the event of hardship, subject to Plan provisions.

Forfeited Accounts

At June 30, 2024 and December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0, \$87,039 and \$42,720, respectively. Forfeitures are used to reduce the amount of Employer matching contributions made during the year, or to pay Plan expenses. No forfeitures were used to reduce Employer matching contributions or pay Plan expenses during the years ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Plan investments are reported at fair value. Shares of registered investment companies determined by obtaining the quoted price on nationally recognized securities exchanges. The common or collective trust fund is valued at NAV of the units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Certain investment management fees are presented in the net depreciation in fair value of investments.

Plan Expenses

Administrative expenses of the Plan are paid by the Company to the extent not paid with the Plan's assets.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Note 3. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. On June 30, 2024, the Plan merged into the Culligan Safe Harbor Retirement Savings Plan and the Culligan of Byron 401(K) Plan and all assets were transferred. See Note 9.

Note 4. Tax Status

The Plan operates under a non-standardized pre-approved profit-sharing plan CODA agreement sponsored by Benefits Plans Administrative Services, LLC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 20, 2020, from the Internal Revenue Service stating that the non-standardized plan constitutes a qualified plan under Section 401 of the Internal Revenue Code. Although the Plan has been amended since

receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Information Certified by the Plan's Trustee and Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Hand Benefits & Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and December 31, 2023 and 2022
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended June 30, 2024 and for the year ended December 31, 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and supplemental schedule.

Note 6. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in methodologies used at December 31, 2023 and 2022.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The common or collective trust fund is valued at NAV of the units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Party-in-Interest Transactions

Administrative expenses paid by the Plan of \$32,351 and \$69,500 during 2024 and 2023, respectively, for legal, accounting and other professional services are primarily rendered by parties-in-interest. The Company provides certain administrative services at no cost to the Plan.

Note 8. Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Plan Merger

On June 30, 2024, assets of \$12,737,850 and \$698,761 were merged into the Culligan Safe Harbor Retirement Savings Plan and the Culligan of Byron 401(K) Plan, respectively.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
