## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Entisys Solutions, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### ***Basis for Opinion***

### Note 1 - Description of plan

#### General

Effective January 1, 1999, Entisys Solutions, Inc. (the "Company", "Plan Administrator", and "Plan Sponsor") has adopted a non-standardized pre-approved defined contribution plan covering all eligible employees of the Company who are over the age of 18. The Plan was restated on September 1, 2021.

This description of the Entisys Solutions, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Company has appointed the Chief Operating Officer as the Plan Trustee and the Manager of Human Resources to manage the operations and administration of the Plan. The Company has contracted with Empower Trust Company LLC and Empower Annuity Insurance Company of America (collectively referred to as "Empower") to act as the Plan custodian, as well as the third-party administrator to process and maintain the records of participant data and monitor compliance with governmental regulatory requirements.

#### Contributions

Each year, participants may elect to defer up to 100% of their pre-tax annual compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan Document permits Roth 401(k) contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds, common/collective trust funds, pooled separate accounts, and stable value investment funds to its participants. The Company is allowed to make discretionary matching contributions as defined in the Plan Document and currently matches 100% of employee contributions up to \$2,000 annually. The Company's discretionary matching contribution, net of forfeitures, was \$249,956 and \$240,434 for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions is based on years of continuous service. A participant is 100% vested upon the completion of six years of credited service.

#### Notes receivable from participants

A participant may only have one loan outstanding at any time. Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. For loans qualifying under the Coronavirus Aid, Relief, and Economic Security Act, the dollar limit is \$100,000 or 100% of the participant's account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rate for loans outstanding as of December 31, 2024 ranged from 4.25% to 9.5%, which is commensurate with local prevailing rates as determined by the Plan Sponsor. Loan terms typically range up to five years, or may exceed five years for the purchase of a primary residence. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$5,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. Effective April 1, 2024, this limit was increased to \$7,000.

Vested balances of \$1,000 or less will be distributed as a lump-sum amount without the participant's consent.

#### Forfeited accounts

Forfeited non-vested accounts may first be used to pay Plan administrative expenses and any remaining amount may be used to reduce future employer contributions under the Plan. Forfeitures used to reduce employer contributions for the years ended December 2024 and 2023 were \$55,220 and \$71,179, respectively. Forfeited non-vested accounts were not significant to the financial statements at December 31, 2024 and 2023.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates. Significant estimates used in preparing these financial statements include the fair value of investments in mutual funds, common/collective trust funds, pooled separate accounts, and stable value investment funds.

### Note 2 - Summary of accounting policies (continued)

#### Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

The Plan's investment in stable value funds represents an indirect investment in fully-benefit responsive investment contracts, which is reported at fair value without presenting the adjustment to contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Monthly and quarterly asset-based fees, fees related to administration of notes receivable, and participant withdrawals are charged directly to the participants' accounts and amounted to \$96,173 and \$36,961 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund and are charged to participant accounts.

#### Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

The Plan's investments in mutual funds, common/collective trust funds, and pooled separate accounts (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,007,831 and \$2,800,506 during 2024 and 2023, respectively.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value of the Mass Mutual Guaranteed Interest Account and Empower Investments Fixed Account, stable value investment funds, are stated at the liquidation value, based on an actuarial formula as defined under the terms of the contract. The fund invests primarily in bonds, mortgage loans, and short-term investments and cash.

The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The underlying securities are comprised of stocks, mutual funds, and a variety of separate accounts, several of which have observable Level 1 inputs.

### Note 5 - Rollover contributions

During 2024, rollover contributions of \$612,913 from other plans came from six active participants. During 2023, rollover contributions of \$680,518 from other plans came from eight active participants.

### Note 6 - Related party transactions and party-in-interest transactions

Plan investments in mutual funds, common/collective trust funds, pooled separate accounts, and stable value investment funds were managed by Empower for the years ended December 31, 2024 and 2023. Empower is the custodian and the third-party administrator, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor and the Plan participants to the various parties-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of parties-in-interest transactions under ERISA.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 8 - Tax status

The Internal Revenue Service has determined and informed Empower by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Committee and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Company is currently in the process of determining the full extent of errors described in **Note 11 - Plan compliance matters**. The Company does not expect these inconsistencies to affect the Plan's tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 10 - Reconciliation of the financial statements to Form 5500

### **Note 11 - Plan compliance matters**

During the years ended December 31, 2024, 2023 and 2022, it was discovered that the definition of eligible compensation was not consistently applied in calculating employee deferral and employer matching contributions for a few employees. During the year ended December 31, 2023, it was discovered that the vested portion of the Company's discretionary matching portion for a participant distribution was incorrectly calculated. Plan management is currently working with Empower to calculate the full extent of these errors. The impact of these errors will be recognized in the period the corrective action is funded by the Company.
