Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the BPM Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BPM Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 of the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the BPM Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering the employees of BPM, LLP (Employer) and was established December 31, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the 2023 Plan year, two companies merged with the Employer. The Plan was amended on January 1, 2023 and on August 1, 2023 to allow credit to employees for eligibility, vesting, and contribution allocations based on their prior service at the time of each merger.

Administration – The Employer is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Employer has delegated certain responsibilities for the operation and administration of the Plan. Administrative, custodial and trustee services were provided by Fidelity Management Trust Company (the Trustee) for the years ended December 31, 2024 and 2023. Recordkeeping services were performed by Fidelity Workplace Services, LLC for the years ended December 31, 2024 and 2023.

Eligibility – All employees age 21 and older are eligible to participate in the Plan on the first day of the month following completion of sixty days of service. An employee who is employed on the last day of the Plan year and has completed more than 1,000 hours of service is eligible for the profit-sharing contribution.

All new participants and any existing participants deferring less than 6% of compensation will be automatically enrolled at a deferral level of 6%, unless electing to opt out or select an alternate deferral amount. On July 1st of each subsequent year, the automatic deferral amount will increase by 2% up to a maximum of 10%.

Contributions – Participants may contribute up to 100% of eligible compensation, subject to IRS limitations, through salary deferrals. Participants may also contribute amounts representing distributions from other qualified retirement plans. Employer matching contributions are discretionary. For the 2024 plan year, the employer provided a matching contribution of an amount equal to 50% of the first 6% of the participant's compensation contributed to the Plan, not to exceed 3% of compensation, as defined in the Plan agreement. The Employer may also make an annual discretionary profit-sharing contribution. The Employer did not make a profit-sharing contribution in 2024. Eligible compensation is defined as gross compensation before deferral of employee contributions, plus any taxable life insurance premiums. Contributions are subject to certain limitations.

Investment options – The Plan offers various investment alternatives through the trustee. Participating employees direct the allocation of their account balances among these investment choices.

Participant accounts – Employee and matching contributions are credited to participants' accounts following each pay period. If there is a profit-sharing contribution provided in a given year, it is credited to participants' accounts the following year. In addition, participant accounts are credited

with the earnings on their investments, as earned. Income and loss is allocated to the participants' accounts based on the ratio of the account balance of the individual participant to the aggregate of all account balances of all participants in the fund within the Plan. The vested balance in a participant's account is the benefit to which the participant would be entitled upon termination or retirement.

Notes receivable from participants – Under the terms of the Plan, participants may borrow from their accounts up to \$50,000 or 50% of their vested account balance, whichever is less. Loans are not allowed for less than \$1,000. The loans are secured by the balance in the participants' accounts. Loans issued on or after January 15, 2014, bear interest at 2% in excess of the prime rate on the date the loan is processed. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. Interest rates on outstanding loans as of December 31, 2024, ranged from 3.25% to 10.50% per annum. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of benefits – On termination of employment due to death, disability, separation of service, or retirement, a participant or their beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Participants with vested account balances greater than \$7,000 may elect to receive the payment directly or roll the balance to an individual retirement account or other eligible retirement plan as soon as administratively feasible. Unless a participant elects to have their vested account balance rolled over into an eligible retirement plan, the Employer will process mandatory distributions, regardless of participant consent, if the vested account balance is less than \$7,000 it will be distributed as a lump-sum distribution in the name of the Participant.

Forfeited accounts – Upon termination of employment, nonvested portions of participant accounts are forfeited. Forfeitures from profit sharing and employer matching contributions may be used to offset Plan expenses or reduce any employer contributions. As of December 31, 2024 and 2023, there was no forfeited balance. During 2024, the Plan used \$579,483 to reduce employer contributions.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting of profit-sharing and employer matching contributions is based on years of service in which the participant has completed at least 1,000 hours using the "hours of service" method. The following table is the vesting schedule based on years of service:

Costs of administration – Plan expenses may be paid for by the Plan unless paid by the Employer. The Plan pays all custodial costs as well as some administrative costs for the record-keeper. For 2024 these costs totaled \$49,130.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Since all the investments are with registered investment companies, quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains are recorded on the accrual basis. Dividends and capital gain distributions are recorded on ex-dividend dates. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year. See Note 3 for discussion of fair value measurements.

Notes receivable from participants – Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Contributions – Employee contributions are recognized in the period payroll deductions are made. Employer contributions are calculated and recognized based on employee contributions and eligible compensation for the Plan year.

Payments of benefits – Benefits are recorded when paid.

Income taxes – The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since the opinion letter was received, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Subsequent events have been evaluated for recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued. The Employer concluded that no material events have occurred since December 31, 2024 that requires disclosure in the financial statements.

3. INVESTMENTS AND FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market fund and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of money market funds, mutual funds, common stocks, and exchange-traded funds, all of which are valued on the basis of readily determinable market prices.

4. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustees).

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan's administrative and recordkeeping services are provided by Fidelity Management Trust Company. Any purchases and sales of the investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.
