### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed an audit of the financial statements of Hunter Services, LLC Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

**Note 1. Description of the Plan**

The following description of the Hunter Services, LLC Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan covers employees of Hunter Services, LLC. and its wholly owned subsidiaries, Hunter Truck Sales & Service, LLC., Hunter Truck Center, LLC., and Hunter Leasing, LLC, as well as Hunter Keystone Peterbilt, L.P., and Hunter Truck, LLC all of which are related through common ownership and are hereinafter referred to collectively as “the Company.” The Plan was originally established on June 1, 1966 as a defined contribution money purchase pension plan. On August 31, 1996, the Plan was amended and restated to become a defined contribution profit-sharing plan. All individuals covered under the money purchase pension plan on August 31, 1996 continued to be covered under the restated plan with no loss of benefits. The recordkeeper of the Plan is Empower Retirement and trustees of the Plan are Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each year, participants may contribute up to 100% of pretax qualifying compensation, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of all contributions into various investment options offered by the Plan. Currently, the Plan offers a variety of mutual funds and an insurance investment contract as investment options. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. An eligible employee is defined as an employee who has completed six months of service and is age 18 or older. As of July 1, 2022, participants are automatically enrolled at a deferral rate of 5% of eligible compensation. Prior to July 1, 2022, participants were automatically enrolled at a deferral rate of 2% of eligible compensation. Automatically enrolled participants have their contributions invested in a designated fund until changed by the participant. Participants automatically enrolled have their deferral percentage increased 1% annually, up to 10%, unless otherwise elected by the participant. The Company contributes 50% of the first 5% of the qualifying compensation that a participant contributes to the Plan during the Plan year. Additionally, the Company may make discretionary profit-sharing contributions to the Plan. Participants must complete 1,000 hours of service and be employed the last day of the Plan year in order to be eligible to receive the discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company did not make a discretionary profit-sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Investment Options***

Participants direct the investment of their contributions among several options as provided by the Plan. Participants may change their investment options on a daily basis. The Plan currently offers various mutual funds and a fully benefit responsive investment contract as options.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Each participant has a nonforfeitable interest in the employer matching and discretionary profit-sharing contributions upon the completion of three years of continuous service.

***Distributions and Payment of Benefits to Participants***

Benefits provided by the Plan are payable to participants at retirement, death or total disability. A participant who has reached the age of 59½ is eligible to take an in-service withdrawal from the vested portion of his or her account. A participant may elect to receive the balance of his or her vested account through a variety of payment options. Vested benefits under \$5,000 are payable immediately upon termination of employment.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment terms range over a period not extending beyond five years from the date of the note. Notes are secured by the balances in the participants' accounts and bear interest at a fixed rate of Prime Rate plus 1% at the time of application. Principal and interest are paid ratably, generally through payroll deductions.

***Forfeitures***

At December 31, 2024 and 2023, there were forfeited nonvested accounts that totaled approximately \$6,000 and \$9,000 respectively. These accounts can be used to reduce future employer contributions and Plan expenses. The Company utilized approximately \$75,000 of the forfeitures to reduce employer contributions to the Plan during the year ended December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses related to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted market prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The Plan recognizes transfers between the levels as of the actual date of the event or change in circumstances that caused the transfer. There were no gross transfers between the levels for the year ended December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Fully Benefit-Responsive Investment Contracts**

The Plan has a traditional investment contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value of investment contracts held by the Plan as of December 31:

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 0.00%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with

another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

**Note 5. Unaudited Information Certified by the Trustee**

The accompanying financial statements and supplemental schedule of assets (held at end of year) include the following unaudited information that was obtained from data prepared and certified to be complete and accurate by Empower Annuity Insurance Company of America ("Empower"), the trustee for the Plan.

**Note 6. Exempt Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds and a guaranteed investment contract managed by Empower. Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. Fees paid to the trustee by the Plan for administrative services were approximately \$111,000 for the year ended December 31, 2024.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**Note 8. Tax Status**

The Plan is a nonstandardized prototype plan that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is tax-exempt. The Plan sponsor has determined that it is eligible to and has chosen to

rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
