INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Infinity Machine & Engineering Corporation 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the information in the supplemental schedule, other than the information agreed to or derived from the certified investment information, is presented, including the form and content, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Infinity Machine & Engineering Corporation 401(k) Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, as adopted effective January 1, 2006 and restated January 1, 2024, covering all full-time and part-time employees of Infinity Machine & Engineering Corporation (the "Company") who have six months of service and are age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to contribute a percentage of their annual compensation not to exceed the amount allowed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All investments are participant directed.

The Company may make a discretionary matching contribution to eligible participants, to be determined annually. For 2024 and 2023, the Company contributed 50% of the first 4% of base compensation that a participant contributed to the Plan. The Company may also contribute a discretionary nonelective contribution to eligible participants, to be shared based on their compensation in proportion to total compensation for all eligible participants. The Company did not make any discretionary nonelective contributions for 2024 and 2023. To share in the Company discretionary matching and nonelective contributions, an employee must have completed 1,000 hours of service during the Plan year and be employed on the last day of the Plan year, unless they were separated from service due to death, disability, or attainment of normal retirement age (65). Company contributions are invested based on the participant's discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's discretionary matching contribution, (b) the Company's discretionary nonelective contribution, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants who are employed on or after their normal retirement age (65), or are terminated due to death or disability, are automatically 100% vested in all employer contributions.

Notes Receivable from Participants

The Plan was amended in 2024 to include a provision allowing eligible participants to borrow from their fund accounts. Participants may borrow from their fund accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. Loans for the purchase of a primary residence may exceed the five-year terms deemed by the Plan administrator. The loans are secured by the balance in the participant's account and bear a commercially reasonable rate of interest. Interest rate was 8.75%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other termination, or other termination, a participant may elect to receive the value of his or her vested account balance in a lump-sum amount equal to the value of the participant's vested interest in their account. If the participant's vested account balance does not exceed \$5,000 and is greater than \$1,000, a direct rollover will be made of the vested account balance into an individual retirement account, unless the participant elects another form of distribution. If the participant's vested account balance does not exceed \$1,000, the Plan will distribute that portion, in a lump-sum, on the first distribution date after the participant terminates employment with the Company, or as soon as administratively practical following that date.

Administrative Expenses

All administrative expense may be paid out of the Plan unless paid by the Company. During 2024 and 2023, expenses were paid by both the Plan and the Company.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5 and \$427, respectively. These amounts will reduce future employer contributions or pay administrative expense of the Plan. During 2024 and 2023, employer contributions and plan expenses were reduced by \$1,187 and \$2,277 from forfeited nonvested accounts, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants totaling \$2,832 and \$354 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions for 2024 and 2023, respectively. The Plan distributed the 2024 and 2023 excess contributions prior to March 15, 2025 and March 15, 2024, respectively.

Payment of Benefits

Benefits are recorded when paid. There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board ASC 820, Fair Value Measurements, establishes a framework for measuring fair value and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds:

Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Information Certified by the Plan Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Alerus Financial, N.A. the custodian of the Plan.

Note 6 - Tax Status

The Company became a participating employer in the Alerus Financial, N.A Defined Contribution Volume Submitter Plan and Trust effective January 1, 2006, and is relying on its most recent opinion letter dated June 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving this opinion letter. However, the Plan Administrator and the Plan’s tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 7 - Transactions with Parties-in-Interest

Alerus Financial, N.A., provides certain administrative services and receives revenue from investment fund service providers for services Alerus Financial, N.A. provides to the funds. This revenue is used to offset certain amounts to Alerus Financial, N.A. for its administrative services to the Plan.

If the revenue received by Alerus Financial, N.A. from such investment fund service providers exceeds the amount owed, Alerus Financial, N.A. remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expense or allocated to the accounts of the participants. During 2024 and 2023, excess amounts totaled \$2,635 and \$5,489, respectively.

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion and those activities are deemed party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of ERISA regulations.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 9 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.
