Notes to Financial Statements

Note 1: Description of Plan

The following description of Partnership Community Health Center 403(b) (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Partnership Community Health Center (the "Employer") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

Eligibility and Participation

Employees are eligible to participate in elective deferrals upon hire. To be eligible to receive Employer matching contributions, participants must be age 18 or older, and complete 90 days of service. After meeting these eligibility requirements, participants begin receiving Employer matching contributions on the first day of the following month.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the plan agreement on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows participants to roll over distributions from other qualified plans (rollover contributions).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Employer makes a matching contribution of 100% of the participant's elective deferral up to 4% of participant compensation. Rollover contributions are not matched. Catch-up contributions are eligible for the employer matching contribution. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, and allocations of plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to three loans outstanding at one time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years unless extended because of absence for military service or for the purchase of a primary residence.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Participants hired prior to January 1, 2019, are also vested immediately in Employer matching contributions, plus actual earnings thereon. Participants hired on or after January 1, 2019, vest in Employer matching contributions, plus actual earnings thereon, based on years of continuous service. These participants vest at a rate of 25% per year beginning with the first year of service and become fully vested after four years of service.

Payment of Benefits

Plan benefits are available to the participant or beneficiary upon death, disability, financial hardship (if certain conditions are met), normal retirement (age 65), or termination of employment. The Plan also allows for in-service distributions upon attaining age 59 1/2. Benefits may be paid in a full or partial lump-sum distribution, with a minimum partial lump-sum distribution of \$1,000.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in Employer matching contributions. There is no Forfeited nonvested amount as of 2024 and Forfeited nonvested accounts totaled to \$22,263 as of December 31 2023. Forfeitures are to be used at the discretion of the Employer, in accordance with the Plan agreement, to reduce Employer matching contributions or to pay Plan expenses. There were \$61,349 of forfeitures used during 2024 to reduce Employer matching contributions and to pay Plan expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as a reduction to the note proceeds and, as a result, are not included in administrative expenses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the processing of withdrawals are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market fund: Valued using \$1 for the net asset value ("NAV"). The NAV is a quoted price in an active market.

Mutual funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by Plan Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Except as described in the subsequent paragraph, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Johnson Bank, a custodian of the Plan.

Certain information disclosed in the accompanying financial statements and supplemental schedule, including \$467,940 and \$399,981 of investments held at December 31, 2024 and 2023, respectively, and \$44,106 of net appreciation in fair value of investments and \$34,333 of interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator, but was not certified as complete and accurate by American Funds Service Company, a custodian of the Plan.

Note 5: Tax Status

The Employer adopted a volume submitter document with an IRS notification letter, which states the volume submitter plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Party-in-Interest Transactions

Certain plan investments are managed by American Funds Service Company. American Funds Service Company is a custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment. The Plan also pays administrative expenses to Johnson Bank, a custodian of the Plan and, therefore, these transactions also qualify as party-in-interest transactions. Fees paid by the Plan to Johnson Bank for administrative expenses amounted to \$39,557 for 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the plan termination, participants would become 100% vested in their Employer matching contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
