Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Center Theatre Group of Los Angeles 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Center Theatre Group of Los Angeles 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Center Theatre Group of Los Angeles 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Center Theatre Group of Los Angeles 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The following description of the Center Theatre Group of Los Angeles (CTG) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a defined contribution plan covering substantially all employees (for certain of these employees under limited contribution provisions) except for those included in a unit of employees covered by a collective bargaining agreement. CTG (employer) functions as the plan administrator and oversees governance of the Plan. CTG's Retirement Plan Committee, consisting of members of senior management, determines the appropriateness of the Plan's investment offerings and monitors investment performance with the assistance of an outside professional advisor and reports annually to the Finance Committee. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees of CTG are immediately eligible to make employee contributions to the Plan. Employees are eligible to receive employer discretionary and matching contributions upon reaching age 21 and being employed as of the last day of the plan year. Eligibility for employer discretionary and matching contributions commences in January or July, after completing one year of service in which at least 1,000 hours are worked. Effective January 1, 2023, the Plan was amended to remove the automatic enrollment provision. Participant eligibility and the contribution of employer matching and discretionary amounts are determined annually and paid after the end of the plan year.

Contributions

Participant contributions – Each year, non-highly compensated employees may contribute between 1% and 100% of pre-tax annual compensation, as defined in the Plan. Highly compensated employees (as defined by Internal Revenue Service (IRS) Regulations) are precluded from contributing to the Plan under a salary reduction agreement. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer match and discretionary contributions – CTG may elect to make discretionary matching and discretionary contributions to the Plan. CTG matches \$1 for each \$1 of employee contributions, up to 3% of eligible compensation deferred to the Plan. The matching contribution relates to the amount contributed by non-highly compensated employees to the Plan under a salary reduction agreement and to highly compensated employees for matching of amounts electively contributed to a 403(b) plan administered by CTG. The Plan did not make any employer discretionary contributions during the year ended December 31, 2024. Contributions are subject to regulatory limitations.

Investment of all contributions is at the direction of the plan participants into investment options offered under the Plan.

Participant accounts – Each participant’s account is credited with the participant’s contributions and employer matching contributions, as well as allocations of the employer’s discretionary contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants are vested immediately in employee contributions plus actual earnings thereon. Vesting in CTG’s discretionary and CTG’s matching contribution portions of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan Agreement, plan loans will bear a reasonable rate of interest determined by the plan administrator. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.25%, with various maturities through February 2030.

Payment of benefits – Payment upon retirement is paid in a lump sum or rolled over to a qualifying account or financial institution. Upon separation of service due to death, the vested balance in the participant’s account is due to the beneficiary. Upon separation of service due to termination, the vested balance in the participant’s account is due to the participant. In-service withdrawals are allowed for participants at the age of 59½. Payments are recorded when paid.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and are used to pay the Plan’s administrative expenses, with any remaining amount used to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$135,908 and \$8,699, respectively. For the year ended December 31, 2024, employer matching contributions were reduced by \$134,173 from forfeited nonvested accounts.

Service providers – CTG as the plan administrator contracted with The Variable Annuity Life Insurance Company (VALIC), a custodial service provider (custodian), for investment management, administrative, and participant recordkeeping purposes until March 2007, at which time CTG changed service providers and entered into a trustee agreement with the Principal Trust Company/Principal Global Investors Trust Company (Principal) to provide such services. Plan assets were transferred on May 4, 2007, from VALIC to Principal, except for 80% of the balance in the fixed interest accounts, which was subsequently transferred in accordance with the related contracts, at 20% per year. At December 31, 2024, a balance of \$5 remained in the fixed interest account. Accordingly, the Plan has had two service providers, of which Principal is the primary provider. Until all assets are transferred from VALIC, the Plan will have two service providers (custodial and trust arrangements). Both VALIC and Principal charge certain percentage administrative costs that reduce the participant return on the investments. All other significant administrative and accounting expenses are absorbed by CTG.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's custodians, VALIC, Principal Global Investors Trust Company, and Principal Trust Company, certify the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a deemed distribution, based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the CTG and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Reclassification – Certain amounts from the prior year statement of net assets available for benefits have been reclassified in order to conform to the current year presentation.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective investment trust – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV practical expedient.

Guaranteed investment contracts (GIC) – Valued by determining the cash flow due under the surrender provisions of the contract discounted according to risk-adjusted market rates.

The Plan's contract with VALIC provides investments that are maintained in insurance company general accounts (unallocated contracts offering fixed rates of interest), which were transferred to Principal at 20% per year of the balance at May 2007, through the year 2011, with the intent that any remaining balance was to be transferred thereafter. The remaining balance of \$5 at December 31, 2024, is expected to be transferred out and is considered *de minimis* compared to total assets. The fixed rate unallocated contracts are not considered fully benefit-responsive. Participants were able to direct the withdrawal or transfer of their investment at contract value (which may be subject to a fair value adjustment) not to exceed 20% on an annual basis.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balances and the amounts reported in the statements of net assets available for benefits. Given recent volatility in the financial markets, it is reasonably possible that investment values could decline significantly in subsequent periods.

Note 6 – Information Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VALIC, Principal Global Investors Trust Company, and Principal Trust Company, the custodians of the Plan, have certified to the completeness and accuracy of:

Note 7 – Party-in-Interest Transactions

Certain plan investments are managed by VALIC, Principal Global Investors Trust Company, and Principal Trust Company. These entities are the custodians or affiliates of custodians of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, CTG has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 9 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has will determined the amount of related lost earnings and remit those amounts to participants' accounts subsequent to year end.
