Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NeoGraf Solutions, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the NeoGraf Solutions, LLC 401(k) Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is sponsored and administered by NeoGraf Solutions, LLC (the Plan Sponsor or Company). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a defined contribution plan covering all eligible employees of the Company. To be eligible to participate in the Plan, employees must be at least 21 years of age and must not be a leased employee or covered by a collective bargaining agreement. All employees of the Plan Sponsor on July 3, 2017, the formation date of the Plan, were immediately eligible.

Contributions: The Plan implements an Automatic Election program for participants by which employees who do not complete a salary reduction agreement form are automatically enrolled in the Plan with a 5% pretax deferral as soon as administratively practicable. Participants may contribute an amount of eligible pretax or after-tax Roth annual compensation not to exceed limits established by the Internal Revenue Code (IRC), as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other certain qualified plans. The Company makes a non-discretionary Safe Harbor matching contribution equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

The Company also makes a profit sharing contribution to the Plan, on a quarterly basis, of 1% of participants' eligible compensation as defined by the Plan. The quarterly contribution made by the Company is reduced by any forfeited account balances of terminated participants.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the employer contributions and Plan's earnings and is charged with an allocation for administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their employee contributions, employer Safe Harbor matching contributions, rollover contributions, catch-up contributions, and actual earnings or losses thereon. Participants vest in the portion of their accounts attributable to profit sharing contributions by the employer based on their years of vesting service under the Plan, as defined in the Plan document, as follows:

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested portion of their accounts, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Benefit payments: A participant may withdraw all or part of his/her interest in the Plan attributable to rollover contributions while still employed by the Company. In addition, a participant or elected beneficiary, upon termination, death or retirement, may receive the vested interest in his/her account in the form of a lump-sum payment or a rollover to an individual retirement account or other qualified plan. Hardship withdrawals, as defined by the Plan, are also available to participants.

Forfeited accounts: The unvested portion of a participant's interest in their account is forfeited upon distribution from the Plan. Amounts forfeited are to be held in a separate account and applied to reduce future employer contributions. There were forfeitures of \$162 and \$276 at December 31, 2024 and 2023, respectively. Unused forfeitures will be applied to reduce future employer contributions as soon as administratively feasible and in accordance with the terms of the Plan document.

Administrative expenses: All expenses of maintaining the Plan are paid by the Plan or the Company, at the discretion of the Company.

Plan termination: Although they have not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. In the event of termination of the Plan, participants will become 100% vested in their accounts. The assets then remaining in the Plan will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Benefit payments: Benefits are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Money market account: Valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of assets within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of assets from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Tax Status

The Plan adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The preapproved plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Party-in-Interest Transactions

Plan investments include certain investments managed by Ascensus Trust Company, the custodian of the Plan, or its affiliates. These transactions qualify as party-in-interest transactions as defined under ERISA guidelines. Fees paid by the Plan for administrative services amounted to \$34,806 for the year ended December 31, 2024.

Note 7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Prohibited Transaction

During 2024 and 2023, the Plan Sponsor inadvertently failed to deposit \$16,627 and \$18,184, respectively, of participant contributions and loan repayments within the required time frame as stated by DOL regulations. The Plan Sponsor deposited lost earnings to correct this failure in 2024. The Plan Sponsor filed Form 5330 and paid any applicable excise tax to the IRS. The correction and any excise taxes, if applicable, were made from the Plan Sponsor's assets and not from assets of the Plan.

Note 9. Subsequent Event

Effective August 1, 2025, the Plan was amended to allow for direct and indirect in-plan Roth rollover contributions. The Plan was also amended to allow for distribution payments in the form of installment payments and employer matching contributions to be funded annually.
