## (1) Plan Description

The following description of the Spencer Savings Bank, SLA Savings Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for further information.

### (a) General

Spencer Savings Bank, SLA (the Company or Plan Sponsor) established the Plan on January 1, 1988, as a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). Employees (not including leased employees, union employees, and nonresident aliens with no U.S. earned income sources) become eligible to participate in the Plan on the first day of the month immediately following the satisfaction of the Plan's age and service requirements. Employees may participate in the Plan by making elective deferrals after reaching age 21 and completing three months of service. Eligible employees are automatically enrolled in the Plan with a 3% contribution rate that will automatically increase by 1% annually, up to a maximum of 6%, unless participants elect otherwise.

Employees are eligible to receive matching Company contributions after reaching age 21 and completing one year of service.

### (b) Contributions

- (1) Participant Contributions – Participants may elect to have up to 100% of compensation contributed to this Plan on a pretax salary reduction basis. A participant may elect to defer a percentage of their compensation subject to certain Internal Revenue Code (IRC) limitations, which is \$23,000 in calendar year 2024. If a participant is age 50 or older, the participant may make additional pretax deferral contributions of up to \$7,500 in year ended December 31, 2024. The Salary Deferral Contribution Account is always fully vested.
- (2) Rollover Contributions – Participants are permitted to rollover amounts representing distributions from other qualified plans.
- (3) Employer Contributions – Participants become eligible for matching contributions on the first day of the month coinciding with or next following the date on which such requirements are satisfied. For each Plan year, the Company shall contribute, with respect to each participant, a matching contribution equal to the following:
  - i. For a participant who has not reached the fifth anniversary of the date of hire, fifty percent (50%) of such participant's salary deferral contribution (up to a maximum of 10% of compensation) made to the Plan.
  - ii. For a participant who has reached the fifth anniversary of the date of hire, one hundred percent (100%) of such participant's salary deferral contribution (up to a maximum of 10% of compensation) made to the Plan.

- (4) Participant Accounts – Individual accounts are maintained for each participant. Each participant’s account is credited or debited with the participant’s contributions and withdrawals, as applicable, and allocations of (a) the Company contributions and (b) plan earnings, and may be debited with an allocation of plan losses and administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. Forfeited balances of terminated participants’ nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**(c) Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 7 pooled separate accounts (PSAs), 26 mutual funds and a guaranteed investment account (GIA) provided through a group annuity contract as investment options for participants as of December 31, 2024. Participants may change their investment options at any time.

**(d) Vesting**

Participants become 20% vested in the matching Company contribution portion of their accounts after completion of two years of service, increasing 20% for every year of service completed thereafter and become 100% vested in their benefits after completion of six years of service.

**(e) Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments over an agreed-upon period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan complies with the automatic rollover provisions under Section 401(a)(31)(B) of the IRC as amended by the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA). The Plan requires that if a participant does not elect to have a mandatory distribution greater than \$1,000 paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. If the participant’s total vested benefit is \$1,000 or less as of the distribution date, the entire vested benefit will be distributed in a lump sum, even if there is no consent to the distribution.

**(f) Forfeitures**

The amount in a participant’s account that is not vested shall be considered forfeited as of the last day of the Plan year within which the participant terminated employment. Such forfeited amounts shall be used to reduce future Company matching contributions. During the year ended December 31, 2024, \$8,367 were considered forfeited. The amount of unused and available forfeited amounts as of December 31, 2024 and 2023 was \$16,137 and \$28,809, respectively. During the year ended December 31, 2024, \$64,896 was used from the forfeiture account to reduce the Company’s matching contributions. The forfeitures are invested in a guaranteed investment account.

**(g) Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account

and bear interest at rates commensurate with a reasonable interest rate at the time funds are borrowed. For the year ended December 31, 2024 and 2023, the interest rates on all outstanding loans ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions. Loans must be repaid within five years of the original date of the loan.

### **(h) *Administrative and Investment Management Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction investment return and included in the investment income reported by the Plan.

## **(2) Summary of Significant Accounting Policies**

### **(a) *Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **(b) *Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

### **(c) *Investment Valuation and Income Recognition***

The Plan's investments, other than the fully benefit responsive investment contract (FBRIC), are stated at fair value. The Pooled Separate Accounts (PSAs) are valued at the net asset value as reported by the investment manager. The net asset value is based on the quoted market prices of the underlying assets. Net appreciation in PSAs is the change in value of those units. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As of December 31, 2024 and 2023, the Plan's GIA, which is an insurance contract with Principal Financial Group, Inc (Principal), is valued at contract value by aggregating the total contributions made to the investment, adding interest earned to date, less any benefit payments and administrative expenses incurred to date, adjusted for transfers in and out of the GIA by participants. Participation in the GIA is expressed in units. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Interest income from the GIA is recorded on the accrual basis.

Purchases and sales of securities are recorded on a trade-date basis.

### **(d) *Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

## **(e) Benefit Payments**

Benefit payments to participants are recorded upon distribution.

## **(3) Fair Value Measurements**

*Financial Accounting Standards Board Accounting Standards Codification 820* provides the framework for measuring fair value that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts (PSA) – The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices, which are based on the performance of underlying assets. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in a single open-ended mutual fund. The underlying investment composition of the pooled separate accounts as of December 31, 2024 and 2023 was approximately 76% and 65% equity index funds, 24% and 35% fixed income securities, respectively. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

Mutual Funds – The fair values of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023.

measure the fair value of the Plan's investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

### **(4) Guaranteed Investment Contract with Insurance Company**

The Plan contains a traditional guaranteed investment contract that is a fully benefit-responsive investment contract with Principal (Issuer). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum interest rate guaranteed per the contract from Principal is 3.59% per year.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract value of the investment contract was \$12,565,141 and \$14,180,337 at December 31, 2024 and 2023, respectively. In accordance with the provisions of the Plan, issuers of these investment contracts must have a credit rating of A+ or better under the fund manager's investment rating system. Accordingly, there are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

The GIA permits the insurance company to terminate the agreement under certain circumstances. Examples of circumstances which would allow the issuer to terminate the contract include the Plan's election to terminate the contract, the Plan's loss of its qualified status, or there is termination or partial termination of the Plan. There are no further conditions that would limit the Plan's ability to transact at contract value. Currently, management believes that such events or termination of the contract is not probable.

### **(5) Party-in-Interest Transactions**

Certain plan investments consist of units or shares managed by Principal, thereafter. These transactions qualify as party-in-interest transactions as defined by ERISA. Expenses paid by the Plan for record keeping services amounted to \$189,209 for the year ended December 31, 2024 and are also considered party-in-interest transactions. All other Plan administrative expenses, including usage of the Plan Sponsor's facilities and resources, are paid by Spencer Savings Bank, SLA, the Plan Sponsor, as provided in the Plan document. Loans to Plan participants also constitute party-in-interest transactions and any indirect expenses paid via deductions in income to the investments.

### **(6) Plan Termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination or partial termination, participants will become 100% vested in their accounts.

### **(7) Administration of Plan Assets**

The Plan is administered by the trustees of the Plan. Principal Trust Company provides recordkeeping and custodial services for the Plan.

### **(8) Federal Tax Status**

The Internal Revenue Service issued an opinion letter dated June 30, 2020, that the prototype plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has since been amended, Plan management believes that the Plan is currently being operated in accordance with the IRC. Plan management believes the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and risks pertaining to global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **(10) Certified Investments and Notes Receivable from Participants**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the custodian of the Plan.

### **(11) Subsequent Events**

The Plan administrator has performed an evaluation of events that have occurred subsequent to December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued.
