INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Van Hessen USA Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Van Hessen USA Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Van Hessen USA Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Van Hessen USA Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

General - The Plan is a defined contribution plan established by Van Hessen USA Inc. ("the Company") under the provision of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed ninety days of service, as defined, are eligible to participate, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Company serves as the administrator of the Plan. The assets of the Plan are maintained by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "custodian"). Empower Retirement, an affiliate of the custodian, provides recordkeeping services for the Plan.

Contributions - Each year, participants may defer pretax annual compensation up to the maximum allowable per Internal Revenue Service ("IRS") regulations (\$23,000 and \$22,500 for the years ending December 31, 2024 and 2023, respectively, with a catch-up amount of \$7,500 for each of the years ended December 31, 2024 and 2023, for those eligible). Participants may also rollover amounts representing distributions from other plans. For the year ended December 31, 2024, the Company made a matching contribution of 100% of the participant's contribution, up to a maximum of \$1,000. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations. Members of collective bargaining units are not eligible for employer contributions.

Participant Accounts - Each participant's account is credited with the participant's contribution, employer contribution, and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all contributions and earnings credited to their accounts.

Investment Options - Upon enrollment in the Plan, a participant may direct employee and employer contributions into any of the investment options available.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50% or \$50,000 of their account balance, whichever is less. Loan terms range from 1 - 5 years or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at Prime Rate plus 1% (based on the day of the loan request). Principal and interest are paid ratably through payroll deductions.

Distributions - Upon termination of service, retirement, death, disability, attainment of age 59-1/2 or financial hardship as defined, a participant may elect to have his or her account balance distributed. A participant may elect to receive either a lump-sum or installment payments or request a rollover to another qualified plan. Participant account balances of less than \$1,000 are automatically distributed in a single lump sum. In addition, participant accounts can be rolled over into an individual retirement account or another qualified defined contribution plan. Minimum distributions may not be deferred past April 1 of the calendar year following the year in which the participant attains age 70-1/2.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Accounting principles generally accepted in the United States of America ("U.S. GAAP") require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor ("DOL").

Investment Valuation and Income Recognition - The Plan's investments in pooled separate accounts are valued at net asset value ("NAV") per unit held by the Plan at year-end as quoted by the funds. The NAV is used as the practical expedient. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily.

The Guaranteed Portfolio Fund is fully benefit responsive and is valued at contract value. See note 8 for discussion of contract value determination.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net

appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments – Benefit payments are recorded when paid. There are no amounts owed to participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and distribution requests from participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value investments.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

4. TAX STATUS

The Company adopted the Plan using a prototype document of the Plan's investment custodian, which was amended during 2021. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

6. INFORMATION CERTIFIED BY THE PLAN'S INVESTMENT CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment custodian has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate.

7. FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP related to fair value measurement. Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

In accordance with U.S. GAAP, certain investments that are measured at net asset value (or its equivalent) are not classified in the fair value hierarchy. Since all the investments are pooled separate accounts valued at net asset value, a fair value leveling table is not required.

8. GUARANTEED PORTFOLIO FUND

The Plan is invested in the Guaranteed Portfolio Fund, which is considered a benefit-responsive single group annuity contract issued by Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum crediting interest rate and prevailing market conditions.

The average market yield earned by the fund, which is also the actual interest credited to participants in the fund, for the years ending December 31, 2024 and 2023 was 1.41% and 1.23%, respectively.

Non-participant directed withdrawals (including employer-initiated events like layoff or a sale of a line of business) may require advance notice before the withdrawal could be made. The fixed income investments qualify as fully-benefit responsive investments and are reported at contract value. The concept of a value other than contract value does not apply to the Guaranteed Portfolio Fund, an insurance company issued general account backed evergreen (no maturity date) group annuity contract. Even upon discontinuance of the contract, contract value would be paid if the sponsor provides a 30-day advance notice. The plan administrator does not believe that any events that may limit the Plan's ability to transact at contract value are probable. The investments in the fully benefit-responsive investment contracts are stated at contract value which is equal to principal balance plus accrued interest. The contract is backed by the full faith and creditworthiness of the issuer.

9. PARTIES-IN-INTEREST

The plan allows loans to participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited rules.

The Plan also invests in various investments issued by the custodian. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. In addition, Empower Retirement, an affiliate of the custodian, provides recordkeeping services for the Plan.

10. ADMINISTRATIVE EXPENSES

The Company pays all administrative expenses of the Plan except for certain contract administrative and trustee fees. Such charges not paid by the Company are applied directly to the accounts of the participants and are classified as administrative expenses in the statement of changes in net assets available for benefits. Certain investment advisory fees are paid by the Plan and included in net appreciation in fair value of investments of the related fund as they are paid through a revenue sharing agreement, rather than a direct payment. Administrative expenses paid by the Company are not included in the financial statements of the Plan.

11. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024, the Company failed to remit to the Plan's custodian certain employee contribution and loan payments within the period prescribed by the Department of Labor's regulations. The total amount of untimely payments for the year ending December 31, 2024 were \$167. Management expects to self-correct untimely remittances, including lost earnings, during 2025.
