Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EDF Renewables Distributed Solutions Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

As of December 31, 2024 and 2023 and For the Year Ended December 31, 2024

1. Description of Plan:

The following brief description of the EDF Renewables Distributed Solutions Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of EDF Renewables Distributed Solutions Inc. (the “Company”), except for employees who have not attained 21 years of age, employees covered by a collective bargaining agreement, leased employees, and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Eligible participants can enter the Plan on the first day of the month coinciding with or next following the date on which they become eligible. The participants’ elective deferrals may be made on a pre-tax or a ROTH deferral basis. ROTH deferrals are subject to federal and state income taxes. Participants may elect to defer up to 90% or a specified dollar amount of their compensation, as defined by the Plan. Contributions are also subject to the maximum annual limit established by the Internal Revenue Service (IRS) of \$23,000 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and participants that are 50 years old or older can make additional “catch-up” contributions of up to \$7,500 in 2024.

The Plan provides for discretionary matching and discretionary non-elective contributions for eligible participants. During the year ended December 31, 2024, the Company made matching contributions of up to 6% of the participant’s eligible compensation. Matching contributions totaled \$693,904 during the year ended December 31, 2024. The Company did not make any non-elective contributions during the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a money market fund as investment options for participants.

Participant Accounts – Each participant’s account is credited with the participant’s voluntary contribution, the Company’s matching contributions and non-elective contributions and plan earnings (net of administrative fees). Allocations of the Company’s non-elective contributions are based on a participant’s eligible compensation relative to total eligible compensation. Allocations of Plan earnings are based on a participant’s account balance relative to the total account balance of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately fully vested in their voluntary contributions, Company matching contributions and Company non-elective contributions, plus actual earnings thereon.

Payment of Benefits – Participants may make withdrawals from their accounts under the following circumstances:

- (1) Normal retirement – the later of age 65 or the fifth anniversary of employment;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

1. Description of Plan (continued):

Distributions will be paid as soon as possible following termination date, except for financial hardship withdrawals which are payable immediately. Distributions are made to participants in a lump sum payment.

Forfeitures – Participants are at all times fully vested in their accounts, including Company matching and non-elective contributions, normally resulting in no forfeitures in the Plan. The Plan held funds in the forfeiture account due to outstanding checks and excess Company contributions totaling \$0 and \$1,022, as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants – At the discretion of the Plan, participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (i) 50% of a participant's vested account balance as of the date the loan is made or (ii) \$50,000 reduced by the highest outstanding loan balance, if any, from the Plan during the one year period ending immediately before the date of the new loan. Loans are secured by the participant's account and bear a reasonable rate of interest based on the prevailing rate as defined by the Plan. Loan terms range from a minimum of 1 year up to 5 years. If the loan is for the purpose of acquiring a primary residence the loan term can be extended up to 10 years from the date of the loan. Loans are to be repaid through salary reductions consistent with the payroll practices of the Company.

2. Significant Accounting Policies:

Basis of Accounting – The accounting records of the Plan are maintained on the accrual basis.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the Company's matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Operating Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

2. **Significant Accounting Policies (continued):**

Subsequent Events – In preparing these financial statements, management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and would be entitled to the full value of their account.

Effective December 31, 2024, the Plan has merged into the EDF Renewables sponsored EDF renewables 401(k) Plan.

4. **Income Tax Status:**

The Company has adopted a pre-approved plan, which received a favorable determination letter from the Internal Revenue Service on June 30, 2020, which stated that the pre-approved plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. **Investments:**

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company served as the Plan’s trustee. They have provided the Plan administrator with a certification as to the completeness and accuracy of investment balances, supplemental schedules, interest and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations.

6. **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurements:

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

 Quoted prices for similar assets or liabilities in active markets;

 Quoted prices for identical or similar assets or liabilities in inactive markets;

 Inputs other than quoted prices that are observable for the asset or liability; and

 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Transactions With Parties-in-Interest:

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions.

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA, these transactions meet the criteria for exemption, are not considered prohibited transactions and do not need to be reported in the supplementary schedules of Form 5500.
