## **INDEPENDENT AUDITORS' REPORT**

To the Administrative Committee of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of **Plan De Compensación Diferida 1165(e) del Concilio de Salud Integral de Loíza, Inc.**, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Plan De Compensación Diferida 1165(e) del Concilio de Salud Integral de Loíza, Inc.**'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the *Auditors' Responsibilities* for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. ## **Emphasis of Matter – Restatement of Prior-Period Financial Statements**

As discussed in Note 7 to the financial statements, the Plan restated its 2023 financial statements to correct an error in the recognition of certain transactions. Accordingly, the corresponding amounts presented for that period have been restated. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **Plan De Compensación Diferida 1165(e) del Concilio de Salud Integral de Loíza, Inc.**'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## 1. DESCRIPTION OF PLAN

The following description of the **Plan De Compensación Diferida 1165(e) del Concilio de Salud Integral de Loíza, Inc.** (the Plan) provides only general information. Participants should refer to the Summary of the Plan Description for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all full-time employees of **Plan De Compensación Diferida 1165(e) del Concilio de Salud Integral de Loíza, Inc.** who have completed twelve (12) consecutive months of service and are age eighteen (18) years or older. The original effective date of the Plan was October 1, 2001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Plan Administration

Effective October 1, 2001, *Concilio de Salud Integral de Loíza, Inc.*, a non-profit organization, (the Company) is the Sponsor of the Plan who created a committee to serve as the Plan Administrator. The Plan's Committee is composed mainly of the Company's Executive Director, HR Director, and Finance Director. The Plan's Trustee is the Plan's Sponsor Executive Director. The Plan's recordkeeper and custodian are *Great-West Life and Annuity Insurance Company* which is responsible for managing the investments, administrative matters, and recordkeeping of the Plan's participant transactions.

### Contributions

A participant may contribute not less than 2% of pre-tax annual compensation as defined in the Plan and shall not exceed the pre-tax contribution limit allowed under Puerto Rico Internal Revenue Code section 1081.01(d) (\$15,000). The participants may contribute after-tax contributions and may not be less than 1% nor exceed 10% of compensation. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants.

The Employer will make Matching Contributions equal to \$1.50 for each dollar of a Participant's Matchable Contributions. However, the Employer will not make Matching Contributions on Matchable Contributions that exceed 2% of the Participant's Compensation during any Matching Period. The Matching Period according to the Plan Document is "Monthly". Employer Matching Contributions will be allocated among a Participant's Pre-Tax Contributions.

### Rollover Contributions

Participants may roll over their funds previously held for their account in another employee benefit plan on a tax-free basis.

### Participants Accounts

Each participant's account is credited with the participant's and Company contributions and a pro-rata allocation of the Plan's earnings, net of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## 1. DESCRIPTION OF PLAN, (Continued)

### Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions portion of their accounts, plus actual earnings thereon are based on years of continuous service. Participants become 100% vested in the matching contributions after three (3) years of credited service.

### Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in the form of a lump sum distribution equal to the value of the participant's vested interest in his/her account or monthly, quarterly, semiannual or annual installments over a period of years certain.

In conditions of "financial hardship", a participant may apply to the Plan Administrator for approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants by the Plan's provisions and existing laws and regulations.

### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested account balances totaled \$9,222 and \$7,882, respectively, and are included within total investments of the Plan.

During the year ended December 31, 2024, additional forfeitures from non-vested participants amounted to \$1,223, and the forfeiture account earned \$117 in interest income.

In accordance with the provisions of the Plan, these forfeited amounts may be used by the Plan Sponsor to reduce future employer contributions or to pay eligible Plan administrative expenses.

No amounts were applied from the forfeiture account during the year ended December 31, 2024.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contributions of their account.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting and have been prepared following generally accepted accounting principles of the United States of America.

### Investments Valuation and Income Recognition

Investments are reported at fair value, except for investment contracts, which are reported at contract value. Fair Value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The mutual funds are credited with actual earnings on the underlying investments and charged for participants' withdrawals and administrative expenses. The investment contract is based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

### Investment Contract

Investment Contract (Key Guarantee Portfolio Fund) held by a defined contribution plan are reported at contract value as contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Changes in Net Assets Available for Benefits is prepared using the contract value basis for fully benefit responsive investment contracts.

### Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America, which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Excess Contributions Payable

When applicable, amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses including audit fees and legal fees are paid directly by the Company. Other administrative expenses directly incurred by the Plan include investment management and distribution fees charged directly to the participant's accounts. These administrative expenses are presented as a deduction to net assets on the Statement of Changes in Net Assets Available for Benefits.

Risk and Uncertainties

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

**3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held on December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year then ended, were obtained, or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian. **4. FAIR VAUE MEASUREMENTS**

Financial Accounting Standard Board (FASB) established the Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which provides a framework for defining and measuring fair value under generally accepted accounting principles. This codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. In some cases where market prices are not available, observable market-based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves, and currency rates. These measurements are classified within Level 3.

The fair value of mutual funds is based upon quoted prices in active markets for identical assets and liabilities therefore classified as Level 1.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. KEY GUARANTEED PORTFOLIO FUND WITH INSURANCE COMPANY**

In 2008, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life and Annuity Insurance Company. Great-West Life and Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great-West Life and Annuity Insurance Company, represents contributions made under the contract, plus earnings, fewer participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract on December 31, 2024, was \$796,760. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed every quarter for resetting.

Certain events limit the Plan's ability to transact at contract value with Great-West Life and Annuity Insurance Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or a merger with another plan), (b) changes to the Plan's prohibition on competing for investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract's value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable to occur.

The guaranteed investment contract does not permit the insurance company to terminate the agreement before the scheduled maturity date.

**6. EXCESS CONTRIBUTIONS PAYABLE**

During the year ended December 31, 2024, the Plan failed to satisfy the *Average Deferral Percentage* (ADP) test performed by an independent consultant company. In accordance with the requirements of the Internal Revenue Code, the Plan is required to correct the failure either by (a) making qualified non-elective contributions to non-highly compensated employees, or (b) refunding excess deferrals to highly compensated employees. To correct the 2024 ADP test failure, the Plan elected to refund excess contributions to three (3) highly compensated employees totaling \$10,493. The excess contributions were recognized as a liability (payable) in the accompanying statements of net assets available for benefits as of December 31, 2024.

## 7. CORRECTION OF AN ERROR

During 2024, the Plan identified an error in its previously issued financial statements for the year ended December 31, 2023, related to the omission of excess contributions payable amounting to \$22,485. Accordingly, the accompanying 2023 financial statements have been restated to correct this error and to properly reflect the related liability as of December 31, 2023.

During the year ended December 31, 2024, the Plan paid \$22,485 in excess contributions attributable to the 2023 plan year.

## 8. TAX STATUS

The Plan constitutes a qualified plan exempt from income tax under the Puerto Rico Internal Revenue Code of 2011, Section 1081.01. On January 1, 2012, the Plan received acknowledgment from the Puerto Rico Treasury Department that the Plan and related trust are designed in accordance with applicable requirements of Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011. The Plan Administrator and the Plan's Tax Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements, therefore, they believe that the Plan was qualified as of the financial statements date.

Accounting principles generally accepted in the United States of America require the management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

## 9. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has a group annuity contract managed by Great-West Life and Annuity Insurance Company and its subsidiaries and/or affiliates. Certain subsidiaries provide administration, custodial, and recordkeeping services. These specific investments issued or managed by Great-West Life and Annuity Insurance Company qualify as party-in-interest transactions.

## 10. NON-EXEMPT TRANSACTIONS

During 2020 and 2022, the Plan refunded to the Company certain contributions related to three months, as they could not be allocated to participants due to missing information. Although the Company made multiple attempts throughout 2023 to resolve the data issues and resubmit the contributions, the Plan was unable to process them and refunded the amounts again, maintaining them as unallocated. Once the required information was successfully provided, the Company resubmitted the contributions to the Plan in January and September 2024, at which point they were properly applied to participant accounts. In addition to resubmitting the original contributions, the Company calculated and paid interest on the refunded amounts totaling \$2,135 during August and October 2024. An additional interest amount of \$14,272 was paid by the Company during the year 2025. These interest payments have been recorded as contributions to participants in the accompanying financial statements.

**10. NON-EXEMPT TRANSACTIONS, (Continued)**

The Plan also identified late remittances of employee contributions during audits for the years 2020 through 2024. As part of the correction process, the Company remitted lost earnings to the Plan to compensate participants for potential investment losses resulting from the delayed deposit of these contributions and refunds. The total interest related to these corrections amounted to \$7,117, which was subsequently paid during 2025 and will be recorded as contributions to participants in that year.

In addition, the Company performed a supplemental analysis to determine potential lost earnings on mid-month (15th) payroll contributions for the years 2019 through 2024. Although the contributions were consistently remitted by month-end, the analysis determined that the Company could have reasonably remitted the mid-month contributions earlier when funds became available. To ensure full correction, the Company calculated and remitted additional lost earnings totaling \$5,466, which were also paid during 2025 and will be recorded as contributions to participants in that year.

These late remittances constitute non-exempt transactions between the Plan and the Company under Department of Labor Regulation 2510.3-102, which requires participant contributions to be remitted to the Plan within a reasonably prompt time frame. The remittance of all lost earnings was completed in October 2025 as part of the correction of these transactions.

The Company plans to submit a formal correction package to the Department of Labor under the Voluntary Fiduciary Correction Program (VFCP) now that all lost earnings have been remitted to the Plan.

**11. SUBSEQUENT EVENTS**

On June 2, 2025, the Plan was amended, effective July 1, 2025, to comply with the applicable provisions of the SECURE 2.0 Act of 2022. This amendment was the result of ongoing meetings and thorough analysis conducted between the Plan Committee and the Plan's advisors to ensure alignment with updated regulatory requirements and to enhance retirement outcomes for participants.
