### 1. Description of Plan

The following description of the Energy Services Group, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

#### ***General***

The Plan is a defined contribution plan covering all employees of Energy Services Group, LLC and The WhiteStar Corporation, Inc. (collectively the “Employer” or the “Plan Sponsor”) except those employees whose employment is governed by a collective bargaining agreement, (“Participants”). Employees may enter the Plan on the first day of employment.

Ascensus Trust Company (“Ascensus”) provides trustee and custodial services for the Plan. Trustee services are certified by Ascensus parent company, Ascensus, LLC, as agent for Ascensus. The Plan Sponsor has contracted Vanguard Group, Inc. (“Vanguard”) to provide certain recordkeeping and administrative services to the Plan pursuant to a Retirement Plan Recordkeeping Service Agreement (“RSA”). Vanguard has retained Ascensus, Inc. as a subcontractor to provide the services under the RSA on behalf of Vanguard. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are Participant directed.

#### ***Plan Mergers***

During 2024, due to an acquisition, The WhiteStar Corporation, Inc. became a participating employer in the Plan. The Employer approved an amendment to merge The WhiteStar Corporation 401(k) profit sharing plan (the “WhiteStar Plan”) into the Plan effective November 1, 2024. For the year ended December 31, 2024, \$1,437,350 of assets were transferred into the Plan from the WhiteStar Plan.

Subsequent to year end, Pandell Technology USA (“Pandell”) became a participating employer in the Plan.

#### ***Plan Administration***

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly with an allocation of administrative expenses, if not paid by the Employer.

#### ***Subsequent Events***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which is October 15, 2025.

### 1. Description of Plan (*continued*)

#### ***Participant Contributions***

Participant contributions to the Plan are deferrals of employee compensation. Each year, Participants may defer a portion of their eligible compensation, as defined by the Plan, not to exceed a dollar limit established under the Internal Revenue Code (the "IRC"). Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("Rollovers").

#### ***Employer Matching Contributions***

A Participant is entitled to employer matching contributions. To be eligible, Participants must have made elective contributions during the Plan year. For the year ended December 31, 2024, the Employer match was equal to 50% of the elective participant contributions up to 6% of their eligible compensation.

#### ***Employer Profit Sharing Contributions***

The Employer, at its discretion, may make a profit sharing contribution to the Plan. Any profit sharing contributions are allocated to Participants based upon a percentage of the Participant's compensation and on the Participant's allocation group, as defined. For the year ended December 31, 2024, the Employer elected not to make a profit sharing contribution to the Plan.

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's deferral contributions, the respective employer contributions, an allocation of the Plan's investment earnings or losses, and is charged with an allocation of certain administrative expenses. Allocations are based on participant compensation or account balance, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

#### ***Vesting***

Participants are immediately vested in deferral contributions, employer contributions, and the investment earnings thereon.

#### ***Notes Receivable from Participants***

Subject to approval by the plan administrator, Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A Participant may only have one loan outstanding at a time. Loans may not be withdrawn for an amount less than \$1,000. Loan terms extend up to five years (or longer for the purchase of a primary residence). Loans are secured by the vested balance in the Participant's account and bear interest at a rate of 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions. The interest rates on loans outstanding at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Loans outstanding at December 31, 2024 and 2023 mature through May 22, 2043.

#### ***Notes Receivable from Participants (continued)***

If a Participant ceases to make loan repayments, the plan administrator can deem the loan to be in default. When a distributable event occurs, the Participant's loan balance is reduced, and a benefit payment is made in accordance with the Plan document. Loans to Participants are reported as notes receivable from Participants at the unpaid principal balance plus any accrued but unpaid interest.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, termination, or retirement, a Participant (or beneficiary) may elect to receive a lump sum, partial payout or installment payments of their account balance. If a terminated Participant's vested account balance is less than \$7,000, and the Participant does not elect to have the distribution paid directly to an eligible retirement plan or receive the distribution as a lump-sum, then the plan administrator may distribute the account balance to an individual retirement arrangement designated by the plan administrator. If a Participant's account balance is less than \$1,000, the Plan administrator may distribute the account balance to the Participant in a lump-sum payment.

In-service withdrawals from the Participant's vested account balance is permitted upon reaching age 59 ½, normal retirement age 65, or upon a deemed severance from employment, as defined in the Plan document. In-service withdrawals are also permitted due to financial hardship, as defined. Hardship withdrawals may be taken from the Participant's deferral contribution accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Fair Value Measurements (continued)***

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified as Level 1 within the fair value hierarchy.

#### ***Investments, Investment Valuation, and Income Recognition***

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

#### ***Notes Receivable from Participants***

Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses and expensed when incurred.

#### ***Payment of Benefits***

Benefit payments to Participants are recorded during the period in which the Participant is paid.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments, and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividend and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus.

### 4. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### 6. Tax Status

The underlying prototype non-standardized profit sharing plan received an opinion letter on June 30, 2020 from the Internal Revenue Service ("IRS"), stating that the form of the plan is qualified under Section 401(a) of the IRC. Any employer adopting this format of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations prior to 2021.

### 7. Party-In-Interest Transaction

Plan investments include mutual funds that are managed by Ascensus, Inc., an affiliate of Ascensus and are issued by Vanguard Investments, an affiliate of Vanguard. Accordingly, these transactions qualify as exempt party-in-interest transactions. The Plan paid administrative expenses of \$40,458 to The Vanguard Group, Inc. during the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

### 8. Delinquent Participant Contributions

During 2023, certain participant contributions and loan repayments amounting to \$95,120 were not remitted to the Plan by the plan administrator on a timely basis as required under DOL 2510.3-102. Under ERISA, such delinquent contributions are considered prohibited transactions and are reported on Schedule H, Part IV, Line 4(a) of Form 5500. During 2024, the plan administrator calculated lost earnings on these contributions and funded them into the Plan.

### 9. Excess Contribution Payable

At December 31, 2024, \$29,581, was recorded for amounts refundable by the Plan to certain Participants, as required, to satisfy the relevant non-discrimination testing provisions of the Plan. The total \$29,581 in excess contributions payable at December 31, 2024 is netted against the Participant deferrals on the statement of changes in net assets available for benefits. The Plan distributed the 2024 excess contributions to the applicable Participants prior to March 15, 2025, as required.
