Summary of Actuarial Methods

The ultimate cost of a pension plan is the excess of actual benefits and administrative expenses paid over actual net investment return on plan assets during the plan's existence until the last payment has been made to the last participant. A plan's "actuarial cost method" determines the expected incidence of actuarial costs by allocating portions of the ultimate cost to each plan year. The cost method is thus a budgeting tool to help ensure that a plan will be adequately and systematically funded. Annual contributions are also affected by a plan's "asset valuation method" (as well as plan provisions, actuarial assumptions, and actual plan demographic and investment experience each year).

Actuarial Cost Method

The actuarial cost method used for determining the Plan's ERISA funding requirements is the Unit Credit method. Under this method, an accrued benefit is determined at each active participant's assumed retirement age based on compensation and service at both the beginning and the end of the current year. The Plan's Normal Cost is the sum of the present value of the excess of each active participant's accrued benefit at the end of the current year over that at the beginning of the current year. The Plan's accrued liability is the sum of (a) the present value of each active participant's accrued benefit at the beginning of the current year plus (b) the present value of each inactive participant's benefits. This method is prescribed for ERISA funding requirements by the Pension Protection Act of 2006.

Asset Valuation Method

The Actuarial Value of Assets used for determining the Plan's ERISA funding requirements is equal to the fair market value of assets.

Amortization Method

For the Plan's ERISA funding requirements, incremental Funding Shortfall amounts are amortized over a fifteen-year period, and the related shortfall amortization payment is determined on the first valuation date following the plan year in which it arises based on the segment rates used for ERISA minimum funding purposes on that date, as prescribed under IRC Section 430.

Maximum Deductible Contribution: 24-month average segment rates but not adjusted to reflect the applicable segment rate stabilization corridor.

Rationale: This is a prescribed assumption set by the Internal Revenue Code Section 430. The sponsor has elected to utilize no look-back period, with rates averaged over a 24-month period, limited to applicable minimum and maximum values. These rates are utilized for purposes of calculating the Plan's Maximum Deductible Contribution.

417(e) Lump Sum: Spot segment rates for the 4th month preceding the first day of the plan year.

Rationale: This is a prescribed assumption set by the Internal Revenue Code Section 430. The sponsor has elected to utilize a 4-month look-back period.

This summary of plan provisions is intended to only describe the essential features of the Plan. All eligibility requirements and benefit amounts shall be determined in strict accordance with the plan document itself.

Definitions

Effective Date

The effective date of the Plan is January 1, 2021.

Plan Year

The plan year is the 12-month period beginning January 1 and ending December 31.

Actuarial Equivalent

For all purposes, actuarial equivalent means a form of benefit differing in time, period, and/or manner of payment from another form of benefit, but having the same value when computed based upon the following interest and mortality assumptions:

Pre-Retirement: Interest - 5.00%
 Mortality Table - None

Post-Retirement: Interest - 5.50%
 Mortality Table - 2024 Applicable Mortality Table

Annual Compensation

Wages, tips and other compensation on Form W-2, excluding reimbursements or other expense a

Average Compensation

Highest 3 consecutive years of participation with at least 500 hours worked.

Benefit Service

Plan year in which the participant works at least 500 hours.

Vesting Service

Plan year with 1000 hours.

Eligibility

All employees excluding union and nonresident aliens. enter the Plan on the first day of the year coinciding with or next following the later of the date they attain age 19 and the date they complete 1 years of service.

Vesting

Graded schedule with 100% vesting after 6 years of service.

Normal Retirement Benefit

111.00% of average monthly compensation.

Normal Form of Benefit

Life Annuity.

Normal Retirement Age

The greater of age 62 or the age at which the participant completes 5 years of plan participation.

Normal Retirement Date

The anniversary date nearest the attainment of the normal retirement age.

Early Retirement

No early retirement is provided under the plan.

Pre-Retirement Death Benefit

A participant's surviving beneficiary will be entitled to receive a death benefit in the event of the death of a participant prior to the commencement of a monthly pension benefit that is equal to the present value of the participant's vested accrued benefit.

Disability Benefit

The Actuarial Equivalent of the vested accrued benefit as of the date of disability as determined by a physician.

Termination Accrued Benefit

Pro-rata based on service.

Termination Vested Benefit

A participant's vested accrued benefit as of a given date is equal to the product of their accrued benefit multiplied by their vested percentage as of the same date.

Optional Benefit Forms

Equal to the actuarial equivalent of the normal benefit form. Such distribution may be in one or more of the following forms:

- Lump Sum
- Life Annuity
- Joint & 50% survivor pension


